### Scottish Parliament Oral Answer

#### Giorgi Kakava

**Bob Doris (SNP):** My constituent 10-year-old Giorgi Kakava tragically lost his mother Sophie in February, while going through the United Kingdom asylum process. Giorgi knows only Springburn and Scotland, having been here since he was three years old. He attends the local school and has good friends and the community wants to protect and support him. Some 70,000 people have signed a petition calling for Giorgi not to be deported and to stay in Scotland with his gran, Ketino.

Does the First Minister agree that the Home Office must conduct Giorgi's case with compassion and that it must move quickly to give certainty, safety and security to Giorgi? I ask the First Minister to make representations to the Home Secretary—as I have done—making the case that Scotland is Giorgi's home and is where he should grow up.

**The First Minister (Nicola Sturgeon):** This is a really tragic situation and it is absolutely heartbreaking to hear what Giorgi has been through. That said, I have been deeply touched—as I am sure that everyone else has—to hear how the local community in Springburn has rallied round, really proving that people make Glasgow.

In achieving more than 70,000 signatures, the Rev Brian Casey's petition shows the strength of feeling that people have for a child who has lost his parents and has only ever known Scotland, our country, as his home.

Giorgi's case needs common sense, but, above all, it needs compassion. I hope that the Home Office will urgently review it with Giorgi's best interests at the heart of its decision making—in fact, with Giorgi's best interests as the only factor in its decision making. I hope that the outcome of the case is that Giorgi is allowed to stay here and grow up here and, as he does so, to make a fantastic contribution to the country that he not only calls home but which considers itself to be his home.

## Scottish Parliament Written Answer

### Migration

**S5W-17047 Graeme Dey (SNP):** To ask the Scottish Government what assessment it has made of the benefits of migration to the Scottish economy and society.

**Reply from Alasdair Allan:** Migration is crucial to the development of Scotland as an inclusive, fair, prosperous, innovative country. It is essential to our economic prospects and our demographic sustainability that Scotland continues to attract the level and nature of migration it needs.

Following the EU referendum we published a report summarising and evaluating the recent literature on the impacts of migrants and migration on Scotland's economy, labour market, public services, communities and culture. In November last year we set out the evidence about the importance of migration to Scotland, in our submission to the Migration Advisory Committee (MAC). We followed that earlier this year with a discussion paper on Scotland's Population Growth and Migration Policy detailing the unique challenges facing Scotland's population and the potential economic gains if migration was sustained. The paper also outlines how a tailored approach for Scotland, with new powers for the Scottish Parliament, could operate.

## UK Parliament, Ministerial Statement

### Immigration Rules

**The Minister for Immigration (Caroline Nokes)** [HCWS768] My right hon. Friend the Home Secretary is today laying before the House a statement of changes in immigration rules.

The changes include exempting doctors and nurses from the tier 2 (general) limit, recognising the important contribution that overseas health professionals make to our NHS. This is in response to the particular shortages and pressures facing the NHS at the current time, as well as the fact that the limit has been oversubscribed in each month since December 2017. The change will mean that health sector employers will be able to sponsor doctors and nurses without putting pressure on the limit, freeing up places within the limit for other key roles which contribute to the UK economy and other public services. The changes will be kept under review.

The Government will also ask the independent Migration Advisory Committee to review the composition of the shortage occupation list.

Building on the changes announced by the Chancellor in the autumn, which were

implemented in January of this year, further improvements are being made to the tier 1 exceptional talent route. These changes include widening the scope of the creative element of the route to include leading fashion designers, and improved provisions for applicants in film and television.

Appendix H is being updated to include a number of visa national countries, which will allow a greater number of students to benefit from a streamlined application process by reducing documentary requirements. This change demonstrates the continued focus on improving the UK's offer to international students.

Today also sees the introduction of a new rule for those transferred to the UK under section 67 of the Immigration Act 2016 (section 67 leave), who do not qualify for refugee or humanitarian protection leave under the existing rules. In keeping with our commitments in the legislation, and in line with those granted refugee or humanitarian protection leave, individuals who qualify for section 67 leave will have the right to study, work, access public funds and healthcare and apply for indefinite leave to remain without paying a fee after five years.

New settlement provisions are being created to put beyond doubt that Afghan nationals who worked with our armed forces in Afghanistan, and subsequently relocated to the UK with their families, will be able to apply for permanent residence here. As announced on 4 May, these applications will also be free of charge. Afghan locally engaged staff worked in dangerous and challenging situations, regularly putting their lives at risk and we would not have been able to carry out our work there without them. The new dedicated settlement rules make clear our commitment to honour their service and ensure they can continue to build their lives here. The changes also implement plans to extend the ex gratia redundancy scheme by six years to recognise and honour the service of those made redundant before 19 December 2012, as announced by the Defence Secretary on 11 June.

As announced in March, a new route to settlement for Turkish business people and their families who are in the UK under the European communities association agreement is also being created. Eligibility is being extended for this route to Turkish workers and their families who are also here under the association agreement.

Changes are being made to provisions to allow holders of an electronic visa waiver (EVW) to present their EVW in a digital format. The changes will also establish a wider set of permissible errors that will overlook specific, minor discrepancies in the biographic details of an EVW, without compromising on the security of the EVW system.

Its commission on the impacts on the UK labour market of the UK's exit from the European Union and how our immigration system should be aligned with a modern industrial strategy includes consideration of the Shortage Occupation List.

The Committee is due to report on this, and on its other commission on international students, in September.

To meet these service standards, case-working functions allocate workload in an appropriate manner and as such there are a number of different objectives and targets in place. These are dependent on the level of experience and seniority of individual caseworkers across the different UKVI case-working routes and also take into account any reasonable adjustments required in order to fulfil our statutory duties under the Equality Act 2010.

**Jo Stevens (Labour)** [151211] To ask the Secretary of State for Justice, in how many immigration appeal cases the applicant had to represent themselves as a litigant in person in 2017.

**Reply from Lucy Frazer:** The information requested is not held centrally and could only be provided at disproportionate cost.

The term "litigant in person" applies to appellants without a legal representative or a representative recognised by the Office of the Immigration Services Commissioner. In the First-tier Tribunal (Immigration and Asylum Chamber) any person may be permitted to act as a representative, including a friend, relative or litigation friend. The case management system cannot provide a breakdown between different types of representative.

**Stephen Timms (Labour)** [149896] To ask the Secretary of State for the Home Department, with reference to the statement in his letter to the Chair of the Home Affairs Committee dated 25 May 2018 that applications potentially falling for refusal under the character and conduct provisions of paragraph 322(5) have been put on hold, if he will grant the people affected by that review the right to work pending the outcome of that review; and if he will make a statement.

**Reply from Caroline Nokes:** Individuals who applied before their existing leave to remain expired have their current status protected while their applications are on hold. This includes their right to work.

For those cases which have already been refused, those who still have existing leave to remain continue to have the right to work. If the review identifies that any of these refusal decisions were incorrect, we will then consider what further steps are needed.

### Immigration

**Faisal Rashid (Labour)** [150773] To ask the Secretary of State for the Home Department, for what reason rectifying a tax return error constitutes sufficient grounds for his Department to refuse indefinite leave to remain under paragraph 322(5) of the Immigration Rules.

**Reply from Caroline Nokes:** It is not the Government's policy to refuse applications due to rectification of tax return errors.

We have refused applications where there are substantial differences – often tens of thousands of pounds – between the earnings used to claim points in an immigration application and an applicant's HMRC records, without a credible explanation from the applicant. We take all available evidence into account before making a decision. Paragraph 322(5) is used where the evidence shows that an applicant's character and conduct is such that their application should be refused. Any such case is signed off by a manager before refusal grounds are applied.

As I advised the Home Affairs Select Committee on 8 May, we are carrying out a review of these cases to see how many showed clear evidence of deceit, and whether any were minor errors.

## Visas

**Mike Penning (Conservative)** [151108] To ask the Secretary of State for the Home Department, whether he has made an assessment of the effectiveness of his contingency arrangements for tackling the situation in which former Tier 1 visa holders successfully apply for the passport of another nation to circumvent UK visa restrictions; and if he will make a statement.

**Reply from Caroline Nokes:** All non-EEA nationals coming to the UK are assessed against the Immigration Rules and an individual's immigration history is considered as part of this assessment.

Those coming to the UK for longer than 6 months (which includes Tier 1), or for a purpose other than a visit, are required to apply for entry clearance and provide their biometric details (face and fingerprints) as part of the application process.

We carry out 100% checks on passengers arriving on scheduled services at the border in order to identify any criminal, security and immigration concerns. and, whilst EEA nationals have a right of admission, this right is not absolute and in certain cases admission can be refused or the individual can be excluded.

## Visas: Married People

**Laura Pidcock (Labour)** [152291] To ask the Secretary of State for the Home Department, for what reason the earnings threshold for the Spouse Visa does not take into account differences in livings costs for different areas in the UK.

**Reply from Caroline Nokes:** The minimum income threshold of £18,600 for sponsoring a non-EEA national partner to come or remain here applies across the UK. The level of the income threshold, which aims to prevent burdens on the taxpayer and promote integration, was set following advice from the independent Migration Advisory Committee and reflects the income at which a family settled here generally cannot access income-related benefits.

The Committee, in its November 2011 report, could see no clear case for differentiation of the income threshold between UK countries and regions and noted several arguments against such an approach. These included that a family living in a wealthy part of a relatively poor UK country or region could be subject to a lower income requirement than a family living in a deprived part of a relatively wealthy one. The Government agrees with that assessment and applying a single minimum income threshold across the UK has been found to be lawful by the courts.

**Anna Turley (Labour Co-op)** [152215] To ask the Secretary of State for the Home Department, what estimate he has made of the number migrants working in the UK on Tier 2 skilled worker visas who have had their indefinite leave to remain removed due to exceeding the 20-day annual limit on unpaid leave from work where strike absence was taken in each of the last five years for which figures are available.

**Reply from Caroline Nokes:** Tier 2 migrants who have indefinite leave to remain are not subject to any leave conditions, so cannot have it removed due to undertaking more than four weeks of unpaid leave.

### **Migrant Workers: Conditions of Employment**

**Reply from Caroline Nokes:** Paragraph 323AA of the Immigration Rules defines circumstances where a Tier 2 migrant's leave may be curtailed. This includes absences from work without pay for four weeks or more during any calendar year. There is no specified exemption for strike or industrial action. The Home Office does however consider the circumstances before deciding whether to take curtailment action.

**Reply from Caroline Nokes:** We have launched a targeted communications campaign to maximise awareness and reassure EU citizens of our commitment to protect their rights and entitlements.

This includes encouraging such citizens to apply under the EU settlement scheme when it opens and alerting those who may have previously acquired indefinite leave to remain, including those resident in the UK before 1973, to exchange it for the new settled status.

**Jo Stevens (Labour)** [150169] To ask the Secretary of State for the Home Department, what estimate his Department has made of the number of EU citizens who will be granted settled status to in the first year of that scheme's operation.

**Reply from Caroline Nokes:** The EU Settlement Scheme will be a simple and streamlined application process, drawing on existing government data and processes to minimise the administrative burden on applicants. The application process is being built around a presumption to grant rather than refuse, so we expect the majority of the current 3.4m resident EU citizens who will be eligible to apply, to do so and to be granted status. We will launch the Scheme by the end of the year and EU citizens will have plenty of time to apply before the deadline of June 2021.

We will be providing further detail on the scheme in due course.

**Steve McCabe (Labour)** [152632] To ask the Secretary of State for the Home Department, with reference to the case of Inga Lockington, if he will assess the effectiveness of the rules on applying for naturalisation for non-UK EU citizens who have lived in Britain for more than five years.

**Steve McCabe (Labour)** [152633] To ask the Secretary of State for the Home Department, what proof of residency EU citizens who apply for British citizenship are able to provide if they do not have permanent residence cards.

**Reply from Caroline Nokes:** The requirement for applicants who are permanently resident in the UK under the EEA Regulations to provide a document confirming this as part of their naturalisation application was introduced in 2015. The requirement is set out in the application form and accompanying guidance which everyone is advised to read before applying, as well the naturalisation pages on Gov.uk.

Where an EEA national does not possess a permanent residence card, then they would still be able to demonstrate that they are free from immigration time restrictions if they have obtained that status through alternative means, such as being granted indefinite leave under the Immigration Rules. However, where they seek to rely on residence under the EEA Regulations then a permanent residence card is required.

The requirement for EEA nationals to provide a document confirming their permanent residence as part of an application to naturalise is in line with the requirements for all other nationals and those EEA nationals who settled under the Immigration Rules, such as Mrs Lockington. Whilst it is regrettable that Mrs Lockington's application was initially refused, this was promptly addressed and the correct decision reached once brought to the attention of UKVI.

### **Immigration: LGBT People**

**Ged Killen (Labour Co-op)** [150776] To ask the Secretary of State for the Home Department, whether the Government plans to replicate in legislation the opinion of European Court of Justice ruling C-673/16 on same sex spousal rights after the UK leaves the EU.

**Reply from Caroline Nokes:** The Immigration (European Economic Area) Regulations 2016, which implement EU free movement law in the UK, already recognise same-sex marriages and unmarried partnerships. This will be replicated in the eligibility rules for the EU Exit Settlement Scheme for those EU citizens and their family members arriving before the end of the implementation period. Existing non-EU immigration rules also recognise same-sex marriages and unmarried partnerships.

In terms of the post-Brexit immigration regime, we are considering the options for our future immigration system carefully. We are building a comprehensive picture of the needs and interests of all parts of the UK and intend to develop a system which works in the national interest. In doing so, we will provide for equal treatment of same-sex couples, as we do now and in line with our obligations under the Equalities Act 2010.

### **Refugees: Children**

**Jo Stevens (Labour)** [150707] To ask the Secretary of State for the Home Department, whether he plans to make an assessment of the potential (a) merits and (b) effect of allowing unaccompanied child refugees to sponsor a close relative to come to the UK.

**Reply from Caroline Nokes:** Our family reunion policy allows immediate pre-flight family members of those granted protection here to reunite with them. The Immigration Rules also provide for relatives with protection in the UK to sponsor children in serious and compelling circumstances and there is provision in the policy to grant visas outside the Rules in exceptional circumstances, which caters for family members who otherwise do not qualify under the Rules.

However, there is currently no provision in the Rules for children with refugee status in the UK to sponsor family members to join them. This is a considered policy position to avoid creating additional motives for children to be encouraged, or even forced, to leave their family, and risk dangerous journeys hoping to sponsor relatives later. We believe the best interests of children are reflected in remaining with their families, claiming asylum in the first safe country they reach – that is the fastest route to safety – and relying on resettlement schemes to travel safely.

We are listening carefully to calls to allow extended family members to qualify and

are reviewing our approach to family reunion as part of the Government's wider asylum and resettlement strategy. However, expanding the policy without careful thought could risk more people being put in harms' way.

#### **Asylum: LGBT People**

**Ged Killen (Labour Co-op) [150775]** To ask the Secretary of State for the Home Department, how many and what proportion of LGBT people seeking asylum from persecution overseas were successful in their application; and whether he has any plans to review the guidelines of such applications.

**Reply from Caroline Nokes:** In November, the Home Office published experimental statistics on asylum claims on the basis of sexual orientation.

These statistics relate to the number of asylum claims where sexual orientation was raised as a basis, or part of the basis, of the claim, and refer to claims made between 1 July 2015 and 31 March 2017. The data do not indicate whether the individual seeking asylum actually had a particular sexual orientation, whether this was the sole basis for the claim, or whether this had any bearing on the outcome of the claim.

We remain committed to improving the asylum process for those claiming asylum on the basis of their sexual or gender identity and decision-makers are provided with dedicated guidance on the management of such claims.

We are developing a new instruction on Gender Identity and Expression that will replace both the current instructions on Gender Identity and on handling asylum claims where a Gender Recognition Certificate is presented. We expect to be able to publish this instruction later this summer.

We are also committed to reviewing the asylum instruction on claims based on sexual orientation on a regular basis. We will progress this review in the near future.

**Lord Ouseley (Crossbench)** [HL8299] To ask Her Majesty's Government whether the compensation scheme for the Windrush generation and others erroneously deemed to be illegally in the UK has been set up; when they expect it to be operational; and, if already operational, how many people have been compensated.

**Reply from Baroness Williams of Trafford:** The compensation scheme for those of the Windrush generation that might have been affected is in the process of being established. The Government has launched a Call for Evidence to hear about the experiences of those that might have been affected, which closes on 8 June.

The information gathered through the Call for Evidence will be used to inform the decisions on the design of the scheme, and Martin Forde QC has been appointed as an Independent Person to oversee that design.

The Government will open the scheme as soon as possible once the design of the scheme has been completed and consulted on, and in the meanwhile will continue to work with affected individuals through the operation of the Windrush Taskforce to help establish their immigration status.

**Tulip Siddiq (Labour)** [149686] To ask the Secretary of State for Health and Social Care, if he will take steps to address the findings of the Anthony Nolan Trust on the comparatively low survival rates for people with blood cancer from BAME backgrounds.

**Reply from Steve Brine:** The Government funds Anthony Nolan and NHS Blood and Transplant to improve equity of access to unrelated donor stem cell transplantation for Black, Asian and minority ethnic (BAME) patients through targeted recruitment to the United Kingdom Stem Cell Registry.

The National Cancer Programme is committed to transforming cancer care and outcomes for all people living with cancer, including those with rarer and hard to diagnose cancers. Ambitions have been set for all cancers and we are clear that we will not meet those ambitions without improving what we do for haematological cancers.

Although cancer patients in England rated their overall care 9 out of 10 in the 2016 Cancer Patient Experience Survey, the survey also tells us that BAME patients report poorer experiences of cancer care. NHS England is therefore working with clinical commissioning groups to ensure they use the very best evidence when planning, commissioning and monitoring services for these communities.

## **Racism, Religious Hatred, and Discrimination**

### **Scottish Parliament Oral Answers**

#### **Sectarianism**

**Stuart McMillan (SNP):** To ask the Scottish Government what action it is taking in schools to address sectarianism. (S5O-02213)

**Reply from the Deputy First Minister and Cabinet Secretary for Education and Skills (John Swinney):** Sectarianism must be challenged wherever it occurs, and the Government has delivered an unprecedented range of activities to tackle the issue across Scotland.

Since 2012, we have invested £13.5 million to support 108 organisations to deliver work to tackle sectarianism. That work has included a wide range of educational activities, including developing Scotland's first national resource on tackling sectarianism and delivering free continuing professional development training

sessions through the sense over sectarianism programme to support teachers to deliver anti-sectarian education. Our investment supported the development of the Nil by Mouth champions for change school programme, and I was pleased to learn that it is now available in all 32 local authority areas.

**Stuart McMillan:** The cabinet secretary might know that, last week, I hosted an event that involved two schools in my constituency—St Columba's high school and Clydeview academy in Gourock—that are working jointly on an anti-sectarian project with Nil by Mouth. Does the cabinet secretary consider that the existing collaborative projects could be worked on? Has he also given any consideration to making similar projects mandatory when it is considered that local communities could benefit?

**Reply from John Swinney:** In relation to the event to which Stuart McMillan referred, two pupils from St Columba's high school delivered time for reflection yesterday, and it was a pleasure to see such fine young people contributing to our parliamentary proceedings.

Nil by Mouth has taken forward very welcome initiatives. As I said in my previous answer, I am very pleased that all 32 local authorities are now taking forward work with Nil by Mouth, and it is appropriate for that work to be deployed in all parts of the country.

Whether such projects should be mandatory is a different question. It is up to individual schools to decide what steps they should take to tackle sectarianism. The issue will be of greater or lesser significance in different parts of the country. What is important is that we make available to schools the materials and the approaches to tackle sectarianism.

### **Prejudice-based Bullying**

**Christina McKelvie (Hamilton, Larkhall and Stonehouse) (SNP):** To ask the Scottish Government whether it will provide an update on its progress in eliminating prejudice-based bullying in schools. (S5O-02214)

**Reply from the Deputy First Minister and Cabinet Secretary for Education and Skills (John Swinney):** On 28 May, the Scottish Government published supplementary guidance for schools and local authorities on the recording and monitoring of bullying incidents in schools. The purpose of that guidance is to develop a consistent and uniform approach to recording and monitoring. To complement the guidance, we are working with SEEMIS—the schools' information management system—to update the current bullying and equalities module to enable improved recording and monitoring of prejudice-based bullying in schools.

**Christina McKelvie:** I welcome all the advances that have been made through the work that the Government has undertaken. Last week, the cabinet secretary visited St John Ogilvie high school, in my constituency, to see the pupil-led work that has led to the establishment and implementation of its new school anti-bullying policy. Does the cabinet secretary agree that pupil-led peer education is to be encouraged and that headteacher leadership can make the difference in ensuring a whole-school approach to ending prejudice-based bullying in schools? Will he also commend the work of St John Ogilvie high school's headteacher, Eddie Morrison, and wish him well for his well-earned retirement?

**Reply from John Swinney:** I had the pleasure of passing on my good wishes to Mr Morrison when I visited St John Ogilvie high school last Wednesday. I took a great deal of heart from witnessing young people leading the process of formulating the school's anti-bullying policy. A very engaged and sometimes very forthright conversation involving a lot of pupils was going on, and it was well shepherded and steered by senior pupils in the school. That is a very good example of pupil engagement and the expression of the pupil voice, which lies at the heart of curriculum for excellence. I saw similar work the week before, at Holy Cross high school in Hamilton. That demonstrated a similar approach to engaging

young people in the formulation of effective anti-bullying policies.

**Megan Quinn (St Columba's High School, Gourock):** ... Anne Frank is a name that I am sure we are all familiar with. Today, on what would have been her 89th birthday, we celebrate Anne Frank day.

Anne Frank was a young German-Jewish refugee who hid from the Nazis during world war two. Anne's life was tragically cut short at the age of 15 in March 1945 when she died of typhus in Bergen-Belsen concentration camp. Anne documented her time in hiding in the form of a diary, which was published by her father, Otto, to share her story. It has been read by millions across the globe, including by many of us here today. That, in turn, inspired a group of people to found the Anne Frank Trust UK.

We at St Columba's high school applied and were selected to work with the Anne Frank Trust as peer guides, and then as Anne Frank ambassadors. Throughout the process, we have shared not only Anne's story but the importance of challenging hate and prejudice within our school and the wider community.

That has been an invaluable experience. Not only have I learned more about Anne's story, I have become more aware of discrimination in society and now feel more confident in using my voice to challenge prejudice and hate.

**Rhys Lambert (St Columba's High School, Gourock):** In today's society, young people face many forms of discrimination and cyberbullying. It is important to challenge and shout down hate and strive for a peaceful and more equal society. Children are the future, which is why we need more young voices to speak up so that they can grow up in a more open-minded and tolerant world.

We read Anne's story and are shocked at the level of discrimination that a 13-year-old girl had to face, yet we forget that it still happens today. I want to live in a world where people do not have to be afraid of speaking up, where people are not judged by race or religion, and where we show compassion instead of hatred.

We invite you to reflect not only on Anne's story but on the dangers and harm that can be caused by prejudice going unchallenged. We leave you with Anne's words:

"How wonderful it is that nobody need wait a single moment before starting to improve the world."
