## Immigration and Asylum

### Scottish Parliament Oral Answer

#### Dallas Family (Asylum Appeal)

**Bob Doris (SNP):** My constituents, the Dallas family, have had their appeal for asylum refused. I understand that they fled to the United Kingdom in December 2017, after Mrs Dallas escaped a gun attack in Karachi that was fuelled by a fatwa against her, simply because she did not agree to convert from Christianity to Islam.

It would appear that the Home Office may place an undue weight on local police reports in making such determinations. Does the First Minister share the concern of the European Centre for Law and Justice over police torture of Christians in Pakistan, which makes victims nervous of reporting such incidents? Will the Scottish Government make representations to the UK Home Office asking it to take such concerns into account when cases such as that of the Dallas family are being considered?

**Reply from the First Minister (Nicola Sturgeon):** I thank Bob Doris for raising

that issue. I share the concern of the European Centre for Law and Justice and I strongly condemn—as I am sure everybody in the chamber does—any persecution of people from minority communities. Nobody should ever feel at risk because of their faith or beliefs.

The Scottish Government will always seek to champion human rights and we strongly support international processes such as United Nations scrutiny of individual member states.

Sadly, asylum is reserved to the UK Government and handled by the Home Office. The Scottish Government has consistently urged the Home Office to adopt fair and humane asylum policies and to ensure that full account is taken of all the individual circumstances in every case. We will continue to do that and if there is any assistance that we can offer to the Dallas family, we would be happy to discuss that with Bob Doris.

## Scottish Parliament Written Answer

### Immigration

**S5W-21858 Emma Harper (SNP):** To ask the Scottish Government what impact reduced levels of immigration as a result of Brexit could have on Scotland's public services.

**Reply from Ben Macpherson:** The UK Government proposal to end free movement will significantly reduce the number of people coming to Scotland to live, work and study. The recently published independent report of the Expert Advisory Group on Migration and Population estimates a reduction in net migration to Scotland of between 30% and 50% over the coming two decades if the UK Government puts in place the measures set out in its White Paper on immigration. Key services, such as health and social care, depend on EU workers to make up a significant proportion of their workforce. A reduction in migration to Scotland of the level suggested in the White Paper will have severe consequences for Scotland's public services. A 5% decline in Scotland's working age population, as the Expert Advisory Group estimates, will reduce the number of workers available to fill roles, affect the Scottish Government's abilities to raise revenue for public services, and therefore increase the challenge of managing the consequences of an ageing population.

## Scottish Parliament Motions

**S5M-16306 Stewart Stevenson (SNP): UK Government's Migration Proposals Damaging to Scotland's Economy** – That the Parliament calls on the UK Government to abandon its current post-Brexit migration proposals that would, it considers, see an end to freedom of movement and set a salary threshold for labour migrants at £30,000; believes that these proposals would have a disproportionate negative impact on Scotland's economy by sending the working age population into decline and causing serious staff shortages in key sectors; considers that sectors such as textiles, hospitality, sales, seasonal agriculture and vital social care service are most at risk, with almost no jobs qualifying for the £30,000 threshold; acknowledges the recent report from the Expert Advisory Group on Migration and Population, which it understands found that less than 40% of workers in the Aberdeenshire Council area, and less than 30% of workers in the

Moray Council area, earn above the £30,000 threshold, limiting jobs in the Banffshire and Buchan Coast constituency; recognises what it sees as the huge benefits that migration brings to Scotland and the valuable contribution that EU nationals have made to communities across the country, and agrees that Scotland's economy now depends on a fair, tailor-made approach to migration that works for all sectors and regions of Scotland.

**S5M-16255 John Mason (SNP): Glasgow Leading the Way in Asylum Reform** – That the Parliament acknowledges that Glasgow could become the first UK city to pilot changes to the asylum process based on the recommendations of a multi-agency taskforce; understands that, if implemented, the reforms would allow asylum seekers in Glasgow to enter employment from six months after their asylum claim has been submitted, and to register and make further submissions in Glasgow, instead of having to travel to Croydon and Liverpool, respectively, at their own cost; considers that these changes would help those fleeing persecution, famine and war to feel more at ease during the stressful application process, and commends Glasgow City Council for, it considers, leading the way in asylum reform to the benefit of all in society.

**Reply from Caroline Nokes:** The Government's White Paper, "The UK's future skills-based immigration system" (Cm 9722), published on 19 December 2018, provides a platform for further discussion. We have launched an extensive

programme of targeted engagement across the UK, to capture views and ensure that we design a future system that works for every nation.

There are three approaches to this engagement programme. The Government is engaging with specific sectors to communicate proposals and understand their priorities for a future system. We will hold cross-sector forums in the nine regions of England and all the nations of the UK to hear views from across the country.

We are also creating advisory groups that will have detailed discussions with private, public and voluntary sector employers and industry representatives as the policy and system is developed

### **Immigration: Research**

**Chris Green (Conservative)** [229276] To ask the Secretary of State for the Home Department, what plans he has to review the immigration rules in relation to the medical research sector; and if he will make a statement.

**Reply from Caroline Nokes:** The Government values the contribution which migrants makes to the medical research sector.

There are generous provisions for PhD-level occupations, which include medical researchers. These occupations have higher priority when allocating monthly places within the Tier 2 cap. We have also exempted these occupations from the £35,000 earnings threshold for settlement applications and exempted them from the Immigration Skills Charge.

The Government is committed to developing a future borders and immigration system that will cater for all sectors of the UK, including for those who make a very valuable contribution to our research sector.

Proposals in the White Paper published in December provide a platform for further discussion. The Home Office has launched engagement over 2019 with a wide range of stakeholders across the UK.

### **Visas: Sponsorship**

**Paul Blomfield (Labour)** [229193] To ask the Secretary of State for the Home Department, how many applications for Tier 2 (General) Certificate of Sponsorship have been submitted in each month since November 2018; how many of those applications were granted; and how many of those applications were refused as a result of the annual cap having been reached.

**Reply from Caroline Nokes:** No applications for Restricted Certificates of Sponsorship have been refused in the period in question due to the cap being reached under Tier 2 General. The information requested is set out below.

Restricted Certificates of Sponsorship (RCoS)

Month	Submitted	Granted	Refused as a result of the Cap being reached

Dec-18	2422	2018	0
Jan-19	1838	1597	0
Feb-19	2093	1691	0

Applications can be refused as they don't meet the criteria set out under Tier General. In addition, applications are rejected for being incomplete, withdrawn by the sponsor or kept under review to be decided at a subsequent monthly allocation panel. This accounts for the difference between the number of applications submitted in a month and the number of grants in the same month.

### **Visas: Applications**

**Laura Pidcock (Labour)** [229242] To ask the Secretary of State for the Home Department, what assessment he has made of the accessibility of online visa applications.

**Reply from Caroline Nokes:** UK Visas and Immigration are rolling out a new application platform across all application routes. The new application forms have been built to comply with the Government Digital Service standard, which in turn ensures compliance with wider standards on usability and accessibility.

Extensive testing has taken place with real users of the service, observing how they interact with the forms and adapting the design and questions in accordance with feedback from those testing sessions. In addition, we offer Assisted Digital support for customers who have difficulty completing online immigration applications, for example, if they do not have the appropriate access, skills or confidence to complete an online application without assistance.

Support is provided over the phone or face-to-face in locations across the UK, in a library or other voluntary sector centre or by a home visit from a tutor. This service has been available since September 2017 to customers who are based in the UK and has recently been extended to include the EU Settlement Scheme.

#### **Immigration: Income**

**Caroline Lucas (Green)** [229180] To ask the Secretary of State for the Home Department, if he will publish the findings of his Department's most recent review into the effects of the minimum income requirement.

**Reply from Caroline Nokes:** The Supreme Court has upheld the lawfulness of the minimum income requirement, which prevents burdens on the taxpayer and promotes integration, ruling that it strikes a fair balance between the interests of those wishing to sponsor a partner to settle in the UK and of the community in general. The Court found that the minimum income requirement is not a breach of the right to respect for private and family life under Article 8 of the European Convention on Human Rights and is not discriminatory.

We continue to keep the family Immigration Rules under review and make adjustments in light of feedback on their operation and impact. Our overall assessment is that the family Immigration Rules are having the right impact and are helping to ensure public confidence in the immigration system.

### **Immigration: EU Nationals**

**Connor McGinn (Labour)** [229264] To ask the Secretary of State for the Home Department, pursuant to the Answer of 5 February 2019 to Question 213222 on Immigration: EU Nationals, what the differences are between the rights retained by Irish citizens under the (a) EU Settlement Scheme and (b) Common Travel Area.

**Reply from Caroline Nokes:** Irish citizens have long-held a status in the UK that, like EU Treaty rights, allows them to live, work, study and access benefits and services without being subject to a requirement to obtain leave to enter or remain. This status will not be affected by the UK leaving the EU. Irish citizens resident in the UK can apply to the EU Settlement Scheme if they choose, though they are not required to given that the relevant rights are protected under the Common Travel Area (CTA) arrangements.

The arrangements for existing close family members, who are not Irish citizens or British citizens, to remain in the UK with, or join, EU citizens resident in the UK in the future are not provided for by the CTA arrangements but under the draft Withdrawal Agreement. Irish citizens will be able to support an application from family members without applying to the EU Settlement Scheme themselves.

### **Immigration: EU Nationals**

**Deidre Brock (SNP)** [228745] To ask the Secretary of State for the Home Department, if he will make an assessment of the potential merits of introducing exemptions from the requirement to apply for the settled status scheme for non-UK EU citizens who are of pensionable age and have lived in the UK for more than five years.

**Deidre Brock (SNP)** [228746] To ask the Secretary of State for the Home Department, if he will make an assessment of the potential merits of introducing exemptions to the requirement to apply for the settled status scheme for non-UK EU citizens who are spouses of UK citizens.

**Reply from Caroline Nokes:** We have considered carefully the introduction of the EU Settlement Scheme and its implications for EU citizens and their family members.

Exempting any cohort of EU citizen from the requirement to apply to the scheme could leave them at a disadvantage because they may be unable to demonstrate their entitlements to employment, benefits and services in the same way that other EU citizens who had applied to the scheme would be able to.

We are clear that we want all resident EU citizens to stay and have de-signed the EU Settlement Scheme to make the application process as simple and easy as possible for all cohorts of applicants.

### **Immigration: EU Nationals**

**Diana Johnson (Labour)** [231405] To ask the Secretary of State for the Home Department, pursuant to the Answer of 26 February 2019 to Question 222793 on applications for looked-after children through the EU Settlement Scheme, how many of the 19 applications made on behalf of looked-after children were made by (a) local authorities and (b) supporting organisations.

**Reply from Caroline Nokes:** In the most recent phase of testing, the Government made provision for eligible children and care leavers looked after by one of five local authorities specified in Immigration Rules to make an application to the EU Settlement Scheme. The five local authorities participating made 19 applications on behalf of looked after children.

Seven voluntary support organisations were also permitted to support EU citizens to make an application during this test phase.

### Entry Clearances: EU Nationals

**Lloyd Russell-Moyle (Labour Co-op)** [229227] To ask the Secretary of State for the Home Department, whether EU citizens will be able to enter the UK with an EEA National identity card under current terms after the UK leaves the EU.

**Reply from Caroline Nokes:** As set out in the Government's white paper 'The UK's future skills-based immigration system' (Cm 9722, published 19 December 2018), if we leave the EU with a deal, we intend to phase out the use of insecure national identity cards as soon as practicable after the end of the implementation period and will give fair notice of moving to a different arrangement, and time to adjust.

EU citizens covered by the citizens' rights deal will be able to travel using a national identity card or a passport, as now, for five years from the end of the implementation period (so until 31 December 2025) and thereafter if the cards meet the relevant International Civil Aviation Organisation (ICAO) biometric standards.

As set out in DExEU's policy paper on citizens' rights (published 6 December 2018), in the event that we leave the EU without a deal, EU citizens will be able to enter the UK by showing either a valid national identity card or a passport until 31 December 2020.

### Entry Clearances: EU Nationals

**Conor McGinn (Labour)** [230087] To ask the Secretary of State for the Home Department, with reference to his Department's White Paper on The UK's future skills-based immigration system, Cm 9722, how the proposed future introduction of Electronic Travel Authorisation for EU nationals set out in that White Paper will operate within local journeys in the Common Travel Area and local journeys over the Irish land border.

**Reply from Caroline Nokes:** The Government intends to introduce a requirement for visitors and transit passengers who do not need a visa to come to the UK to obtain an Electronic Travel Authorisation (ETA). The requirement will not apply to Irish nationals,

The detail of our ETA scheme is currently under development and requires primary legislation before it can be introduced.

The UK does not operate routine immigration controls on local journeys from within the Common Travel Area and the ETA scheme will be developed to operate in a way which is consistent with those arrangements.

### Refugees: Children

**Chi Onwurah (Labour)** [229183] To ask the Secretary of State for the Home Department, what steps he is taking to reduce the number of dangerous journeys being taken by unaccompanied child refugees with family in the UK.

**Reply from Caroline Nokes:** The Government has a number of policies in place

to prevent children from undertaking dangerous journeys to reach family in the UK – our family reunion policy, the Dublin Regulation, and the Mandate resettlement scheme.

This Government's family reunion policy allows a partner and children under 18 of those granted protection in the UK to join them here, if they formed part of the family unit before the sponsor fled their country. Under this policy, we have granted visas to over 26,000 partners and children of those granted protection in the UK in the last five years – that is over 5,000 a year. There are also separate provisions in the Immigration Rules to allow extended family to sponsor children to come to the UK where there are serious and compelling circumstances.

We continue to meet our commitments to transfer unaccompanied children in another EU Member State with qualifying family in the UK, under the Dublin Regulation for the purpose of assessing their asylum claim. We accept all requests for transfer of an unaccompanied child's asylum claims with qualifying family in the UK where transfer is in the child's best interests.

On a specific point, as part of the Sandhurst Treaty, signed between the UK and France in January 2018, we committed to deploying a UK Asylum Liaison Officer to support the transfer of eligible children under section 67 and the Dublin Regulation. We also allocated £3.6 million specifically to fund the development of the Dublin process to support transfers of eligible children to the UK, including training for those working with unaccompanied children, family tracing and targeted information campaigns.

And lastly, the Mandate resettlement scheme resettles recognised refugees who have a close family member in the UK who is willing to accommodate them. The refugee must be a minor child, spouse, or parent or grandparent aged over 65 of someone in the UK who is willing to accommodate and support them.

**Reply from Caroline Nokes:** The government remains fully committed to delivering on our commitment to relocate the specified number of 480 children under Section 67 of the Immigration Act 2016 and we continue to work very closely with participating States -France, Greece and Italy - and local authorities and delivery partners in order to meet this commitment as soon as possible.

Over 220 unaccompanied children have been transferred to the UK, and transfers of eligible children are ongoing. We will not provide a running commentary on numbers and will publish the details once all children are in the UK.

The Mandate Resettlement Scheme also allows those recognised by the UNCHR as refugees to join close family members here in the UK.

We always aim to resettle families referred to the UK's resettlement schemes by the UNHCR as close as possible to any family members already here in the UK, however this is subject to the availability of suitable and sustainable accommodation and relevant support services in that area.

We are working with key stakeholders and international partners on our future Asylum and Resettlement Strategy. This includes consideration of the UK's resettlement offer beyond 2020.

**Stuart C McDonald (SNP)** [217596] To ask the Secretary of State for the Home Department, with reference to the transition from the asylum accommodation COMPASS contracts to the Asylum Accommodation and Support Transformation contracts, whether transition, risk management and contingency plans have been shared with local authorities in participating asylum dispersal areas.

**Reply from Caroline Nokes:** The Home Office has designed the Asylum Accommodation and Support Transformation project to replace the current asylum accommodation and support services to ensure a smooth transition of services from one Provider to another.

The current timetable allows eight months for mobilisation and transition activities, which is similar to the time that such activity took when the current contracts came into operation.

The transition governance structure means that we are now working closely with local authorities and other statutory partners to ensure a smooth transition. Regional Transition leads are working to ensure that their regional plans are co-ordinated on a local basis with strategic stakeholders to manage risks and to ensure

effective contingency measures are in place to minimise impacts to all Service Users.

### Health Professions: Migrant Workers

**Lord Jones of Cheltenham (Liberal Democrat)** [HL14156] To ask Her Majesty's Government, further to the Written Answer by Baroness Blackwood of North Oxford on 27 February (HL13739), what plans they have, if any, to abolish the health surcharge for overseas health workers in order to recruit more health professionals from overseas; and if not, why not.

**Reply from Baroness Williams of Trafford:** There are no plans to exempt international healthcare professionals from the requirement to pay the Immigration Health Surcharge. It is right that healthcare professionals subject to immigration control who come to the UK for more than six months make a fair contribution to the running of the NHS, as do other providers of essential public services, including teachers.

The Government recognises the major contribution that overseas health workers, and other highly skilled professionals make to the UK. Nurses currently benefit from an exemption from the minimum salary threshold for Tier 2 and a number of health professions appear on the Shortage Occupation List.

In addition, on 6 July 2018 we took action to exempt doctors and nurses entirely from the annual Tier 2 cap that applies to skilled workers. This change means that there is no limit on the number of overseas doctors and nurses needed in the UK who can be sponsored to work here. The Home Secretary has recently made clear that he has no plans to remove that exemption.

**Baroness Doocey (Liberal Democrat)** [HL14164] To ask Her Majesty's Government what consideration they have given to a tourism and hospitality sectoral exemption in their proposals for intermediate and high-skilled migrants to earn a minimum salary of £30,000 per annum.

**Reply from Baroness Williams of Trafford:** As set out in the White Paper, 'The UK's future skills-based immigration system', we propose to define high, medium and lower skilled occupation by referring to the national Regulated Qualification Framework (RQF) levels.

Occupations falling into each of these skills will be set out in codes of practices.

In their report, EEA migration in the UK, the independent Migration Advisory Committee (MAC) recommended maintaining the existing £30,000 minimum salary

threshold. We are launching an extensive year long programme of engagement with a wide range of stakeholders across the UK, including the private, public and voluntary sector, employers and businesses, as well as the EU and international partners. We are also launching a number of new advisory groups and expand on existing forums, consisting of business and employer representatives, to help inform the detailed design of the future immigration system.

### **Immigration: EU Nationals**

**Lord Greaves (Liberal Democrat)** [HL14055] To ask Her Majesty's Government what plans they have to ensure that there is no gender discrimination built into the application scheme for settled status, including for (1) women who do not have continuous HMRC records, (2) people whose documents are largely in their husband's name, (3) people who have changed their name due to marriage, change of gender or other reasons, and (4) women who are victims of domestic violence or whose present or former husbands or partners are not willing to co-operate.



**Reply from Baroness Williams of Trafford:** The EU Settlement Scheme will accept a wide range of documentation as proof of residence. We have worked closely with our Safeguarding User Group to establish the types of evidence that vulnerable applicants will have available to them. The automated checks with Her Majesty's Revenue and Customs and the Department for Work and Pensions will, in most cases, provide us with the information we need to confirm residence. Where these checks are not sufficient, we allow for alternative ways of proving residence, including methods which do not rely on access to formal documentation.

When the scheme is rolled out fully from 30 March there will be additional provisions allowing applicants who are unable to provide identity documents due to circumstances beyond their control, or for compelling practical or compassionate reasons, to provide alternative evidence of their identity. This may include where such documents are being held by abusive partners or employers.

**Reply from Richard Harrington:** The Government is committed to supporting all entrepreneurs to start and grow a business and is a key aspect of our ambitious Industrial Strategy. The government supports diversity in business and recognises the valuable contribution of BAME communities to our economy.

British Business Bank programmes are also currently supporting over £5.9bn of finance to over 82,000 SMEs. The Start-Up Loans programme, now part of the British Business Bank, has delivered nearly 61,000 loans totalling over £464m, and was extended in the autumn budget to April 2021 to enable up to an additional 10,000 loans to be made to entrepreneurs. Of these 22% of loans were made to entrepreneurs with a BAME background (4% of existing SMEs have a BAME owner). ...

As a key part of the Industrial Strategy, Sector Deals are supporting business of all sizes across the economy and ensuring that businesses meet our wider goals to improve diversity and inclusion in our workforce. For example, the Offshore Wind Sector Deal commits the sector to calculating a baseline figure for BAME representation and to set a stretching target for improving this by the end of 2019.

**Reply from Kelly Tolhurst:** The Government is committed to supporting all entrepreneurs to start and grow a business and is a key aspect of our ambitious Industrial Strategy. The government supports diversity in business and recognises the valuable contribution of BAME communities to our economy.

British Business Bank programmes are also currently supporting over £5.9bn of finance to over 82,000 SMEs. The Start-Up Loans programme, now part of the British Business Bank, has delivered nearly 61,000 loans totalling over £464m, and was extended in the autumn budget to April 2021 to enable up to an additional 10,000 loans to be made to entrepreneurs. Of these 22% of loans were made to entrepreneurs with a BAME background (4% of existing SMEs have a BAME owner).

On 6<sup>th</sup> March BEIS launched the Young Entrepreneurs Review, independently led by the Prince's Trust. The Review will close in September 2019 and will seek to better understand young entrepreneurs, the specific barriers and opportunities they face, and what more can be done to support them to start and grow a business, including young entrepreneurs from a BAME background.

## Racism, Religious Hatred, and Discrimination

### Scottish Parliament Oral Answers

#### Sectarianism (Reduction and Prevention Funding)

**James Dornan (SNP):** To ask the Scottish Government how much funding it provides to organisations that aim to reduce and prevent sectarianism in society. (S5O-02982)

**Reply from the Cabinet Secretary for Justice (Humza Yousaf):** The Scottish

Government has invested £13.5 million to support anti-sectarian education in schools, prisons, workplaces and communities over the past seven years, which has supported more than 100 projects to deliver anti-sectarian education and activity across Scotland. In 2018-19, that includes £515,000 for nine projects, including Nil by Mouth and sense over sectarianism. We intend to build on that work in 2019-20 by ensuring that there is a real-terms increase to the funding for work in the area. I will shortly make an announcement about the specific work that will be funded in 2019-20.

**James Dornan:** It is clear from the cabinet secretary's answer that third sector organisations are undertaking a lot of work to eradicate sectarianism in Scotland. They include the aforementioned Nil By Mouth as well as the West of Scotland Regional Equality Council and North Kelvin Sports Development Group, all of which are members of my cross-party group on combating sectarianism in Scottish society.

Does the cabinet secretary agree that, although sectarianism is undoubtedly a societal issue, football is a huge part of Scottish society and therefore football, too, must play its part in the eradication of this terrible problem, which so often rears its ugly head in football stadia?

**Reply from Humza Yousaf:** I thank James Dornan for raising that issue. He has raised it many times in the chamber, for which he should be given credit. I know that he has suffered a lot of abuse because he has raised his head above the parapet to mention the issue very publicly in the chamber. I thank him for that. James Dornan is absolutely right that sectarianism is a wider societal issue, and therefore the work that has been done in communities is very important. However, it would be silly and ignorant of us—we would be burying our heads in the sand—to ignore the obvious recent unacceptable conduct in that regard in and around football. I have said many a time, but I will repeat and re-emphasise it, that football clubs have to take real responsibility in this area; if they do not, the Government of course reserves the right to act.

**Liam Kerr (Conservative):** The cabinet secretary has talked about where the funding is going, but a written answer that the Scottish Government provided to me in October revealed that, of the nine organisations that are funded by the Scottish Government to tackle sectarianism, only one—Nil by Mouth, which James Dornan mentioned—takes its message to workplaces. Education in schools is of course vital, but what steps is the Scottish Government taking to improve the number of initiatives that are aimed at working-age adults?

**Reply from Humza Yousaf:** That is a good point. As I said, I will shortly make an announcement on the specific work that will be funded in 2019-20. We have to work in schools, workplaces, prisons and communities. I will have another look at the organisations that we are funding, and if we think that we can build on that and do more in specific sectors or areas of society, we should do that. I am afraid that the issue is a society-wide one that goes from young people all the way to old people, and we should cover as much of society as possible. I will reflect on what the member says. As I said, I will make an announcement on the matter shortly, but I am happy to keep the conversation going with him and with anybody else who has an interest in tackling this scourge.

### Schools: Racial Discrimination

**Giles Watling (Conservative)** [228161] To ask the Secretary of State for Education, what steps his Department is taking to encourage anti-racism initiatives in schools.

**Reply from Anne Milton:** All schools are required to actively promote our shared values of democracy, the rule of law, individual liberty, and mutual respect and tolerance for those of different faiths and beliefs. Schools are also required to promote equality and respect for others, with particular regard to the protected characteristics. Promotion of these values is part of Ofsted's inspection framework and the department has published guidance to schools on promoting these important values as part of pupils' spiritual, moral, social and cultural development. In 2016, the department also launched the Educate Against Hate website which provides resources for teachers and school leaders to support their promotion of these values. This includes the department's Respectful Schools Communities toolkit; a self-review and signposting tool to support schools to develop a whole-school approach which promotes respect and discipline.

Additionally, subject to the passage of regulations through parliament, schools will be required to teach relationships education to all primary pupils and relationships and sex education to all secondary pupils from September 2020. The focus is on building positive, respectful relationships, including online, and understanding the impact of harmful stereotypes and bullying.

The department also supports a number of specific initiatives in schools to combat bullying. The department is providing over £2.8 million of funding, between September 2016 and March 2020, to 4 anti-bullying organisations to support schools to tackle bullying. This includes projects targeting bullying of particular groups, such as those who are victims of hate-related bullying, along with a project to report bullying online. These projects contribute towards the government's Hate Crime Action plan.

Finally, as part of our commitments in the government's Integrated Communities Action Plan, the department has funded an expanded national school linking programme. This seeks to encourage meaningful social mixing between different types of schools and foster understanding of those with different backgrounds, faiths and beliefs. Last year, the Linking Network worked with over 400 schools leading to 17,635 pupils taking part in activities supporting integration.

Sharia-compliant home purchase plans are enabled by regulations overseen by the Financial Conduct Authority (FCA). They are currently offered by four UK banks.

Beyond the requirements set out in the FCA regulations, decisions around the pricing and availability of individual mortgage loans remain commercial decisions for lenders, and the Government does not seek to intervene in these decisions.

## Responses to the New Zealand Mosque Attacks

### UK Parliament, House of Commons

#### **Speaker's Statement: New Zealand Terror Attacks**

**Mr Speaker:** In respectful memory of the 49 people who horrendously lost their lives in the terrorist attack in Christchurch, New Zealand, and of the apparently dozens who were injured in the attack on the two mosques, as well as in solidarity with the people of New Zealand and Muslims around the world, I humbly suggest to the House ... that we hold one minute's silence at 11 am. ...

**The Minister for Security and Economic Crime (Ben Wallace):** Let me say to the House on behalf of the Government that we send our sincere condolences to the victims and people of New Zealand for their loss, and that they have our offer of any assistance required to deal with this repugnant attack. The UK stands shoulder to shoulder with New Zealand against terrorism, and we will not falter in our commitment to uphold the values of tolerance, religious freedom and democracy that we both hold so dear.

Later today, the Home Secretary and I will be speaking to police counter-terrorism leaders and the security services to discuss what further measures we can take to protect our mosques and communities from any threat here in the United Kingdom. No one should be in any doubt that our police and security services treat all threats the same and all terrorists the same. No matter what community, religion or background they come from, a terrorist is a terrorist, and we shall deal with them exactly the same.

**Mr Speaker:** I thank the Minister for the clarity and passion with which he has addressed

the House. Colleagues will not be surprised to know that I intend to write to my opposite number in New Zealand, and I know that I will be able to do so conveying the sympathies of the House and the collective outrage of the House at this bestial slaughter.

**Wes Streeting (Labour):** As the co-chair of the all-party parliamentary group on British Muslims, I thank you, Mr Speaker, for what you have just said. I also thank, most deeply and sincerely, the Security Minister for what he said about reassuring our own Muslim community in this country. Any of us who understand the Muslim community will understand why what has happened in Christchurch will be felt deeply by Muslims in this country and right across the world, but we do not have to be Muslim to understand their loss, and their sense of grief and fear; we just have to be fully paid-up members of the human race.

Mr Speaker, I warmly endorse what you and the Security Minister have said. Through you, may I express our solidarity with the Prime Minister of New Zealand, all the people of Zealand and Muslims right across the world? In the wake of Islamophobia and anti-Muslim prejudice not just in this country but right across the world, let us say plainly and simply that we are not blind to what is going on; we have been here before on many different fronts and in the face of many different types of prejudice. ...

It is time for all of us in this House, across the country and around the world to think about the hatred and prejudice facing not only Muslims but lots of minorities, and to understand what it genuinely means to be an ally and never to be a bystander. As we have seen painfully in Christchurch, this is where hatred and prejudice lead, but this is not necessarily how it needs to end. ...

**Thangam Debonnaire (Labour):** ... I have the great honour and privilege of representing a constituency where there is a large faith community of many faiths. I want to say to the Muslims in my constituency, as Jacinda Ardern said this morning to Muslims in New Zealand: we are you, and you are us, and this hatred is not us; it is not for us. I know the pain that my Muslim constituents will feel. The thought that people could walk into a place of prayer and face this is unbearable. It will give my constituents comfort that you have extended your thoughts to them, Mr Speaker, and that the Security Minister is attending to this. I wish to add my thanks to him and ask him to do everything he can to ensure that those in mosques across this country feel safe not just today but forever, and that they are welcome, because they are us and we are them. ...
