### UK Parliament, House of Commons Written Answers

#### **Visas: Applications**

**Louise Ellman (Labour Co-op) [280157]** To ask the Secretary of State for the Home Department, what representations he has received on the efficiency of the UK Visa and Citizenship Application Services online appointment booking system; and if he will make a statement.

**Louise Ellman (Labour Co-op) [280162]** To ask the Secretary of State for the Home Department, what plans he has to improve the UK Visa and Citizenship Application Services online appointment bookings system; and if he will make a statement.

**Reply from Seema Kennedy:** Sopra Steria Ltd (SSL) monitors the performance of

the UKVCAS website and regularly reviews feedback from customers to ensure the website meets their needs and expectations.

So far, since service inception in November, the following improvements have been made to the online booking system:

- more detailed information in the FAQs section to help customers resolve problems
- improved visibility of appointments by expanding the number of locations that customers can view from four to eight.
- extended period for customers booking appointments from four to six weeks for core service points and from two to four weeks for enhanced service points.

### **English Language: Education**

**Rosena Allin-Khan (Labour)** [280442] To ask the Secretary of State for Education, whether his Department has conducted an impact assessment on changes in English for Speakers of other Languages funding.

**Rosena Allin-Khan (Labour)** [280444] To ask the Secretary of State for Education, what steps the Government has taken to ensure that people who are granted refugee status and who do not speak English as their first language are offered a two-year course in English as a foreign language.

**Reply from Kemi Badenoch:** The government recognises that learning English is essential to help people integrate into life in England, including breaking down barriers to work and empowering refugees to rebuild their lives. That is why the Department for Education supports adults in England through the Adult Education Budget (AEB) to secure the English language skills they need. The AEB is allocated on an annual basis, and colleges and adult learning providers have the freedom and flexibility to determine how they use their AEB allocation to meet the needs of their communities. This includes planning, with local partners, the English for Speakers of Other Languages (ESOL) courses that they will deliver locally. The Home Office and the Department for Education have also provided £10 million specifically to enable refugees resettled through the Vulnerable Persons Resettlement Scheme to access additional classes.

The government has committed to developing a new strategy for ESOL in 2019. The strategy will provide a shared vision for all publicly funded English language provision including addressing the needs of refugees and migrants. Funding for all programmes beyond 2019/20, including any potential funding for this strategy, will be set during the upcoming Spending Review.

**Lord Steel of Aikwood (Liberal Democrat)** [HL17371] To ask Her Majesty's Government what assessment they have made of the joint All-Party Parliamentary Group (APPG)

report by the APPG for Africa, the APPG for Diaspora, Development and Migration and the APPG for Malawi Visa problems for African visitors to the UK, published on 16 July, in particular its findings in regard to the level of refusals of short-term visitor visa applications from Africa.

**Reply from Baroness Williams of Trafford:** Officials will review the findings of the report and the Immigration Minister will respond on it in due course.

#### **Entry Clearances: Overseas Students**

**Lord Jones of Cheltenham (Liberal Democrat)** [HL17408] To ask Her Majesty's Government, further to the International Education Strategy: global potential, global growth, published in March, what plans they have to introduce a new system of visas for international students to (1) enable the growth of international student numbers, (2) improve their experience of applying for visas, (3) reduce the administrative burden and be cost-effective, and (4) increase the reliability, transparency and accountability of the immigration system.

**Lord Jones of Cheltenham (Liberal Democrat)** [HL17409] To ask Her Majesty's Government, further to the International Education Strategy: global potential, global growth, published in March, what plans they have to introduce a new system of visas for international students which would (1) increase the diversity of applicants, (2) be accessible to all applicants, and (3) be simpler for students and sponsors to understand and navigate.

**Reply from Baroness Williams of Trafford:** The Government welcomes international students and has an ambition to increase the total number of international students hosted in the UK to 600,000 per year by 2030. University-sponsored Tier 4 visa applications rose by 10% in the year ending March 2019 and are at their highest level on record. 97% of those who applied for a Tier 4 visa in 2018 were granted.

As set out in the immigration white paper 'The UK's future skills-based immigration system' and supporting the International Education Strategy, we will increase the post-study leave period for postgraduate students to six months, and doctorate students to a year, and make it easier for graduates to switch into skilled work in the UK. We will also increase the post-study leave period for all undergraduates studying at institutions with degree awarding powers to six-months. These changes will benefit hundreds of thousands of students. We keep the visa system under review to ensure it remains fit for purpose and that the UK's visa system is world-class, with the aim of improving the customer journey both for students and their sponsoring institutions. This will include reviewing processes for conducting interviews to ensure that these are appropriately focused and to minimise any inconvenience for applicants and continuing to consider the increased use of differentiation, streamlining the application process by allowing students to benefit from reduced documentary requirements when applying for a visa.

### **Immigrants: Domestic Abuse**

**Baroness Hamwee (Liberal Democrat)** [HL17515] To ask Her Majesty's Government what arrangements they have in place to protect non-EU nationals resident in the UK who are victims of domestic abuse, and in particular to ensure access to homelessness support, refuge and benefits.

**Reply from Baroness Williams of Trafford:** This Government is committed to tackling domestic abuse against all women, regardless of their background or nationality. On 16 July this Government introduced the Domestic Abuse Bill which aims to improve protection and support for all victims irrespective of their immigration status.

Non-British victims residing in the UK are able to apply for support from authorities, many of whom will have statutory obligations to support victims. For individuals in the UK who are married, or partners of, British or settled sponsors and who claim to be victims of abuse, there is the option of applying for immediate crisis support under the Destitute Domestic Violence Concession (DDVC).

In addition, funding has been made available to support a range of support networks. In March £1,090,000 was made available specifically to be used to provide safe accommodation, and other support functions.

We are not complacent about our responses to domestic abuse. We strive to see what more can be done and we have committed to reviewing the support available to migrant victims of domestic abuse. The review will be launched over the summer and we aim to report progress of the review during the passage of the Bill.

### **Free School Meals: Immigrants**

**The Lord Bishop of Durham** [HL17456] To ask Her Majesty's Government, further to the answer by Baroness Williams of Trafford on 23 July (HL Deb, cols 668–70), what plans they have to review access to free school meals for children who are affected by having no recourse to public funds.

**Reply from Lord Agnew of Oulton:** As per the response provided by my noble Friend, Baroness Williams of Trafford, during the debate on 23 July, decisions around recourse to public funds are made by the Home Office.

Free school meals are available to disadvantaged families in receipt of certain qualifying benefits, including children of immigrants and refugees who are receiving support under Part VI of the Immigration & Asylum Act (1999).

The Home Office is able to exercise discretion to grant recourse to public funds where the family would otherwise be destitute. Where this entitles the family to receive certain benefits, they may also be able to claim free school meals.

### **Immigration: EU Nationals**

**The Lord Bishop of Durham** [HL17344] To ask Her Majesty's Government what is the status of the guidance issued on 3 April to all local authorities and health and social care trusts in regard to the EU Settlement Scheme and looked-after children and care leavers; and whether it is mandatory for local authorities to follow that guidance.

**The Lord Bishop of Durham** [HL17345] To ask Her Majesty's Government what evidence was collected on the children who were non-UK European nationals accommodated under section 20 of the Children Act 1989, their family situations and possible vulnerabilities, before drafting the guidance on EU Settlement Scheme and looked-after children and care leavers issued on 3 April.

**The Lord Bishop of Durham** [HL17346] To ask Her Majesty's Government what plans they have to evaluate the impact of the funding of support and its provision to vulnerable groups, including analysis of what future work is needed to ensure that vulnerable groups are able to apply to the EU Settlement Scheme after funding ends in March 2020.

**Reply from Baroness Williams of Trafford:** The guidance pack issued to local authorities in England, Wales and Scotland and to Health and Social Care Trusts in Northern Ireland on 3 April is not statutory guidance. The pack puts together in one place, information readily available on gov.uk to provide a useful tool for front line local authority and HSCT staff tasked with supporting looked after children and care leavers. The Children Act 1989 provides the legal framework for local authorities to promote a child's welfare and best interests, setting out statutory duties in relation to looked after children in England, with respective authorities for the devolved administrations. Statutory guidance is provided by DfE in relation to this. This statutory duty to promote best interests, coupled with funding provided to local authorities under a new burdens assessment should ensure that this important work will be done.

During a private trial phase of testing five local authorities were asked for detailed information on the children in their care eligible to apply to the EUSS, including what ID evidence they had access to and family situations in order to ascertain difficulties in obtaining identity documents. The participating local authorities, along with the seven other community organisations participating in the trial phase provided detailed feedback on challenges they encountered during the test phase, which was considered before drafting the guidance. The new burdens assessment takes into account work required to identify the cohort of eligible children as well as work needed to undertake the EUSS application process itself.

Organisations awarded grant funding are required to submit monitoring reports to the Home Office and this content will be used to assess of the grant funding. Grant funded organisations will be reporting on the number of vulnerable people they have supported to make applications and this will assist in determining what future support is required after March 2020.

### **Immigration: EU Nationals**

**Lord Greaves (Liberal Democrat)** [HL17347] To ask Her Majesty's Government whether they are giving a guarantee to EU citizens who are resident in the UK that the proposals for settled status and pre-settled status will apply whether or not there is a negotiated deal for the UK leaving the EU; and whether they are guaranteeing that settled status will last for life once granted.

**Lord Greaves (Liberal Democrat)** [HL17348] To ask Her Majesty's Government what estimates they have made of the number of EU citizens who (1) are resident in the UK, (2) will have applied for settled status by the end of 2020, and (3) will still be living in the UK by the end of 2020 without having made an application for settled status.

**Lord Greaves (Liberal Democrat)** [HL17349] To ask Her Majesty's Government what procedures they plan to have in place to apply to EU citizens who are resident in the UK at the end of 2020 who will have (1) applied for settled status but not been granted either that status or pre-settled-status, and (2) not made an application by that date.

**Reply from Baroness Williams of Trafford:** On 6 December 2018 the Government confirmed that the EU Settlement Scheme will continue to operate whether the UK leaves the European Union with or without a negotiated deal. This ensures that the rights of EEA and Swiss citizens resident in the UK before it leaves the EU will be protected in every outcome.

Those granted settled status under the scheme will retain that status for life, unless they allow their leave to lapse by being absent from the UK and the Islands (the Bailiwick of Jersey, the Bailiwick of Guernsey and the Isle of Man) for a period of more than five years, or that status is revoked or cancelled, for example as a result of serious criminality.

The Home Office estimates that the total number of EEA and Swiss citizens (excluding Irish citizens) eligible to apply for the EU Settlement Scheme by the end of the planned implementation period on 31 December 2020 is likely to be between 3.5 million and 4.1 million.

As set out in the revised Impact Assessment for the scheme, the estimate is based on a number of assumptions as to how the size of the resident EEA population will change over the period, and on an initial estimate that 3.4 million EEA and Swiss citizens (excluding Irish citizens) were resident in the UK in the year October 2017 to September 2018. Therefore, the figure should be considered indicative as future migration flows can be affected by many factors and are difficult to predict. The revised Impact Assessment can be found at:

We are working extensively with a range of stakeholders to ensure that all those who are eligible to apply do so by the deadline of 30 June 2021 for those resident in the UK by the end of the implementation period on 31 December 2020 (or, in a no deal scenario, by 31 December 2020 for those resident in the UK by exit). We have made clear that we will take a proportionate approach to anyone who misses the deadline and will make provision for those who have reasonable grounds for doing so to apply after the deadline. Those who apply before the deadline but whose application is not decided until after the deadline will have all their rights protected until their application is concluded.

**Baroness Doocey (Liberal Democrat) [HL17397]** To ask Her Majesty's Government what is the Home Office's strategy for ensuring that the families of EU national offenders and EU nationals in the probation system are able to apply for settled or pre-settled status through the EU Settlement Scheme.

**Reply from Baroness Williams of Trafford:** The Home Office is working closely with the Ministry of Justice, Her Majesty's Prison and Probation Service, the Devolved Administrations and relevant voluntary and community sector groups to ensure that the EU Settlement Scheme is accessible to EU national offenders and their family members eligible to apply for status under it.

#### **Immigration: EU Nationals**

**Baroness Hamwee (Liberal Democrat) [HL17401]** To ask Her Majesty's Government what steps they are taking, or intend to take, to ensure that EU nationals granted pre-settled status under the EU Settlement Scheme but who fail to apply for settled status and become illegal residents are not placed in immigration detention.

**Reply from Baroness Williams of Trafford:** We have been clear that encouraging and supporting compliance will be at the heart of our future immigration system. As with our commitment to take a proportionate approach to anyone who has reasonable grounds for missing the deadline to apply to the EU Settlement Scheme, we will also take a proportionate approach to these individuals with pre-settled status and give them every opportunity to regularise their status.

As mentioned in the Statement of Intent for the EU Settlement Scheme, we intend to send a reminder to people to apply for settled status before their pre-settled status expires. We will set out further details on our approach to situations like this as part of our broader plans for the future immigration system in due course.

### **Immigration: EU Nationals**

**Baroness Hamwee (Liberal Democrat)** [HL17403] To ask Her Majesty's Government what assessment they have made of the case for applying a lower suitability threshold than for adults for children from the EU, European Economic Area and Switzerland living in the UK who are applying for settled status under the EU Settlement Scheme.

**Reply from Baroness Williams of Trafford:** Under the relevant provisions of the Immigration (European Economic Area Regulations) 2016, children under the age of 18 benefit from a higher level of protection and can only be deported on imperative grounds of public security.

The Home Office has not made an assessment of the case for applying lower suitability thresholds for children applying for settled status under the scheme. The EU law public policy and public security test will continue to apply to conduct committed before the end of the implementation period if the UK leaves the EU with a deal, or to pre-exit conduct if we leave without a deal.

This is consistent with the Withdrawal Agreement and the Free Movement Directive.

This statutory duty to promote best interests, coupled with funding provided to local authorities under a new burdens as-sessment should ensure that this important work will be done.

The Home Office engaged with the Department for Education, the Association of Directors Childrens Services and other Local Authority stakeholders across the UK in advance of publishing the guidance. The Home Office also conducted a private trial phase of testing where five local authorities were asked for detailed information on the children in their care eligible to apply to the EUSS, including what ID evidence they had access to and family situations in order to ascertain difficulties in obtaining identity documents.

The participating local authorities, along with the seven other community organisations participating in the trial phase provided detailed feedback on challenges they encountered during the test phase, which was considered before drafting the guidance.

The Home Office is committed to continuing to engage with local authorities as they undertake their responsibilities to ensure that all eligible looked after children and care leavers are supported to make an application to the EUSS. The Home Office

will ensure that caseworkers liaise with and support applicants to get the status they require. We consulted with the Department for Education in advance of publishing the guidance to ensure adequate consideration was given to other categories of looked after children, where the local authority does not hold full PR, under section 20 of the Children Act 1989. It has been confirmed that in those cases there is a duty on the local authority to raise awareness of the EU Settlement Scheme to those with PR for those eligible child(ren) and to provide practical support where needed, or signpost to relevant community support where deemed more appropriate to do so.

### **Immigrants: Children**

**The Lord Bishop of Durham** [HL17455] To ask Her Majesty's Government, further to the answer by Baroness Williams of Trafford on 23 July (HL Deb, cols 668–70), how many children have been affected by having no recourse to public funds in each of the 54 local authorities; and what estimate they have made of the total number of children so affected.

**Reply from Baroness Williams of Trafford:** There are no official figures for the number of cases subject to no recourse to public funds restrictions. Families including children may be subject to such restrictions as a consequence of their immigration status where they have been granted temporary leave to remain, or where they require leave but do not have it. The expectation is that the majority of people granted time-limited leave under the Immigration Rules, including those entering as visitors, workers, students and those on the path to settlement, will support themselves without placing pressures on taxpayers.

Families granted time-limited leave in the family and private life route can request the Home Office to lift conditions restricting access to public funds to avoid destitution. The Home Office provides support to asylum seekers and works closely with local authorities operating duties to support those with community care needs, including families with children.

### Scottish Parliament Written Answers

#### Early learning and childcare statistics: ethnicity

**S5W-24125 Alex Cole-Hamilton (Liberal Democrat):** To ask the Scottish Government for what reason it does not record data on ethnicity in early learning and childcare statistics, and whether it plans to start recording such data.

**Reply from Maree Todd:** The current Early Learning and Childcare (ELC) census is collected annually from centres delivering funded ELC in September. It was designed to capture the number of funded registrations with ELC providers, along with some additional breakdowns such as stage and additional support needs. The methodology makes it difficult to capture more detailed information at an aggregate level, such as ethnicity, without encountering quality issues and placing a significant burden of collection on providers.

It has been recognised for some time that the current ELC census is not sufficient to provide the information necessary to manage this growing sector, and so since 2015 we have been carrying out a development project to transform the ELC census to an individual level child census. The new census process will be based on extractions of data from management information systems, and will collect more information on the characteristics of children registered for funded ELC, including ethnicity. Data from the new census will be available in 2021.

**Reply from Aileen Campbell:** The Tackling Child Poverty Delivery Plan is backed by the £50 million Tackling Child Poverty Fund, as announced in Programme for Government 2017-18. Current investment is set out within the first annual progress report published in June 2019.

The Fund is supporting innovative projects to tackle and reduce levels of child poverty in Scotland so minority ethnic households will benefit from all of the programmes supported from the Fund. In addition, we have outlined that the Fund will invest £500,000 (2020-22) to work directly with Gypsy/Traveller families and other partners on our community education programme.

Member for Houghton and Sunderland South, representing the Speaker's Committee on the Electoral Commission, what recent discussions the Commission has had with (a) church and community leaders from black and minority ethnic communities and (b) Operation Black Vote on increasing registration levels for voters in those communities.

**Reply from Bridget Phillipson:** We know from our research of the electoral registers that voters from BME communities are less likely to be registered to vote when compared with white voters.

As part of all of its public awareness campaigns ahead of elections, the Electoral Commission provides voter registration resources to a wide range of groups or individuals, to use in encouraging registration. These are freely available via the Commission's website or its 'Roll Call' newsletter, to which anyone can subscribe. We also identify specific organisations who could help promote registration to under-registered groups and actively provide these partners with resources: these have recently included, for example, the Council of African and Caribbean Churches and the Muslim Women's network. It also works closely with Electoral Registration Officers, who hold many important relationships with church and community leaders to promote voter registration at a local level.

The Commission most recently contacted Operation Black Vote ahead of the Government's voter ID pilots which took place in May 2019, to seek a contribution to its statutory evaluation of the pilots. It did not receive a response.

There were 230 Grade 5 staff, of whom 200 had declared their ethnicity; of these 11 were BAME. This means that 5.5% of Grade 5 staff with known ethnicity were BAME.

There were 54 Grade 3 staff, of whom 46 had declared their ethnicity; the number



of these who were BAME was less than three.

This is based on staff voluntarily recording their ethnicity data on the HR system (SOP).

## UK Parliament, House of Lords Written Answers

### Racial Discrimination

**Lord Jones of Cheltenham (Liberal Democrat)** [HL17521] To ask Her Majesty's Government what plans they have to review legislation on racism; and what action they intend to take to eliminate racist attacks in the UK.

**Reply from Viscount Younger of Leckie:** The United Kingdom has one of the strongest legislative frameworks in the world to protect communities from hostility, violence and bigotry. We believe that no-one's opportunities in life should be determined by their ethnicity or religion.

The Government takes racist attacks very seriously, which is why we published the Hate Crime Action Plan in 2016. This was refreshed in 2018, when we committed up to £1.5 million for projects to tackle racially and religiously motivated hatred. We continue to work with the police and third party services such as the Community Security Trust, Tell MAMA and GATE Herts to encourage reporting and support victims of racially motivated hatred.

We have also asked the Law Commission to undertake a review of hate crime legislation and, last year, launched a national hate crime public awareness campaign.

**Reply from Lord Agnew of Oulton:** On 16 May 2019, the former Minister for Universities, Science, Research and Innovation (Chris Skidmore), my hon. Friend for Kingswood, wrote to higher education providers on the importance of tackling antisemitism in universities. This letter urged them to consider adopting the International Holocaust Remembrance Alliance (IHRA) definition and set out his view that, although legally non-binding, it is a useful tool which will help front-line services better understand and recognise instances of antisemitism.

This government believes that adopting the IHRA definition of antisemitism sends a clear message that antisemitic behaviour will not be tolerated, and that any instances of antisemitism will be taken very seriously. It is for public bodies and agencies to implement the definition and embed it within operational guidance as relevant. As autonomous organisations, it is for each higher education provider to

decide if and how they wish to implement the IHRA definition. The government will continue to call on providers to demonstrate their commitment to Jewish students on campus by adopting this definition in its entirety.

In this letter, the former Minister for Universities, Science, Research and Innovation (Chris Skidmore), my hon. Friend for Kingswood, communicated to providers that the department would be keen to hear more regarding the initiatives taken by providers to address antisemitism and all forms of intolerance, harassment and hate-crime. The following institutions have so far responded to the letter: University of Cambridge, University of Nottingham, Nottingham Trent University, University of Oxford, University of Worcester, SOAS University of London and University of Southampton.

**Lord Pearson of Rannoch (UKIP) [HL17222]** To ask Her Majesty's Government, further to the Written Answer by Lord Keen of Elie on 4 July (HL16559), what proportion of the prison population of HMP Belmarsh identifies as Muslim; and how this compares to the average of the proportion of prisoners who identify as Muslim in other prisons in England and Wales.

**Reply from Lord Keen of Elie:** HMP Belmarsh had a population of 826 on the 31<sup>st</sup> March 2019. On the same date there were 233 Prisoners at HMP Belmarsh who identified as Muslim, which represents 28.20% of the population.

Available statistics for England and Wales ending 31<sup>st</sup> March 2019 showed an overall Prison Population of 82,634. Of that Population, a total of 13,008 Prisoners identified as Muslim, which represents 15.74% of the Prison Population.
