UK Parliament, House of Commons Oral Answers

EU Citizens

Philip Dunne (Conservative): What discussions [has the Minister] had with the Home Secretary on the level of fees payable by EU citizens who are the spouse of a UK national and continue to reside in the UK after the UK leaves the EU. [900008]

Reply from the Parliamentary Under-Secretary of State for Exiting the European Union (James Duddridge): The Secretary of State regularly discusses the rights of EU citizens with the Home Secretary and other Cabinet colleagues. To protect the right to reside, EU citizens who are resident at the end of the implementation period must apply for settled status by June 2021. This is a free-of-charge process, and we have already received well over 2.6 million applications to the scheme.

Philip Dunne: I am grateful to the Minister for that reply, and obviously I am delighted by

the progress that the settlement scheme is making in encouraging EU citizens who are here to remain. In common with many colleagues in the House, I spent a number of days in the last few weeks knocking on doors and talking to my constituents. One of the people I came across was an EU citizen—an Italian who was married to a British lady and had lived here for over 50 years, working all the time and paying his taxes. He wanted to become a British citizen, but is faced with an application fee of £1,700. Does my hon. Friend think that that is fair? Is there something that we can do to encourage people who have lived here for a long time to become British citizens?

Reply from James Duddridge: I am more than happy to meet my right hon. Friend to talk about the specifics of that case and the EU settlement scheme. Yesterday the Minister for immigration talked about why that issue would not be covered by the withdrawal agreement Bill, but I am more than happy to chat to my right hon. Friend about that individual case.

Peter Grant (SNP): Does the Minister have even the tiniest twinge of conscience at the sheer immorality of demanding that somebody pay an extortionate sum simply to be allowed to continue to live in their own home?

Reply from James Duddridge: The settlement scheme is free.

Philip Hollobone (Conservative): To what extent is the Government's EU settlement scheme in this country being replicated by the EU27, including with reference to fees and charges?

Reply from James Duddridge: My hon. Friend makes a good point. The Prime Minister made a big, bold offer for EU citizens, and we urge member states to do the same.

Jim Shannon (DUP): Will the Minister further outline whether he intends to level the fees between European partners and Commonwealth partners such as Canada to ensure that there is a level playing field for immigration? Is he aware that that would reduce the fees paid by Commonwealth spouses?

Reply from James Duddridge: Such issues are for the Home Office, but an advantage of taking back control is that we can look at our relationships with other parts of the world, particularly the Commonwealth, which makes up a third of the world by population.

Joy Morrissey (Conservative): Can my hon. Friend assure EU citizens in Beaconsfield that there is no charge for applying for settled status?

Reply from James Duddridge: ... I agree fully.

Wera Hobhouse (Liberal Democrat): What recent discussions [has the Minister] had with Cabinet colleagues on protecting the rights of EU citizens living in the UK after the UK leaves the EU. [900009]

Reply from the Secretary of State for Exiting the European Union (Steve Barclay): I have regular discussions with Cabinet colleagues on citizens' rights. The withdrawal agreement will protect the rights of EU citizens who arrive in the UK by the end of the implementation period. As of the end of November, we were already moving towards receiving 3 million applications to the EU settlement scheme.

Wera Hobhouse: Will EU nationals who fail to get settled status by the end of this year become our next Windrush generation, losing their driving licences and jobs, and ultimately facing deportation?

Reply from Steve Barclay: I am glad that the hon. Lady asks that question, because it lets me say: first, we have a grace period until June 2021 to address that issue; and, secondly, the declaratory scheme that she advocates would increase the risk of exactly the issue to which she refers.

Andrew Bridgen (Conservative): Does the Secretary of State agree that the fact that 3.5 million EU citizens see the best future for themselves and their families as to remain living and working in post-Brexit Britain is a huge endorsement of our post-Brexit prospects? I

wish that that confidence was shared by hon. Members on both sides of the House.

Reply from Steve Barclay: I urge Members on both sides of the House to support Third Reading of the withdrawal agreement Bill because it safeguards the rights of the 3 million EU citizens here, as it does those of the 1 million or so UK citizens in Europe. The Bill guarantees the rights of those EU citizens because we value the contribution they make to our homes, communities and businesses.

Thangam Debbonaire (Labour): Refusing to provide paper proof of status, rejecting Labour's proposal to grant automatic status, granting only uncertainty inducing pre-settled status to people who have been here legally for years and the high cost of applying for citizenship—what part of all that does the Secretary of State believe makes our EU friends and neighbours living in the UK feel truly valued and welcome? ...

Reply from Steve Barclay: ... the hon. Lady should well know that the specific issue of documentation versus digital was raised with the Minister for Security, who was clear that although there will be a letter to provide a document, it would have reference to the digital number. That issue was explored at length. She will also know that citizens do not lose any rights when they get pre-settled status, and that they then move on to settled status. Those issues were debated—that is what a Committee stage is for—and addressed by a Home Office Minister at that time.

Topical Questions: Exiting the European Union

Keir Starmer (Labour): ... Yesterday, the Government voted down the Opposition's amendment on unaccompanied child refugees. Our amendment would have preserved the victory that Lord Alf Dubs had campaigned for. I have always had a good personal relationship with the Secretary of State, but whatever he says about the wider issues, he must know that the Government have got this wrong. This could be his last Brexit oral questions; is he prepared to reconsider? I urge him to do so.

Reply from Steve Barclay: To understand the context, it is important to look at the commitment the Government gave to commencing negotiations on this issue, as reflected in the letter of 22 October from the Home Secretary to the European Commission. As was touched on in earlier questions, the Government have a strong record on this. They take 15% of unaccompanied child refugees; we are one of the top three EU countries in that regard. That commitment on granting asylum and supporting refugees remains; it is actually embedded in our manifesto, on page 23. In the European Union (Withdrawal Agreement) Bill, we return to the traditional approach, in which the Government undertake the negotiation and Parliament scrutinises that, rather than Parliament setting the terms, as happened in the last Parliament.

Keir Starmer: I am disappointed by the Secretary of State's reply. Labour will continue to fight to protect the most vulnerable. We may not win many votes in Parliament just now, but we can win the moral argument. I urge everyone who cares about the issue to put pressure on the Government, and urge Ministers to rethink this disgraceful decision. A legal obligation on the Government has been converted into reliance on the Prime Minister's word. Surely the Secretary of State can see why that gives rise to anxiety among Labour Members.

Reply from Steve Barclay: The shadow Brexit Secretary is right: there clearly has been anxiety among Labour Members, but I hope that he takes assurance from the explanation I gave that the commitment is unchanged. That is reflected in the letter of 22 October to the Commission from the Home Secretary, and in the manifesto.

The policy is unchanged. It is right that the Bill should, as is traditional, implement the international agreement; that is what it will do.

Bambos Charalambous (Labour): Will the Minister confirm whether EU citizens who work and pay taxes in the UK post Brexit will be liable for the immigration health surcharge? Does he envisage similar charges being introduced for UK citizens living and working in the EU? [900033]

Reply from Steve Barclay: I am happy to guarantee to all those EU citizens living in the UK ahead of our exit that the withdrawal agreement Bill guarantees their rights, among which are their rights to healthcare. That is why I urge the hon. Gentleman to support the Bill on Third Reading.

Damien Moore (Conservative): Will my right hon. Friend confirm that the UK will remain an open, dynamic and welcoming place for EU citizens to study in our world-class universities, and that Britain continues to lead the way with the internationally recognised quality of our higher education? [900030]

Reply from James Duddridge: ... The Government are clear that they wish to continue to attract students from the EU and the rest of the world to study here in the UK. The UK's higher education institutions have long-established traditions of attracting the brightest minds at all stages of their education and research careers, as we saw yesterday with the alumna of the London School of Economics. This being our last oral questions, I thank civil servants for their support. I particularly thank my private office and Cara Phillips. They have been wonderful.

Immigration: Wales

Ruth Jones (Labour) [346] To ask the Secretary of State for Wales, what assessment he has made of the potential effect of the policies set out in the immigration White Paper on Wales.

Reply from Simon Hart: This Government is committed to developing a new

system for immigration that is fit for purpose and based upon the skills of the individuals seeking to work in the UK, rather than the country that they are from. On 6 September 2019, the Home Secretary commissioned the Migration Advisory Committee to consider a new points-based immigration system for introduction from January 2021.

The Committee has also been commissioned to review the salary thresholds for the future immigration system and will continue with this work in addition to its work on the new points-based immigration system and report back to the Government by January 2020.

Lord Alton of Liverpool (Crossbench) [HL1] To ask Her Majesty's Government when they intend to remove the fee charged by the Home Office to register children as British citizens; and whether they intend to refund those who paid such fees before the High Court ruling on 19 December.

Lord Alton of Liverpool (Crossbench) [HL2] To ask Her Majesty's Government what assessment they have made of the ruling of the High Court on 19 December in the case brought by the Project for the Registration of Children as British Citizens that there is a "mass of evidence" that the fee charged to children registering for British citizenship prevents many such children from registering British citizenship, leaving them feeling "alienated, excluded, 'second-best', insecure and not fully assimilated into the culture and social fabric of the UK."

Reply from Baroness Williams of Trafford: The judgment was handed down on 19 December, and we are carefully considering its implications, and next steps.

Religious Hatred: Islam

Steve Baker (Conservative) [286] To ask the Secretary of State for Housing, Communities and Local Government, when he plans to establish a working definition of Islamophobia; and if he will make a statement.

Reply from Luke Hall: The Government agrees that there needs to be a formal definition of Islamophobia to give the issue a stronger focus. We have committed to appointing independent advisers to provide expert advice on a definition. The first of these advisers, Imam Qari Asim MBE, was appointed in July 2019. We are taking steps to appoint individuals with the right combination of skills and experience to drive the work. We endeavour to move at pace on these appointments; good progress is balanced by the necessity for careful consideration of due process.

Stephen Morgan (Labour) [200] To ask the Secretary of State for the Home Department, what steps her Department is taking to improve the ability of taxi drivers to record incidents of (a) hate crime and (b) racism against them.

Stephen Morgan (Labour) [201] To ask the Secretary of State for the Home Department, how many recorded incidents of (a) violence and (b) hate crime were recorded against taxi drivers in (a) 2010 and (b) 2018.

Stephen Morgan (Labour) [202] To ask the Secretary of State for the Home Department, what steps her Department is taking to reduce hate crime against taxi drivers.

Reply from Victoria Atkins: UK legislation does not prohibit the installation and use of systems capable of recording visual and audio data in taxis and Private Hire Vehicles (PHVs). It is for individual taxi and PHV licensing authorities to consider whether such systems should be prohibited, permitted or mandated in their fleet. The Government has asked the Law Commission to undertake a full review of the coverage and approach of current hate crime legislation. That review is in progress. The Law Commission will publish a Consultation Paper in early 2020, and we expect their Final Report in early 2021.

The Government is clear that all forms of hate crime are unacceptable, and we have robust legislation to tackle these crimes. The Government's Hate Crime Action Plan includes a commitment by the Department for Transport to ensure that taxi and private hire vehicle drivers identify and report hate crime in the night-time economy and includes relevant advice in the Department's best practice guidance on Taxi and Private Hire Vehicle licensing.

The Home Office does not hold information on the occupation of victims of violence or hate crime.

Sports: Racial Discrimination

Lord Bourne of Aberystwyth (Conservative) [HL14] To ask Her Majesty's Government what action they are taking to promote anti-racism in sport.

Reply from Baroness Barran: The Government is clear that racism has no place in sport or society at large, in line with the sport and physical activity strategy 'Sporting Future: A New Strategy for an Active Nation', which has diversity and inclusion at its heart. Government remains supportive of a number of anti-racism initiatives that work with sports bodies from grassroots to the elite, including Show Racism the Red Card and Kick it Out. With Kick It Out stats demonstrating that racism constitutes 65 per cent of reports made via them in the 18/19 season, government will continue to call governing bodies to account for actions in this space. Over the past year the Government has led debates in the House of Commons on tackling racism in sport (on 22nd May 2019 and 12th July 2019), and hosted an Anti-Racism Summit in February 2019. This led to clear commitments to tackle racism in football stadia from the three main English football organisations in July 2019. Ministers and officials continue to speak to the FA and relevant football bodies to explore what more can be done. Grassroots sport clubs also receive support in tackling racism from our national sport council, Sport England, who provide free support and learning in running a club through its "Club Matters" programme.

Hate Crime: Public Transport

Lord Bourne of Aberystwyth (Conservative) [HL16] To ask Her Majesty's Government what action they are taking to tackle hate crime on public transport.

Reply from Baroness Williams of Trafford: The Government is clear that all forms of hate crime are unacceptable. The Government's Hate Crime Action Plan 2016, and the refresh in 2018, contains a number of commitments to tackle hate crime on public transport. These include:

- The Department for Transport committing, in the July 2018 Inclusive Transport Strategy, to run a public awareness raising campaign to increase disability awareness amongst all transport passengers; and
- Working with local transport providers to ensure that bus drivers across England and Wales are fully equipped to challenge hate, including new guidance to support them.
- The 2018 Hate Crime Action Plan refresh also includes a number of broader

actions addressing all forms of hate crime, including hate crime on public transport. These include:

- A review by the Law Commission into the coverage and approach of current hate crime legislation; and
- A wide-ranging national hate crime communications campaign to publicly address hate crime and make clear that it is unacceptable to target people on the basis of their identity.

More widely, the British Transport Police (BTP) provides a policing service that meets the needs of all passengers and people who use or work on the railways. BTP has a firm commitment to responding to all reports of hate crime and it actively works with train operating companies and Network Rail to improve awareness, vigilance and reporting of information on hate crime incidents.

S5M-20304 Anas Sarwar (Labour): Recognising the Life and Achievements of Bashir Maan CBE: That the Parliament marks the sad passing of Bashir Maan CBE and recognises his immense contribution to public life in Scotland; notes that Bashir arrived in Glasgow in 1953 aged 26 as a student and worked as a door-to-door salesman; recognises his many achievements, including in 1968 being appointed the first Asian and Muslim Justice of the Peace in Scotland, in 1970 making history by being the first Muslim Councillor publicly elected in the UK, serving the Labour Party in the Kingston ward in Glasgow, in 1971 becoming the first Muslim magistrate, in 1977 being appointed Deputy Chairman of the Commission for Racial Equality by the Home Secretary for three years, and in 1983 becoming the first South Asian to be appointed Deputy Lieutenant of Glasgow by the Lord Provost, Michael Kelly; notes that in 2000, in recognition of his extensive work in the community, race relations and the voluntary sector, Bashir was awarded a CBE; acknowledges that in 2003 he retired from politics after a career that spanned 33 years and completion of a four-year term as Convenor of the Strathclyde Joint Police Board; recognises that in June 1999 he received an honorary doctorate from the University of Strathclyde, and that in total he was awarded three honorary doctorates and two fellowships by Scottish universities; acknowledges that Bashir published a number of books, including *The New Scots: The Story of Asians in Scotland* in 1992, which chronicles the history of the Asian diaspora in Scotland, as well as *The Thistle and the Crescent: a study of Scottish-Islam relations* in 2008, and *Muslims in Scotland* in 2015, which chronicle Scottish Muslim life; recognises that, in 1997, he was a founding member of the Muslim Council in Britain, and that between 2007 and 2009 he was Convener of the Muslim Council of Scotland, and believes that Bashir Maan was a pioneering and inspiring role model and a true trailblazer who broke barriers several times, achieving many firsts, and made history paving the way and opening the civic door for a whole generation of South Asian Scots.

The Government shares the concern that some people may nonetheless marry in a way that does not, and without appreciating the consequences.

The independent Sharia review has recommended an offence apply to religious celebrants marrying in a ceremony that is outside the ambit of the Marriage Acts.. Any legislative proposal, including such an offence, must be thoroughly assessed for its fairness to all religious groups and for how far it could achieve the change of practice intended. That is why it is with the greatest care that the Government is continuing the exploration of both limited reform and non-legislative options that it began in detail in the spring.

Separately from this exploration, the Law Commission has begun its weddings project. It will make recommendations for how the wider law on getting married in England and Wales can be systematically reformed in a way that is simple, fair and consistent.
