## Immigration and Asylum

### UK Parliament, Ministerial Statement

#### Immigration Rules: Simplification

**The Parliamentary Under-Secretary of State for the Home Department (Kevin Foster):** [HCWS186] This Government are committed to creating a firm and fair immigration system that prioritises the skills people have to offer, not where their passport comes from, and restores public trust by ensuring the immigration system truly works for this country.

The immigration rules form one of the foundations of our immigration system. So I am pleased today to publish our response to the Law Commission's report and recommendations on simplifying the immigration rules. I am extremely grateful to the Law

Commission for their detailed and constructive work.

The first recommendation from the Law Commission is we should overhaul the immigration rules, consolidating and streamlining, based on the principles it has identified. I am pleased to announce we accept this recommendation. Our aim is to complete this overhaul by January 2021.

Simplified rules will be at the heart of Britain's new, global points-based immigration system.

For far too long, users have struggled to understand the confusing and complex immigration rules. They create barriers for employers who want to bring skilled workers to the UK; to colleges who want to encourage international students to come to the UK, and to the brightest and best migrants from around the world who want to make a contribution to the UK.

We will cut through the complexity and make the rules clear, consistent and accessible, to encourage those who have the skills or talent to benefit the UK, and to crack down on illegal migration and remove those who abuse our hospitality by committing criminal offences.

In line with the Law Commission's recommendations, I have already established a Simplification of the rules review committee to look at the drafting and structure of the rules. The committee will ensure the simplification principles put in place now continue to apply in future, while providing ongoing support to continuously improve and adapt the rules in our changing world.

The Law Commission made 41 recommendations for change. We accept 24 of the recommendations, and partially accept the other 17 recommendations. Where we have not fully accepted a recommendation that does not mean we disagree with the ambition behind the recommendations; it generally means we want to explore how it can be delivered in practice.

Simplification of the immigration rules, the global points-based immigration system, and the Immigration and Social Security Co-ordination (EU Withdrawal) Bill which will end free movement, will deliver the biggest shake-up of the immigration system in a generation.

## UK Parliament, House of Commons Oral Answers

### Settled Status for EU Citizens: Internet Access

**Neale Hanvey (Independent):** What support her Department is making available to EU citizens who are unable to use the internet to apply for settled status to continue living in the UK. [901681]

**Reply from the Parliamentary Under-Secretary of State for the Home Department (Kevin Foster):** We are committed to giving all EU citizens living in the UK the certainty they need. Last week, I announced that 3 million people have been granted status under the European settlement scheme. We have made available a further £8 million of funding to help vulnerable EU citizens apply. For those who are unable to access the support mechanisms in place, including assisted digital, a paper application form will be made available.

**Neale Hanvey:** I have met a number of constituents and organisations who are providing

vital support to vulnerable people applying for EU settled status. Some of the stories they have shared about the difficulties faced by those challenged by an internet-based system, such as people with dementia, are harrowing. While the news that funding to support those groups has been extended until this June is welcome, with a bidding process until June 2021, many vulnerable people are currently only able to secure pre-settled status. They will be required to apply again for settled status within five years. Where should those individuals turn when the funding to support them is cut off?

**Reply from Kevin Foster:** As the hon. Gentleman reflected, we are making funding available, and the current grant-funded organisations will continue until the new funding comes in, one of which is Fife Migrants Forum in his constituency. As with any Member, I invite him, once the current situation is over, to visit the team in Liverpool who are dealing with the European settlement scheme to see at first hand the lengths to which they go to ensure that everyone gets the status they are entitled to.

**Diane Abbott (Labour):** ... On the settlement scheme, we obviously welcome the fact that 3 million persons have been successfully processed, but Ministers will be aware that the number of rejections is on a rising curve, with 300 last month. That is increasingly because of problems with documentation. Last week, the House debated the Windrush lessons-learned review and one of the problems at that time was documentation. Is it not time that the Government ended the uncertainty hanging over the heads of EU citizens and guaranteed the rights of EU citizens in the UK?

**Reply from Kevin Foster:** A very small number has been rejected—just 300 out of over 3 million applications—and the core reason for rejection, for saying no to someone, is criminality. Where there are eligibility issues, people can make a free re-application but the evidence levels are quite basic. People must prove their identity; they must prove that they have residence in the UK, particularly for pre-settled status; and they are subject to the eligibility and suitability checks around criminality. Actually, the system is working very well, and again, I extend an invitation to the right hon. Lady to come to meet the team and see at first hand the work that they are doing and why this has been such a success. It is the biggest documentation of immigration status in history and it is going well.

### **Covid-19: English Language Testing**

**Caroline Ansell (Conservative):** What plans she has to review the English language testing requirement for student visas as a result of the closure of overseas language test centres in response to the covid-19 outbreak. [901683]

**Reply from the Parliamentary Under-Secretary of State for the Home Department (Kevin Foster):** These are extraordinary times, and we are working hard to ensure that no foreign students are penalised unfairly by these events. We recognise the concerns of the education sector about the impact of covid-19, and we are working with it to mitigate the adverse consequences. We are also working closely with secure English language test providers to ensure that there is sufficient capacity for all those who need to take tests while prioritising the health and safety of staff and applicants.

**Caroline Ansell:** I thank the Minister for his answer. Clearly my question was tabled before we hit the mission-critical phase in our actions to combat the virus, and of course it feels rather discordant to talk today about international travel when we are talking self-isolation and social distancing. But below that there is another really important message—that we

will come through this, we will rally and we will rebuild. So can the Minister say what measures are being taken to expedite the process for international students coming to our universities in particular, because it is so vital in towns such as Eastbourne and across the country?

**Reply from Kevin Foster:** I recognise the comments my hon. Friend makes, and as she says, at the moment it seems strange to be talking about international travel when we are rightly advising against all non-essential travel within the United Kingdom, let alone abroad. We are very clear that no one will have a negative outcome through the immigration system due to a circumstance that was beyond their control. We have already done a block extension of visas for Chinese nationals, and we are looking at further measures that we can take—for example, allowing in-country switching that we would not normally allow—to ensure that no one is penalised because they followed the advice and did what they could to protect our NHS and save lives.

**Reply from Priti Patel:** Let me give the hon. Gentleman, his constituents and all public health workers in that category reassurance. Some very fast work is taking place at the Home Office right now to look at exactly that issue. I would be very happy to write to the hon. Gentleman outlining that work.

**Reply from Kevin Foster:** The new points-based system will be introduced from 1 January 2021.

The operation of the system will be kept under review and, as the policy statement published on 19 February makes clear, the Home Office will continue to refine it in light of experience and will consider adding further flexibility into the system including additional attributes which can be 'traded' against a lower salary.

### **Immigrants: Coronavirus**

**Tim Farron (Liberal Democrat)** [32103] To ask the Secretary of State for the Home Department, what steps she plans to take to protect migrants unable to attend (a) reporting appointments, (b) court dates and (c) interviews self-isolating during the covid-19 outbreak from being penalised.

**Reply from Chris Philp:** Following the Prime Minister's announcement on 16 March, and Public Health England (PHE) advice in relation to COVID-19, Home Office Immigration Enforcement are reviewing the frequency with which people need to report. While this goes ahead, we have temporarily deferred reporting.

We will continue to contact all those who report via SMS text message with details of their future reporting dates and will keep this under review in light of the ongoing situation.

**Reply from Kevin Foster:** We are taking a pragmatic approach to visa extensions due to the coronavirus outbreak.

We continue to monitor the situation closely in all countries and are keeping this under constant review. Individuals who are following official advice will not be penalised as a result of issues arising from the covid-19 pandemic which are beyond their control.

### **Visas: Foreign Nationals**

**Diana Johnson (Labour)** [31456] To ask the Secretary of State for the Home Department, pursuant to the Answer of 17 March 2020 to Question 28642 on Foreign Nationals, what plans she has to make provision under paragraph 39E (1) of the Immigration Rules that a good reason for extension of leave will include self-isolation as a result of covid-19.

**Reply from Kevin Foster:** Paragraph 39E (1) of the Immigration Rules already provides for a limited period of overstaying to be disregarded where an application is made within 14 days of the applicant's previous leave expiring, if it is considered that there was a good reason beyond the control of the applicant or their representative, provided in or with the application, why the application could not be made in-time.

The Home Office has also put in place a range of measures to support those affected by travel restrictions associated with coronavirus, including taking a pragmatic approach to visa extensions. We continue to monitor the situation in all countries, and we are keeping this under constant review.

### **Migrant Workers: Physiotherapy**

**Baroness Masham of Ilton (Crossbench)** [HL2445] To ask Her Majesty's Government what steps they are taking to ensure that the points-based immigration system enables registered physiotherapists to be eligible for an NHS visa.

**Reply from Baroness Williams of Trafford:** Physiotherapists are already eligible to come to the UK under Tier 2, the UK's main route for skilled migrants. These roles will continue to be eligible under the UK's Points-Based Immigration System. The Government has also accepted the Migration Advisory Committee's recommendation in their report on "A Points-based System and Salary Thresholds for Immigration" on occupations which should be subject to formal pay scales. This means physiotherapists will need to be paid in line the 'Agenda for Change' pay scales.

The Government's manifesto set out plans for improving the visa system for doctors, nurses and allied health professionals, including physiotherapists. Further details will be published in due course.

As the national situation develops, Asylum Operations will take the measures necessary to support appointments, interviewing and decision making including the use of technology, whilst always protecting the needs of the most vulnerable.

### **Asylum: France**

**Philip Davies (Conservative)** [29919] To ask the Secretary of State for the Home Department, how many asylum seekers who have arrived in the UK from France have been returned to France in each of the last five years for which figures are available.

**Reply from Chris Philp:** The UK has a proud history of providing protection to those who need it, in accordance with our international obligations under the Refugee Convention and European Convention on Human Rights (ECHR).

Those found not to need protection are refused and if unsuccessful at a subsequent appeal will be removed from the UK and it is an established principle that those seeking asylum should claim it in the first safe country they reach.

The Home Office publishes data on the number of returns from the UK and Dublin regulation in the 'Immigration Statistics Quarterly Release'.

### **Immigrants: Detainees**

**Bell Ribeiro-Addy (Labour)** [31559] To ask the Secretary of State for the Home Department, whether she has plans to release immigration detainees to reduce the rate of infection of covid-19 in response to the decision to extend early release for some prisoners.

**Reply from Chris Philp:** The health of those in immigration removal centres is of the utmost importance but we remain committed to removing foreign national offenders or those who violate our immigration rules. Detention plays a key role in securing our borders and maintaining effective immigration control.

Decisions to detain an individual are based on all of the information known at the time. As circumstances change, temporary release may then become the most appropriate option.

We are following all Public Health England guidance and have robust contingency plans in place. Measures such as protective isolation will be considered to minimise the risk of Covid-19 spreading to vulnerable groups in the immigration detention estate.

Basic hygiene is a key part of tackling Coronavirus. Handwashing facilities are available in all immigration removal centres and we are working closely with suppliers to ensure adequate supply of soap and cleaning materials.

All immigration removal centres have dedicated health facilities run by doctors and nurses which are managed by the NHS or appropriate providers.

## **UK Parliament, House of Lords Written Answers**

### **Visas**

**Lord Bowness (Conservative)** [HL2422] To ask Her Majesty's Government whether they intend to seek equality of treatment after 31 December for EU citizens visiting the UK who will be entitled to a six month visa and UK citizens visiting the EU who could be restricted to a 90 day visa, if an agreement is not reached.

**Reply from Baroness Williams of Trafford:** The Government has announced that EU, EEA and Swiss nationals will be able to continue to travel to the UK for holidays or short-term trips without needing a visa from the end of the transition period following the UK's departure from the EU.

From 1 January 2021, EU nationals intending to come to the UK on a long-term basis to live, work or study will need to do so under the Future Points-Based System. This is without prejudice to those who acquire status through the EU Settlement Scheme.

The EU has also legislated not to impose visas on UK tourists or short-term visitors.

In line with the Schengen Border Code, UK nationals who intend to stay in the Schengen area for longer than 90 days in any 180-day period may need a visa or permit from the relevant Member State to do so.

These arrangements are not dependent on whether or not the Government concludes a Comprehensive Free Trade Agreement with the EU.

**Lord Hylton (Crossbench)** [HL2580] To ask Her Majesty's Government how many offers to receive vulnerable unaccompanied children who are currently in Europe have been

received in (1) 2019, and (2) 2020, by the Home Office from (a) local authorities, (b) care and fostering agencies, and (c) private individuals.

**Reply from Baroness Williams of Trafford:** The Home Office works closely with local authorities and third sector partners in order to identify suitable placements for unaccompanied children for transfer to the UK from Europe under our existing obligations.

The Government remains fully committed to relocating the specified number of 480 unaccompanied children to the UK under section 67 of the Immigration Act 2016 (the Dubs Amendment) as soon as possible. We will publish a full data set on the transfers once we have fulfilled this commitment.

Over 220 children were transferred to the UK under section 67 when the Calais camp was cleared in late 2016. Since then we have been making further progress with Greece and the other participating states, to transfer more eligible children to move closer to achieving this commitment

## Racism, Religious Hatred, and Discrimination

### UK Parliament, House of Lords Written Answer

#### Universities: Antisemitism

**Baroness Deech (Crossbench)** [HL2491] To ask Her Majesty's Government what assessment they have made of whether universities in England and Wales (1) have breached the public sector equality duty, and (2) are compliant with the International Holocaust Remembrance Alliance's working definition of antisemitism, by permitting Israeli Apartheid Week activities to take place on their campuses.

**Reply from Baroness Berridge:** There is no place in our society - including within higher education (HE) – for hatred or any form of harassment, discrimination or racism, including antisemitism. The government will continue to work with universities to ensure we stamp out antisemitism in all its forms.

The government expects HE providers to take their responsibilities, including those under the Equality Act 2010 (including the Public Sector Equality Duty) and to promote freedom of speech, seriously. We expect HE providers to have robust policies and procedures in place to meet, and balance, their legal obligations effectively and to investigate and swiftly address reports of hate crime, including any antisemitic incidents that are reported.

We expect HE providers to have clearly set out procedures and policies for events and the hosting of external speakers, which allow for open, transparent events, challenge and debate and ensure that lawful speech can occur on campuses. Under the Education (No. 2) Act 1986, HE providers have a legal duty to take reasonably practicable steps to ensure that freedom of speech within the law is secured for their members, students, employees of the establishment and visiting speakers.

In relation to events occurring under the banner of Israeli Apartheid Week, it is crucial that HE providers handle these appropriately, taking into account their legal obligations to ensure that our values, expectations and laws are upheld.

The government strongly encourages HE providers to adopt the IHRA definition of antisemitism. It is an important tool in tackling antisemitism and a strong signal that HE providers take these issues seriously.

### UK Parliament, House of Lords Oral Answers

#### **BAME Students: Pupil Referral Units**

**Baroness Lawrence of Clarendon (Labour):** To ask Her Majesty's Government what assessment they have made of the experience of BAME students referred to Pupil Referral Units; and what steps they are taking to ensure that any such students are able to re-enter mainstream education.

**Reply from the Parliamentary Under-Secretary of State, Department for Education and Department for International Trade (Baroness Berridge):** My Lords, 27% of pupils in PRUs, alternative provision academies and AP free schools are BAME, compared with 32% in all schools. There is variation among different groups, however, and it is important that we seek to understand those differences. We are committed to improving outcomes for all pupils in alternative provision and will build on the good practice identified by our £4 million AP innovation fund. Three of the projects focus specifically on reintegration into mainstream education.

**Baroness Lawrence of Clarendon:** I thank the Minister for her Answer. In the last few months, the *Evening Standard* has been running a campaign to raise funds for young people who have been excluded from school, so that the school can keep them and educate them within its premises instead of sending them off into PRU units. As we all know, young people are very vulnerable and are exposed to gangs once excluded from school. We know that the trap exists for young people who are not in mainstream schools. Do the Government have any policies for reducing the numbers of pupils in PRUs and getting them back into mainstream schools? As we all know, the majority are young black boys. Also, with the partial closure of schools that we have now, are there any thoughts on excluded children?

**Reply from Baroness Berridge:** I am grateful to the noble Baroness for raising a number of issues there. If I may begin with the current policy, yes, AP is included within the request to schools, so that, if at all possible, head teachers should keep that provision open. We believe that about half of the pupils within AP will qualify under the definition of "vulnerable" but we trust that the head teachers will make the correct decisions on the ground. It is of course correct that education is one of the strongest protective factors for young people, and it is this Government's ambition that there should be an expansion of alternative provision and that being excluded from mainstream education settings should not be an exclusion from excellent

education. We have the same aspirations for those in the AP sector as we do in other educational settings.

**Lord Woolley of Woodford (Crossbench):** My Lords, Diane Abbott said many years ago that once you have excluded a black child from school you can almost put a time and date on when they will turn up in prison. That is still true today. According to the excellent coalition of BME education practitioners, there should be no more exclusions. School exclusions cost the taxpayer an eye-watering £2.1 billion a year. Many children go to pupil referral units, but only 1% of them go on to achieve good GCSEs. However, two-thirds of pupils in PRUs will at some point go to prison. Clearly PRUs are not fit for purpose. Does the Minister agree that we should stop all school exclusions, as some places do, such as Northampton? I witnessed that when I was a children's commissioner. Given that BME and other disadvantaged children are more likely to be excluded, I say, as I did last week, that we must recruit more black teachers and teachers from other disadvantaged backgrounds, including Roma, Gypsy, Traveller and white working-class. I apologise for going on.

**Reply from Baroness Berridge:** The noble Lord makes an important point. We are aware that educational outcomes for students in alternative provision are not high enough, but last year 85% of all state-funded schools did not permanently exclude any pupil. The Government support head teachers having the power, as a last resort, to exclude pupils, but that should not be a ticket into education that is less than excellent. In fact, 83% of alternative providers were judged by Ofsted to be good or outstanding. That is only slightly less than overall for schools, which is 86%, and more than for secondary schools. Although there are issues, I pay tribute to the workforce in the alternative provision sector who are doing an excellent job dealing with behavioural and educational issues. ...

**Lord Addington (Liberal Democrat):** My Lords, does the Minister accept that certain hidden or non-obvious conditions, such as dyslexia, tend to be even slower to be picked up among the BME community than in others, usually due to things such as it being more commonly working-class, and that many of these conditions are seen to be white, middle-class problems which are identified by the parents and then fought through the education system? When are we going to get better provision in schools to sort this? Having more working-class and black teachers would help.

**Reply from Baroness Berridge:** I am grateful to the noble Lord. On the recruitment of teachers, a £2 million project with the diversity hubs is aimed specifically at increasing the diversity of the workforce, which is an important factor. On non-diagnosis, for every child who is not meeting the requisite attainment standards, graduated action on their attainment gap should be taken by teachers and SEN co-ordinators, regardless of a diagnosis. We are aware that 81% of the children in alternative provision also have special educational needs and disabilities, so we need to intervene earlier. That will be part of the SEN review, to avoid this correlation. ...

**Baroness Uddin (Non-affiliated):** My Lords, in the other half of the statistic mentioned by my noble friend Lord Woolley and the noble Baroness, Lady Lawrence, lie numbers of Muslim young boys, in particular, as well as those who are autistic. That statistic makes them vulnerable students and pupils. Some of them may be vulnerable to county lines, about which we heard last week, and sexual exploitation, about which we have heard many times. Given the crisis that we face, what will the Minister do to ensure that local authorities take seriously the gaps that may begin to emerge, with these young people falling through the system because they are not classified as vulnerable children?

**Reply from Baroness Berridge:** My Lords, any child who is not in an educational setting should be. We do take action. We recognise that they are particularly vulnerable to the phenomenon now called "county lines". The Government have provided £20 million to fund more national co-ordination on county lines. Since September 2018, four weeks of criminal justice interventions have led to 2,500

arrests; more importantly, they have resulted in more than 3,000 people being identified as having safeguarding concerns. We are doing what we can and taking action to deal with these issues.

## **Scottish Parliament Oral Answer**

### **Covid-19 (Justice)**

**Anas Sarwar (Labour):** ... Will the Scottish Government provide guidance to funeral operators, and particularly community-organised funeral operators? Muslim and Jewish burials are done with a ritual of washing of the body before the burial takes place. Will there be guidance on what should happen with Covid-19 patients in those circumstances? If that is to be done by those community organisations, will the Government help them to acquire PPE so that they can keep themselves safe at this really difficult time? ...

**Reply from Humza Yousaf:** I am happy to answer the question. It perhaps does not fall within the remit of the justice secretary, but I work closely with my colleagues in public health, and Joe FitzPatrick in particular. In addition, Anas Sarwar will understand, as I do, that on matters relating to the Muslim community, he and I will often be approached regardless of what our official remits are or are not.

To answer the question directly, I note that guidance has been provided to Glasgow central mosque, which does the vast majority of such funerals in the west of Scotland, but I have been told that it has also been passed to the Muslim Council of Scotland, which will disseminate it across mosques. In relation to the Jewish community, I will have to look that up, but I will ensure that advice is sent to all communities on the specific rituals that they have in dealing with the deceased.
