UK Parliament, House of Commons Written Answers

Visas: Married People

Claire Hanna (SDLP) [33614] To ask the Secretary of State for the Home Department, if she will reduce the minimum income requirement of £18,600 per year to sponsor a spouse's visa during the covid-19 outbreak.

Reply from Kevin Foster: The Home Office has put in place a range of measures to support those affected by the covid-19 outbreak.

We continue to monitor the situation closely and may make adjustments to requirements where necessary and appropriate.

Visas: China

Alan Brown (SNP) [34370] To ask the Secretary of State for the Home Department, if she will further extend the relaxation of visa requirements for Chinese nationals in the UK beyond 31 March 2020.

Reply from Kevin Foster: Visa nationals whose leave expired after the 24 January and who cannot leave the country because of travel restrictions or self-isolation due to the COVID-19 pandemic will be able to extend their visa.

A dedicated COVID-19 immigration team has been set up within UKVI to make the process as straightforward as possible. Anyone in this situation just needs to contact this team, via the following email address, CIH@homeoffice.gov.uk, to let them know their visa has expired and they will be issued with an extension.

This will last until 31 May, but will be kept under regular review in case further extensions are needed.

Immigrants: Coronavirus

Claire Hanna (SDLP) [32747] To ask the Secretary of State for the Home Department, whether the Government plans to provide a support package for migrants in the UK without access to public funds during the covid-19 outbreak.

Reply from Chris Philp: The Home Office has put in place a range of measures to support those affected by the covid-19 outbreak. We are continually reviewing the situation to consider what more can be done.

Individuals who have leave to remain on human rights grounds can already apply to have their no recourse to public funds condition lifted if they would otherwise be destitute. We are working to ensure that those who are eligible to have the condition lifted can have a decision taken as swiftly as possible.

Local authorities may also provide basic safety net support if it is established that there is a genuine care need that does not arise solely from destitution, for example, where there are community care needs, migrants with serious health problems or family cases.

Covid-19 has been added to the list of communicable diseases so anyone experiencing symptoms regardless of their immigration status will be treated for free.

A dedicated covid-19 immigration help-centre has been set up to deal with queries.

Immigration: EU Nationals

Daniel Zeichner (Labour) [32240] To ask the Secretary of State for the Home Department, if she will make an assessment of the potential merits of extending the deadline for applications to the EU Settlement Scheme beyond 30 June 2021 as a result of the covid-19 outbreak.

Reply from Kevin Foster: There are still nearly 15 months before the deadline of 30 June 2021 for applications to the EU Settlement Scheme. The published statistics, to 29 February 2020, show the scheme is performing well, with more than 3.3 million applications having been received and applications continuing to be received and processed.

EU citizens can apply online, free of charge, simply by completing three key steps: proving their identity, showing they live in the UK and declaring any criminal convictions. There is support available online and by email.

Where a person eligible for leave under the scheme has reasonable grounds for

missing the application deadline, they will be given a further opportunity to apply. Our compassionate and flexible approach will ensure individuals who miss the deadline through no fault of their own can still obtain lawful status in the UK. We will publish clear guidance for caseworkers in due course to ensure consistency of approach.

Asylum: Information

Jim Shannon (DUP) [33517] To ask the Secretary of State for the Home Department, what steps she is taking to improve the accuracy of (a) information gathered during interviews with asylum applicants and (b) asylum decisions.

Reply from Chris Philp: Asylum operations is working to improve the quality and accuracy of decision-making to ensure that we get decisions right first time. This includes assuring that we properly consider all evidence provided by applicants in order to reduce the proportion of allowed appeals, analysing the reasons for allowed appeals and using this to inform and further improve guidance and training for decision making staff.

All decision makers receive extensive training on how to interview asylum seekers in a sensitive way and consider the claim for sustainable decisions to be reached. We ensure that claimants are given every opportunity to disclose information relevant to their claim before a decision is taken, even where that information may be sensitive or difficult to disclose.

UKVI has an internal audit process which assesses the quality of decisions, interviews and the application of Home Office policy. We have Senior Case Worker assessments as well as independent auditors from the Central Operations Assurance Team who audit asylum cases and provide quarterly reports.

It is Home Office policy to digitally record asylum interviews unless the exemptions policy applies, a copy of the interview record is given to the applicant and legal representative if present.

Asylum

Jim Shannon (DUP) [33522] To ask the Secretary of State for the Home Department, what steps the Government is taking to monitor the quality of experience of people seeking asylum in the UK.

Reply from Chris Philp: The Home Office issues an information leaflet to asylum claimants at the point of claim which outlines the asylum process and the claimant's responsibilities within that process. This information leaflet is periodically reviewed. Independent guidance and advice are also available to asylum claimants provided by Migrant Help. Migrant Help are present in initial accommodation where destitute asylum seekers are initially housed and their services can also be accessed via their website or by phone. Their website is available in multiple languages, and the helpline is free and accessible in multiple languages.

UKVI work closely with our key partners and stakeholders to seek and share

feedback to identify ways in which we can improve the quality of experience of people seeking asylum in the UK. We have recently set up a Customer Experience Management Team, based across the UK, who will work closely on a local level with stakeholders, to identify key areas to improve the overall experience for people seeking asylum in the UK.

Asylum: Employment

Jim Shannon (DUP) [33521] To ask the Secretary of State for the Home Department, if she will make it her policy to grant asylum applicants (a) the right to work after six months waiting for a decision on their application and (b) access to English language classes from application.

Reply from Chris Philp: Asylum seekers can work in the UK if their claim has been outstanding for 12 months, through no fault of their own. Those allowed to work are restricted to jobs on the Shortage Occupation List, which is published by the Home Office and based on expert advice from the Migration Advisory Committee.

It is important to distinguish between those who need protection and economic migrants, who can apply for a work visa under the Immigration Rules. Our wider immigration policy would be undermined if migrants could bypass work visa routes by lodging unfounded asylum claims.

Asylum seeker right to work is a complex issue and is under review. It is crucial we take the time to get this right. We are listening carefully to the arguments and considering the evidence put forward on the issue. Work on the review is ongoing. After six months we provide a 50% contribution to the costs of English language classes for asylum seekers in certain circumstances. Those granted refugee status are entitled to access fully funded English language tuition if they are unemployed and in receipt of certain benefits.

Currently around half of those who seek asylum in the UK are found not to need international protection. Therefore, rather than invest in integration for those who may not qualify for international protection, this Government's priority is to focus our efforts and resources to support those who most need it.

Immigrants: Health Services

The Lord Bishop of Durham [HL2738] To ask Her Majesty's Government what consideration they have given to exempting NHS workers from the immigration health surcharge.

Baroness Williams of Trafford: The Government fully recognises the role overseas Doctor's Nurses and Allied Health Professional play in our NHS, hence we are working to introduce an NHS visa for qualified health professionals who will be offered fast track entry, reduced visa fees and dedicated support to come to the UK with their families.

Yet it is right all who come to work in the UK contribute towards the cost of providing the NHS services they will have access to from their arrival as do providers of other essential public services such as teachers and care-workers. Those who show a long-term commitment to our country become exempt from the immigration health surcharge when they secure Indefinite Leave to Remain.

Immigrants: Coronavirus

Baroness Lister of Burtersett (Labour) [HL2809] To ask Her Majesty's Government what steps they are taking to ensure that residents without recourse to public funds will have financial protection during the COVID-19 pandemic.

Reply from Lord Agnew of Oulton: The government has introduced a range of measures to provide financial protection for those affected by Covid-19, including those with no recourse to public funds (NRPF).

Employers will be able to apply for grants under the Coronavirus Job Retention Scheme for workers on the PAYE system. The government has also extended Statutory Sick Pay to be payable from Day 1 rather than Day 4 and made Contributory Employment and Support Allowance available from the first day of sickness rather than the eighth, subject to other eligibility criteria. For those who file Self-Assessment returns, the government has deferred Income Tax Self-Assessment payments from July 2020 to January 2021.

In addition, the government has announced that banks and building societies will offer a three-month 'mortgage holiday' for borrowers in financial difficulty, including landlords with tenants in financial difficulty, as a result of Covid-19. Alongside this, the government has legislated to prohibit tenant evictions for three months.

Migrant Workers: Ministers of Religion

The Lord Bishop of Durham [HL2680] To ask Her Majesty's Government whether there will be any change to the existing requirements for a Temporary Worker-Religious Worker visa (Tier 5) under the new points-based immigration system.

Reply from Baroness Williams of Trafford: Under the current Immigration Rules, there are a range of routes for specialist activities, including temporary religious workers. From January 2021, these routes will be opened to EEA and Swiss citizens.

Detention Centres: Coronavirus

The Lord Bishop of London [HL2780] To ask Her Majesty's Government what steps they are taking to provide healthcare and support services to people in immigration removal centres during the COVID-19 pandemic.

Reply from Baroness Williams of Trafford: The Home Office continues to follow national guidance issued by Public Health England (PHE), Health Protection Scotland and the National Health Service. In addition, all immigration removal centres have communicable disease contingency plans, based on PHE advice. Measures such as protective isolation and use of personal protective equipment (PPE) are being used to minimise the risk of COVID-19 spreading to vulnerable groups in immigration removal centres.

Basic hygiene is a key part of tackling COVID-19. Handwashing facilities are available in all immigration removal centres and we are working closely with suppliers to ensure adequate supply of soap and cleaning materials.

All immigration removal centres have dedicated health facilities run by doctors and nurses which are managed by the NHS or appropriate providers.

Public Appointments: Ethnic Groups

Lord Boateng (Labour) [HL2485] To ask Her Majesty's Government how many publicly appointed members of public bodies regulating (1) social work, and (2) education, identify as BAME; and what is the recorded ethnicity of each of those members, disaggregated by public body.

Reply from Baroness Berridge: The Department for Education has 136 publicly appointed members of public bodies, 17 of whom identify as Black, Asian or Minority Ethnic (BAME). Social Work England has seven public appointees. Due to the low number of appointees, and the risk of potential identification of individuals within this group, we are not able to confirm the number of declared BAME appointees within Social Work England. Ethnicity is based on voluntary declaration. In order to protect personal information, the Department is unable to provide this data disaggregated by public body as, within each body, the number relates to fewer than 10 individuals.

Travelling People: Coronavirus

Lord Bourne of Aberystwyth (Conservative) [HL2922] To ask Her Majesty's Government what steps they are taking to ensure that there is protection from eviction for Gypsy, Roma and Traveller communities during the COVID-19 pandemic.

Reply from Baroness Bloomfield of Hinton Waldrist: The Government takes the welfare of all citizens seriously and we are working hard to ensure those most at risk are identified and supported including those in GRT communities who will be receiving support alongside others.

The Government is also holding regular discussions with community representatives to understand issues faced and are looking into what guidance and support is required for Local authorities, who have a responsibility to look after vulnerable groups.

We are sending a clear message to landlords that they should do everything possible to avoid evictions – particularly where households are facing hardship as a result of coronavirus. Where a person's main home is on a camp site or caravan park, those sites can stay open.

We are urgently introducing emergency legislation to protect tenants in social and private accommodation from an eviction process being started and are considering what further action may be appropriate. In the meantime, we are urging the landlords of those on licences to follow the same guidance to work with renters who may be facing hardship as a result of Covid-19.

Hate Crime: Facebook

Rupa Huq (Labour) [33632] To ask the Secretary of State for the Home Department, what assessment her Department has made of the adequacy of Facebook's complaints process for reporting hate crimes.

Reply from James Brokenshire: As outlined in the Online Harms White Paper, we intend to establish in law a new 'duty of care' on companies towards their users. The 'duty of care' will ensure companies have appropriate systems and processes in place to deal with harmful content, which includes hate crime, on their services to keep their users safe. The 'duty of care' will apply to companies that provide services which facilitate the sharing of user generated content or user interactions, for example through comments, forums or video sharing.

Companies will be required to have effective and proportionate user redress mechanisms which will enable users to report harmful content and to challenge content takedown where necessary. This will give users clearer, more effective and more accessible avenues to question content takedown, which is an important safeguard for the right to freedom of expression. These processes will need to be transparent, in line with terms and conditions, and consistently applied.

Female Genital Mutilation: Education

Baroness Jenkin of Kennington (Conservative) [HL2173] To ask Her Majesty's Government what assessment they have made of whether female genital mutilation education in schools is having a positive impact.

Baroness Jenkin of Kennington (Conservative) [HL2174] To ask Her Majesty's Government what assessment they have made of the impact of female genital mutilation education in schools on any stigma experienced by children of African descent.

Reply from Baroness Berridge: Female Genital Mutilation (FGM) is child abuse and it is illegal. Services, including schools, should safeguard children from this abuse as from any other form of abuse.

Keeping children safe in education is statutory safeguarding guidance. All schools must have regard to it when carrying out their duties to safeguard and promote the welfare of children. The guidance sets out that safeguarding is everyone's responsibility and that all school staff should receive appropriate safeguarding training at induction and that the training should be regularly updated. The guidance states that all staff should speak to the school's designated safeguarding lead with regard to any concerns about FGM. It then goes on to explain the specific legal duty placed on teachers to report an act of FGM on a girl under the age of 18 to the police. The guidance is available here and attached:

We want to support all young people to be happy, healthy and safe. We want to equip them for adult life and to make a positive contribution to society. From September 2020, we are making Relationships Education compulsory for all primary pupils, Relationships and Sex Education compulsory for all secondary pupils and Health Education compulsory for all pupils in state-funded schools.

The statutory guidance states that by the end of secondary education, pupils should have been taught about FGM. Schools should address the physical and emotional damage caused by FGM. They should also be taught where to find support and that it is a criminal offence to perform or assist in the performance of FGM or fail to protect a person for whom you are responsible from FGM. As well as addressing this in the context of the law, pupils may also need support to recognise when relationships (including family relationships) are unhealthy or abusive (including the unacceptability of neglect, emotional, sexual and physical abuse and violence, including honour-based violence and forced marriage) and strategies to manage this or access support for oneself or others at risk. All teaching for these subjects should be age as well as developmentally appropriate and sensitive to the needs of the pupil. This includes ensuring that no pupil feels stigmatised. Schools for example should work closely with the local community and key partners such as school nurses, as well as draw on local health data, when planning their teaching for any aspect of these subjects.
