## UK Parliament, House of Commons Written Answers

### **British Nationality: Applications**

**Catherine West (Labour)** [178561] To ask the Secretary of State for the Home Department, how she plans to assess applicants for British citizenship who cannot meet the continuous residency requirement as they were unable to return to the UK from abroad as a result of the covid-19 pandemic.

**Reply from Kevin Foster:** We are taking a pragmatic approach to the coronavirus outbreak and continue to monitor the situation in all countries. Individuals who are following official advice will not be penalised as a result of issues arising from the COVID-19 pandemic.

There is discretion within the British Nationality Act 1981 to overlook excess absences. We would normally do so where there are compelling or compassionate grounds, such as the impact of the global pandemic.

### **Biometric Residence Permits**

**Peter Kyle (Labour)** [179297] To ask the Secretary of State for the Home Department, how many and what proportion of Biometric Residence Permit cards are produced by the DVLA within 10 working days of a notification of the decision to grant leave being sent out.

**Reply from Kit Malthouse:** DVLA processes all BRP within 10 working days of receiving the request. It has a service level agreement to complete 90% of production requests within one working day and the remaining 10% within two working days. For the financial year 2020/21 it achieved 69.3% (630,173) within 24 hours and 97.9% (259,977) within 48 hours. 2.1% (19,250) took longer than 48 hours.

The production of BRPs outside the 48 hour target was the result of a production failure at DVLA over a three working day period between 22 – 26 October 2020. The average processing time of the 19,250 affected was three working days. This enabled our secure delivery provider, FedEx, to attempt to deliver all BRPs within 10 working days of the decision notification being issued.

UKVI meets with DVLA weekly to monitor performance. The impacts of Covid-19 restrictions and safe working practices have reduced staffing capacity within the production site and contributed to the delays experienced in failing to achieve the 24 hour SLA.

**Stephen Timms (Labour)** [174718] To ask the Secretary of State for the Home Department, what steps her Department is taking to implement its commitment to external

engagement and transparency as part of its review of the compliant environment; and if she will publish the (a) past and (b) future programme of external consultation on that review.

**Reply from Chris Philp:** As part of our commitment to external engagement we have already spoken to a range of external stakeholders including employer groups, non-governmental organisations and other government departments. We will continue to do this throughout the review.

I can confirm we intend to publish a progress report on the evaluation at a suitable juncture. As set out in the Comprehensive Improvement Plan, initial analysis of data and evidence on the compliant environment will be completed by autumn 2021.

**Preet Kaur Gill (Labour Co-op) [174236]** To ask the Secretary of State for the Home Department, for what reasons her Department's Migration Statistics do not capture the number of applications (a) received, (b) granted and (c) rejected for visas under the adult dependent relative rule.

**Reply from Kevin Foster:** Home Office Migration Statistics capture data on a number of Adult Dependent Relative routes, which are grouped together with other routes under Family: Other (for immediate settlement) in our published data. This includes the number of applications received, granted and refused.

However, not all Adult Dependent Relative applications are captured under the Adult Dependent Relative route, to capture accurate data would require a manual trawl of cases and to do so would incur disproportionate cost.

### Immigration: Disclosure of Information

**Afzal Khan (Labour) [174258]** To ask the Chancellor of the Exchequer, what steps HMRC has taken to share Highly Skilled Tier 1 (General) migrant data with the Home Office for indefinite leave to remain decisions.

**Reply from Jesse Norman:** Where legally permitted and proportionate, HMRC undertake to share data with the Home Office (HO) under the relevant legislation and where requested by HO, which is governed by a single Partnership Agreement. The Partnership Agreement sets out the framework under which HMRC and HO work together. Under this partnership agreement, HMRC may undertake to share data where there is a Data Usage Agreement (DUA) or Memorandum of Understanding (MoU) for the purpose outlined within the agreements.

These documents are signed off by both departments and outline the approved legal gateway for the data share, the purpose of the data share, how the data will be used, what data is to be shared and how, data security obligations, and data retention policy.

HMRC have extensive senior governance in place to assure that DUAs adhere to legal requirements and are proportionate in their requests. All DUAs are assessed under relevant legislation and are reviewed under a regular schedule. Secure data transfer infrastructure is in place for data exchange, and data is only permitted to be used for the agreed purpose.

**Paul Blomfield (Labour) [174109]** To ask the Secretary of State for the Home Department, how many Tier 2 (General) working visas have been issued in each of the last 24 months.

**Reply from Kevin Foster:** The Home Office publishes data on Tier 2 (General)

visas in the '[Immigration Statistics Quarterly Release](#)'.

Data on the number of Tier 2 (General) visas are published in table Vis\_D02 of the [entry clearance visas applications and outcomes](#) dataset. Information on how to use the dataset can be found in the 'Notes' page of the workbook.

The latest data relates to year ending December 2020. Data for the first quarter of 2021 are due to be published on 27 May 2021.

### **Visas: English Language**

**Drew Hendry (SNP)** [179233] To ask the Secretary of State for the Home Department, what assessment her Department has made of the potential merits of enabling visa applicants who would have to travel between local authority areas to attend a testing centre to undertake online English language testing during the covid-19 outbreak.

**Reply from Kevin Foster:** As of 13 April 2021, all SELT test centres in the United Kingdom are open, and testing is available with appropriate health and safety measures in place. There are currently no plans to introduce online testing.

Consideration of the feasibility of online testing prior to the award of the current concessions contracts was undertaken in 2019, however it was assessed at the time the maturity of online proctoring technology and its anti-fraud measures were not at a suitable level to ensure the integrity of the SELT.

The Home Office continues to be interested in the opportunities, innovations and new technologies in this space which can be provided to our customers in the future.

### **Visas: British National (Overseas)**

**Naz Shah (Labour)** [174151] To ask the Secretary of State for Housing, Communities and Local Government, what funding the Government has provided to support integration of British National (Overseas) visa holders in each of the last five years.

**Reply from Eddie Hughes:** The Ministry of Housing, Communities and Local Government is leading the Government's work on welcoming Hong Kong BN(O)s into the UK. While the Department has run integration programmes such as the Controlling Migration Fund and the Integration Area Programme, these were not tailored to BN(O) communities.

The new BN(O) route and access to public services is an unprecedented offer following China's passing of the National Security Law. This new law significantly impacts the rights and freedoms of the people of Hong Kong and since the situation that BN(O) status holders find themselves in has changed, it is right that their rights and entitlements in the UK change too.

The visa route reflects the historic and moral commitment to the people of Hong Kong who chose to retain their ties to the UK by taking up BN(O) status at the point of Hong Kong's handover to China in 1997.

### **Windrush Generation: Compensation**

**Stuart C McDonald (SNP)** [179170] To ask the Secretary of State for the Home Department, what most recent information her Department holds on the number of applicants to the Windrush Compensation Scheme who have died in the period between applying for and receiving that compensation.

**Reply from Priti Patel:** Representatives of the estate of affected individuals who have sadly passed away can claim compensation. Close family members of an

eligible primary claimant, including in cases where the primary claimant has died, can also make a claim for compensation in their own right. Guidance and claim forms are available on GOV.UK

The specific information requested on the number of Windrush Scheme overseas applicants who had passed away before the application process was completed is not included in statistical data published by the Home Office.

The Home Secretary provides updates to the Home Affairs Select Committee on the work of the department in connection with Windrush.

### **Windrush Generation: Compensation**

**Stuart C McDonald (SNP)** [179171] To ask the Secretary of State for the Home Department, what most recent information her Department holds on the number of people whose applications to the Windrush Compensation Scheme remain outstanding more than (a) two years, (b) 18 months and (c) 12 months after first submitting those applications.

**Reply from Priti Patel:** Data on the number of claims received and the number of payment made is published as part of the regular transparency data release which can be found here:

Each person's claim is deeply personal and requires careful and detailed consideration to understand their individual circumstances and experiences. There are thirteen different categories of claim and some individuals' experiences are more complex than others and it is right we take the time to ensure these are considered carefully. We want people to receive the maximum compensation to which they are entitled and work closely with individuals, for example by contacting other government departments and third parties to help gather evidence to support their claim.

This holistic approach necessarily takes time but is ultimately beneficial to individuals. The average calendar days from the date the claim was received to a Full and Final payment date is 434, as at 31<sup>st</sup> January 2021.

However, we recognise that we need to go further and faster which is why, following feedback from the Windrush Cross Government Working Group, members of the Windrush generation, community leaders and those affected, we have made fundamental improvements to the Scheme to ensure people receive significantly more money, more quickly. As we continue to make decisions on the oldest cases, we expect to see the time taken from application to final decision fall significantly in the coming months.

### **Immigration: EU Nationals**

**Peter Grant (SBNP)** [175925] To ask the Secretary of State for the Home Department, what steps she is taking to ensure that EU citizens are able to access support to obtain their status through the EU Settlement Scheme by the deadline of 30 June 2021 in light of the disruption caused by the covid-19 pandemic.



**Reply from Kevin Foster:** We have worked extensively to promote awareness of the EUSS. The Home Office has already spent a total of £4.6 million on marketing campaigns to encourage those EU citizens and their family members who have not yet applied to do so. We recently launched a new £1.5 million wave of UK-wide advertising to ensure EU citizens and their family members are aware of the deadline and know they need to apply.

Guidance on how to apply and details of the support available to applicants (as it has been throughout the pandemic), is available through the EU Settlement Resolution Centre (SRC), which is open seven days a week to provide assistance over the telephone and by email. The SRC also provides a direct line for organisations working with vulnerable groups. In specific cases the SRC has the capacity to transfer customers to Assisted Digital for more bespoke support.

As well as the above process of “warm transfer” customers from SRC to our supplier We-Are-Digital (WAD), we signpost customers to our supplier WAD for the Assisted Digital service, which is available cost-free for customers who cannot access or struggle to use technology.

We remain committed to making sure everybody eligible for the EUSS can apply, including those who are vulnerable or need extra support. We have already awarded £17 million of funding to a network of now 72 organisations across the UK, to ensure important information and assistance gets through to those who are hardest to reach, and no one is left behind. These organisations have helped more than 250,000 vulnerable people to apply to the EUSS already.

In addition, we recently announced a further £4.5 million for the Grant Funded Network so it can continue to provide a wide range of invaluable support across the UK, including after the 30 June deadline, ensuring those most at-risk continue to get the help they need.

### **Immigration: EU Nationals**

**Peter Grant (SNP)** [175922] To ask the Secretary of State for the Home Department, what steps she is taking to help ensure that EU citizens who are resident in care homes in the UK are made aware of the requirement to apply to the EU Settlement Scheme.

**Reply from Kevin Foster:** The Home Office has provided £17million in grant funding to a network of 72 organisations which provide bespoke support to vulnerable and hard to reach EU citizens and their family members eligible to apply to the EUSS, including those who are resident in care homes or receiving some element of support from the care sector

On top of the £17million in grant funding, the Home Office recently announced a further £4.5million of funding to the 72 organisations to continue the support services well beyond the 30 June 2021 deadline.

Of the 72 Grant-funded Organisations (GFOs), 56 support the elderly to apply to the EU Settlement Scheme. These organisations are spread across the four nations.

In Scotland, Citizen’s Advice Scotland, have grant funding across their four consortiums, including thirty partner organisations who are working with 204 Care providers in the Clackmannanshire, Falkirk and Stirling local authority areas to target both EU citizens employed in the care sector, together with elderly EU citizens resident in care homes.

**Peter Grant (SNP)** [175926] To ask the Secretary of State for the Home Department, what assessment his Department has made of the potential merits of requiring EU Nationals with settled status to update their passport details with the EU Settlement Scheme each time they renew their passport.

**Reply from Kevin Foster:** Holders of EU Settlement Scheme status are issued with a letter from the Home Office which provides clear instructions as to how and when individuals can update their details using the online service.

We advise applicants to use the online Update Your Details service to update their passport information whenever it changes. When an update is made, the applicant will then use their new passport number to access their digital status.

Updating document details is advised, but not mandatory. Applicants can continue to log into their status using the document number they applied with.

### **Immigration: EU Nationals**

**Peter Grant (SNP)** [175924] To ask the Secretary of State for the Home Department, what steps she is taking to ensure that the rights of EU citizens to live and work in the UK are maintained in the event that those EU citizens have not been able to secure their status before the deadline for closure of the EU Settlement Scheme on 30 June 2021.

**Reply from Kevin Foster:** In line with the Withdrawal Agreement, EU citizens resident in the UK by the end of the transition period have until 30 June 2021 to apply to the EU Settlement Scheme, unless they have reasonable grounds for missing the deadline.

Those who apply before the deadline, but whose application is not decided until after it, will have their rights protected pending the outcome of their application (and of any appeal).

Where a person with reasonable grounds for missing the 30 June 2021 deadline applies to the scheme after the deadline and is granted status, they will, consistent with the Withdrawal Agreement, enjoy the same rights from the time they are granted status as someone who applied before the deadline.

### **Undocumented Migrants**

**John Hayes (Conservative)** [175701] To ask the Secretary of State for the Home Department, how many illegal immigrants are estimated to currently reside in the UK.

**Reply from Chris Philp:** In June 2019, the Office for National Statistics (ONS) published a note on '[measuring illegal migration](#)'.

By its very nature, it is not possible to know the exact size of the illegal population and so we do not seek to make any official estimates of the illegal population. The

Government is focused on making it harder for people to enter and live in the UK illegally whilst ensuring those who have the right to reside in the UK can do so. Exit checks introduced in April 2015 will, over time provide more detailed insights into the behaviour of migrants and how they comply with the restrictions placed upon their length of stay in the UK, but the data obtained does not provide the total number of illegal migrants currently in the UK.

**Vicky Foxcroft (Labour)** [174175] To ask the Secretary of State for the Home Department, what plans he has to use data collected through the Windrush Compensation Scheme to make an assessment of the revenue lost from taxation as a result of prohibiting undocumented migrants from taking up employment.

**Reply from Priti Patel:** None. The data collected through the Windrush Compensation Scheme relate to people who have status in the UK with the right to work rather than undocumented migrants without status.

### **Refugees: Syria**

**John Lamont (Conservative)** [179353] To ask the Secretary of State for the Home Department, how much funding has been provided to the Scottish Borders Council as part of the Syrian vulnerable person resettlement programme.

**Reply from Chris Philp:** All local authorities receive a 5-year tariff, per refugee resettled, to assist with costs incurred providing support to refugees they have welcomed through the Vulnerable Persons Resettlement Scheme. In year 1 this totals £8,520 per refugee, with additional support for educational and medical needs. In years 2-5 local authorities receive £12,000 per refugee in total: tapering from £5,000 in year 2 to £3,700 in year 3, to £2,300k in year 4 and £1,000k in year 5.

[Home Office Immigration Statistics](#) on asylum and resettlement are published on a quarterly basis. This includes a detailed breakdown of the number of refugees resettled to each local authority.

### **Asylum: Applications**

**Catherine West (Labour)** [174211] To ask the Secretary of State for the Home Department, what steps her Department is taking to reduce applicant waiting times for decisions on asylum applications.

**Reply from Kevin Foster:** We are fixing a broken asylum system and creating a new one which will be fairer and firmer and compassionate towards those who need our help.

There are several factors which contribute to the length of time to process asylum claims. In this context, we have developed a programme of work designed to transform the system.

We have already made significant progress in prioritising cases with acute vulnerability and those in receipt of the greatest level of support, including Unaccompanied Asylum-Seeking Children and are working to simplify and speed up decision making.

We are continuing to develop existing and new technology to help build on recent improvements such as digital interviewing and move away from a paper-based system.

### **Asylum: Slavery**

**Liz Saville Roberts (Plaid Cymru)** [175960] To ask the Secretary of State for the Home Department, what assessment her Department has made of the potential merits of granting asylum seekers who are victims of modern slavery a minimum of one year of leave to remain in the UK to support their long term recovery.

**Reply from Victoria Atkins:** The UK's policy for confirmed victims of modern slavery is to consider granting discretionary leave to remain on a case-by-case basis, based on the individual's circumstances. The published policy can be found on gov.uk [Discretionary leave for victims of modern slavery casework guidance](#) and gives a number of examples in which a grant of discretionary leave is appropriate. Confirmed victims of modern slavery who are also asylum seekers are eligible for a grant of leave under the same policy, but this usually only needs to be considered if the asylum claim is refused.

As part of the New Plan for Immigration announced on 24 March 2021, we are consulting on a proposal that confirmed victims with long-term recovery needs linked to their modern slavery exploitation can be considered for a grant of temporary leave to remain to assist their recovery. This builds on our end-to-end needs-based approach to supporting victims. We also make clear that temporary leave to remain may be available to victims who are helping the police with prosecutions and bringing their exploiters to justice.

As part of that work, we have looked at what a whole host of other countries do in order to inform a plan for the UK.

Specific discussions in respect of identifying a particular place for asylum processing would always be done in close partnership with that country jurisdiction.

**Reply from Chris Philp:** We are finalising communication plans to ensure the proposed measures are appropriately communicated to the public, key stakeholders and those affected by the changes.

We are currently running an organised immigration crime deterrence campaign which directly speaks to migrants in their native languages. We are preparing the next phase of the campaign, including how it can reflect and support the New Plan for Immigration.

**Neil Coyle (Labour)** [175880] To ask the Secretary of State for the Home Department, pursuant to Answer of 11 February 2020 to Question 11509, on Asylum, what steps his Department have taken to consult representatives of (a) the Church of England, (b) the Catholic Church and (c) other faith based organisations on the review and action plan in respect of asylum claims on the basis of religion.

### **Asylum: LGBT People**

**Neil Coyle (Labour)** [175881] To ask the Secretary of State for the Home Department, pursuant to Answer of 11 February 2020 to Question 11509, on Asylum, what steps his Department has taken to consult representatives of LGBT+ organisations on the review and action plan in respect of asylum claims on the basis of sexuality.

**Reply from Chris Philp:** The UK has a proud record of providing protection to individuals fleeing persecution based on their religious beliefs, sexual orientation and gender identity and are committed to delivering an asylum system that is responsive to all forms of persecution.

We have previously worked closely with the All-Party Parliamentary Group (APPG) for International Freedom of Religion or Belief and associated stakeholders, to produce a specialist training package designed to ensure that where religion or belief is raised in an asylum claim, decision makers appropriately consider all the available evidence. The course has now been rolled out to all relevant staff and we will continue to update this as and when required, working with relevant parties.

The Home Office continue to work with organisations specialising in sexual orientation/gender identity to further our work for LGBT+ people, including the development of a new interview training workshop that is being developed in consultation with UK Lesbian Gay Immigration Group (UKLGIG). It is hoped that, if successful, this training will be rolled out in the next few months.

Updated policy guidance on how to approach religious based claims and sexual orientation has been published, including guidance on the need to ensure appropriate and sensitive questions are asked during asylum interviews.

Our processes are underpinned by a robust framework of safeguards and quality checks, ensuring that claims based on LGBT+ issues are properly considered, decisions are sound, and that protection is granted to those who genuinely need it.

We do not have any plans to publish the findings of this internal review.

## UK Parliament, House of Lords Oral Answers

### Clergy: EU Visas and Residence Permits

**The Lord Bishop of Leeds:** To ask Her Majesty's Government what assessment they have made of the impact of new (1) visa, and (2) residence, permit regimes for United Kingdom citizens working in the European Union on the numbers of Church of England clergy securing such permits.

**Reply from the Minister of State, Foreign, Commonwealth and Development Office:** My Lords, the withdrawal agreement protects UK nationals who were lawfully resident in the EU before the end of the transition period. Thirteen member states require them to apply for new resident status. British citizens travelling to the EU for work may need visas or permits from relevant member states. Member states are, of course, responsible for implementing their domestic immigration systems, and the UK does not hold information on the specific occupations of UK nationals abroad.

**The Lord Bishop of Leeds:** ... This is of course a question that goes wider than the Church, but let us consider a diocese in Europe supporting UK citizens which is now unable to assign clergy for locum duty, for example, because of the lack of clarity regarding work permits. How do the Government intend to support UK citizens in what was an inevitable outcome of the withdrawal agreement? Can the Minister give any practical encouragement to the Bishop in Europe as he seeks to resolve these issues?

**Reply from Lord Ahmad of Wimbledon:** My Lords, I assure the right reverend Prelate that, as he may well be aware, we are working very closely with the Church of England—for example, on citizens' rights—as it is one of the implementing partners of the UK nationals support fund. In addition, through our embassies, we are providing direct and relevant support as well as an extensive communications programme for all citizens across the European Union.

**Lord McConnell of Glenscorrodale (Labour):** ... the Church of Scotland also has deep concerns about the position of locum ministers serving congregations throughout the European Union following Brexit. We also have concerns about split ministries, where the minister involved may be part-time in two different, perhaps neighbouring, countries, in two different churches. Will the Government guarantee to involve the Church of Scotland in any discussions about resolving these issues, including, of course, other Churches and faiths?

**Reply from Lord Ahmad of Wimbledon:** My Lords, I can of course assure the noble Lord that we will work with all organisations, including the Church of Scotland. ...

**Lord Flight (Conservative):** My Lords, many religious communities are not yet aware of how they will be affected by Brexit. They have relied on EU members to fill temporary posts; this will be hit when free movement ends on 31 December, along with routes for the previous temporary priest cover for summer holidays, for example. They can no longer sponsor a worker in the tier 5 category to fill the post of temporary minister of religion. Do the Government anticipate that the basis of an individual's visits will fall within the visitors' visa rules?

**Reply from Lord Ahmad of Wimbledon:** My Lords, I will write to my noble friend on the specific question he raises and, of course, place a copy in the library.

**Lord Singh of Wimbledon:** My Lords, the Question reminds us that we have inextricable ties of culture, trade and even religion with our former partners in the European Union. Does the Minister agree that, rather than looking selectively to the concerns of Anglicans, we should be looking to better working arrangements for all branches of Christianity, as well as other faiths and cultures, in reducing onerous visa requirements and enhancing better living and working arrangements with our former partners in Europe?

**Reply from Lord Ahmad of Wimbledon:** My Lords, I will first perhaps correct the noble Lord by saying that we do not regard the European Union as former partners; we continue to have a strong partnership with the European Union on a range of different issues. On the issues of religion and communities across Europe, yes, diversity is a strength of the continent and we should encourage those who wish to visit different parts of it. In this regard, the noble Lord will be aware of what has already been agreed: the ability to visit different countries on a rolling basis without the necessity of visa requirements. Anyone wishing to visit the European Union from the UK can do so for 90 days on a revolving 180-day basis. ...

**Lord Wallace of Saltaire (Liberal Democrat):** My Lords, I want to press the Minister on reciprocity. There are expatriate communities in this country that also have religious services—the Swedish Church in London, in which I have sung, and other Lutherans; French and Polish congregations; Jewish congregations with visitors from the continent—so there are clear mutual interests. Are we negotiating on the basis of reciprocity or are we asking for greater freedom of access for UK citizens in the EU than for EU citizens in the UK?

**Reply from Lord Ahmad of Wimbledon:** My Lords, the noble Lord raises an important issue on reciprocal arrangements. There are a whole range of areas where we have seen reciprocal arrangements put in place. The whole purpose of the Specialised Committee on Citizens' Rights, which is supported both by the UK and by the EU—officials are meeting regularly—is to unlock those very issues that can provide for the kind of access that he is suggesting. ...

## UK Parliament, House of Lords Written Answers

### Immigration: Roma

**The Lord Bishop of St Albans [HL14662]** To ask Her Majesty's Government what steps they are taking to assist members of the Roma community to apply for settled status under the EU Settlement Scheme before 30 June; and what assessment they have made of the barriers (1) to obtaining the required documentation during the COVID-19 pandemic, and (2) to accessing, and completing, online applications, experienced by that community.

**Reply from Baroness Williams of Trafford:** The Home Office has provided £17million in grant funding to a network of 72 organisations which provide bespoke support to vulnerable and hard to reach EU citizens and their family members eligible to apply to EUSS, including members of the Roma Community.

Of the 72 Grant-funded Organisations (GFOs), 54 support members of the Roma community to apply to the EU Settlement Scheme, with 5 organisations primarily focused on working with vulnerable members of this cohort (Clifton Learning Partnership, Tros Gynnal, STEP Northern Ireland, Tower Hamlets Law Centre, and Positive Action in Housing).

On top of the £17million in grant funding, the Home Office recently announced a further £4.5million of funding to the current 72 organisations to continue these

support services well beyond the 30 June 2021 deadline.

Whilst the GFN directly funds 72 organisations, these organisations have expanded their network across the UK by forming partnerships with other organisations. These partners are similar, they are on the ground, giving direct support to the vulnerable including homeless/rough sleepers, victims of domestic violence and members of the Roma community.

This network is also supported by the Home Office through an online GFO forum called 'Basecamp'. This platform allows organisations to share ideas, best practise and for organisations to reach out to one another for help and support. It is the innovative ways of working demonstrated by the Grant Funded Network during the COVID-19 pandemic, which have continued to meet the needs of vulnerable individuals for completing online applications or accessing digital status, such as virtual face to face meetings and, where necessary, face to face appointments with use of lateral flow testing, enabling them to do so in a safe way for both themselves and these vulnerable individuals.

The EU Settlement Resolution Centre, will also continue to provide over the phone digital assistance to applicants who require support to access their digital status.

### **Asylum: Housing**

**The Lord Bishop of Durham** [HL14571] To ask Her Majesty's Government how many members of staff working for asylum accommodation providers have received the training specified in the Asylum Accommodation and Support Statement of Requirements; and whether training for staff who have face-to-face contact with service users is stipulated in Home Office contracts with providers.

**Reply from Lord Greenhalgh:** The Asylum Accommodation and Support Services contracts (AASC) are published and the requirements of the contract are set out in the Statement of Requirements, this includes provisions around training and the training programme for those with face-to-face contact with our customers.

The Provider must fully equip and train staff (including volunteers) to ensure they are able to fulfil their roles and ensure appropriate and sufficient security provisions are made for all staff undertaking face-to-face activities. Those with face to face contact must cover the following:

- Ethnic diversity and cultural awareness
- Suicide and self-harm awareness and prevention
- Basic First Aid
- Gender based violence
- Fire Safety
- Health and Safety
- Vicarious Trauma
- Unconscious Bias
- Counter Terrorism
- Modern Slavery
- Training relating to housing standards and regulatory requirements

As a minimum, provider staff should receive refresher training on the requirements listed above annually (i.e. refresher training completed every twelve (12) months), or more regularly if required.

The Home Office does not intend to publish data on the number of staff employed by accommodation providers, who will be expected to undertake training. However, provider performance and service delivery is discussed on a weekly basis. There



are formal performance meetings each month, plus strategic boards with senior provider management, once a quarter.

The Home Office discusses performance of the contracts and service improvements with Local Authorities who participate in asylum dispersal. Durham is the only Local Authority in the North East of England who do not accommodate supported asylum seekers. We would encourage all Local Authorities to play their part and hope Durham will join their neighbours in doing so.

### **Asylum: Housing**

**The Lord Bishop of Durham** [HL14572] To ask Her Majesty's Government what procedures they have established to (1) monitor, and (2) evaluate, contracts with asylum accommodation providers.

**Reply from Lord Greenhalgh:** We expect the highest standards from our providers, who are expected to conduct regular checks across the accommodation estate. The Home Office have access to providers' systems to monitor compliance. The Asylum Accommodation and Support Services contracts (AASC) have a robust performance management system, against which providers are expected to deliver. Where performance falls short of the required standard, failures are recorded and can result in the award of points and, ultimately, service credits being applied. Providers' performance is monitored closely by dedicated staff in each contract area, who are in daily contact with them.

This is supplemented by a formal governance process which includes quarterly Strategic Review Management Boards and monthly Contract Management Groups. Service credits and subsequent improvement plans are discussed and monitored as part of this process.

Contract management is operated in line with Covid-19 guidance. Service Delivery Managers speak daily with providers about service delivery and performance. In response to the global pandemic, officials also have formal meetings on a weekly basis to ensure individuals are housed safely, services are delivered in line with their contractual obligations and adherence to guidance from Public Health England (PHE) is followed. Asylum seekers can also raise specific issues or concerns about their accommodation through the 24/7 Advice, Issue Reporting and Eligibility (AIRE) service operated by Migrant Help. The Home Office and our providers receive feedback on complaints raised through our regular dialogue with Migrant Help, which enables attention to be focussed on particular areas of concern.

### **Asylum: Military Bases**

**Lord Hylton (Crossbench)** [HL14386] To ask Her Majesty's Government whether the number of residents at Napier Barracks and Penally training camp has reduced since 12 March; how many residents have tested positive for COVID-19; and when they expect to provide adequate accommodation for all residents.

**Reply from Baroness Williams of Trafford:** The number of residents at Napier has reduced since 12 March 2021.

Due to the closure of Penally Training Camp, the accommodation providers Clearsprings Ready Homes (CRH) have moved all remaining asylum seekers as of the 21 March.

197 people accommodated at Napier tested positive for coronavirus earlier this year. There have been no recorded cases at Penally.

All asylum seekers who would otherwise be destitute are provided with safe, suitable, fit for purpose and correctly equipped accommodation.

**Reply from Baroness Williams of Trafford:** The current global pandemic has presented us with significant challenges when it comes to the provision of asylum accommodation, including sourcing sufficient suitable accommodation to meet demand.

The use of hotels and wider government facilities as contingency accommodation are a short-term measure. We are working to move people to longer-term dispersal accommodation as soon as it becomes available.

**Reply from Baroness Williams of Trafford:** Tackling modern slavery, including child trafficking, is a priority for this Government and we are committed to continuing to work closely with EU partners to address this heinous crime.

The UK/EU Trade and Cooperation Agreement (TCA) delivers a comprehensive package of capabilities that ensures we can work with counterparts across Europe to tackle serious crime. This includes enabling our law enforcement agencies to continue to share information on investigations, including those related to child trafficking, with EU counterparts.

## UK Parliament, House of Commons Oral Answer

### **Prime Minister's Questions: The Commission on Race and Ethnic Disparities**

**Kim Johnson (Labour)** Contrary to the conclusions of the Commission on Race and Ethnic Disparities report, institutional racism still exists. Forty years since the Liverpool 8 uprisings, black communities continue to suffer racial injustice and the report downplays the structural inequalities that still exist. The Resolution Foundation announced today that the unemployment rate for young black people rose by 35%, compared with 13% for their white counterparts. Can the Prime Minister confirm the allegations that Downing Street redrafted the report to change the narrative? Does he agree that the report should now be withdrawn? (914262)

**Reply from the Prime Minister:** Of course, when we look at and read the report in detail, the Government are not going to agree with everything, but there are some interesting observations and some interesting ways of looking at things. We will be responding in due course, but what we say is that nobody should be in any doubt as to the reality of racism and the struggle that too many people face. We will do everything we can to stamp it out, particularly to help young black people get the jobs and the education they need.

### Students: Ethnic Groups

**Lord Taylor of Warwick (Non-affiliated)** [HL14349] To ask Her Majesty's Government what steps they are taking to reduce the attainment gap between ethnic minority university students and other university students.

**Reply from Lord Parkinson of Whitley Bay:** It is more crucial than ever before that we tap into the brilliant talent that our country has to offer, and make sure that university places are available to all who are qualified by ability and attainment to pursue them and who wish to do so.

All higher education providers wishing to charge higher levels fees must have an access and participation plan agreed by the Office for Students (OfS), the regulator for higher education. These plans set out how they will support students from disadvantaged backgrounds and under-represented groups, including students from ethnic minority backgrounds, to access, participate, and succeed in higher education and to progress from it.

On 11 March the OfS published the access and participation data dashboard, which is used to identify gaps in access, continuation, attainment, and progression at English providers delivering undergraduate provision by different student characteristics. This is available here:

## UK Parliament Early Day Motions

**Diane Abbott (Labour) [1726] Report of the Commission on Race and Ethnic Disparities** – That this House notes that the publication of the report of the Commission on Race and Ethnic Disparities in March 2021 was met with immense disappointment and frustration by members of Black, Asian and minority ethnic communities across the country, and many racial justice organisations; is deeply concerned that the report largely seems to deny the existence of institutional racism in Britain, and in doing so has raised concerns that it reverses progress towards racial equality; is alarmed by the report's poor methodology, including selectively citing and listing authors and academics whose views were neither sought, or accurately represented in the report; further notes the disturbing allegations that the report was rewritten by No.10; urgently calls on the Government to acknowledge the existence of institutional racism in society and commit to tackling it in all forms; further calls on the Government to reject the report and instead implement the recommendations of existing reports on institutional racism, including the Macpherson report, the Lammy review, the McGregor Smith review and the Windrush Lessons Learned review.

**Bell Ribeiro-Addy (Labour) [1709] Black maternal health** – That this House recognises the existing racial inequalities in maternal health; notes with great sadness that Black women in the UK are four times more likely to die in pregnancy and childbirth, that women of mixed heritage are three times more, and Asian women are two times more likely to die in pregnancy and childbirth; further notes that women of Black African heritage are 83 per cent more likely to suffer a near miss in childbirth, and women of Black Caribbean heritage are 80 per cent more likely; acknowledges the MBBRACE analysis which has found that black babies have a 121 per cent increased risk for stillbirth and a 50 per cent increased risk of neonatal death; supports the work of Five X More and their efforts to raise awareness of Black maternal health inequalities; is shocked by the 2020 Black people, racism and human rights report which confirms statistics but reveals that there is no target to end it; and urgently calls on this Government to fully acknowledge these disparities and commit to working with the NHS to improve Black maternal health outcomes.

## Racism, Religious Hatred, and Discrimination

*The following two questions both received the same answer*

#### **Hate Crime: Educational Institutions**

**Preet Kar Gill (Labour Co-op) [174229]** To ask the Secretary of State for the Home Department, how many hate crimes have been recorded at education institutions in each of the last 10 years.

#### **Hate Crime: Young People**

**Preet Kar Gill (Labour Co-op) [174230]** To ask the Secretary of State for the Home



Department, what support is available to young people to help them report a hate crime if they are a victim or witness of such a crime at college or at school.

**Reply from Victoria Atkins:** There is no place for racism and hatred in our education system. Schools and colleges have an important role in preparing children and young people for life in modern Britain. This involves supporting them to understand the society in which they are growing up and teaching about respect for other people and tolerance.

The Government expects schools to take a strong stand against all forms of bullying and discrimination and tackling it at the earliest opportunity to prevent it from escalating, particularly given the impact it can have on pupils, both emotionally and physically. Schools should develop their own approaches for monitoring bullying and discriminatory incidents and exercise their own judgement as to what will work best for their circumstances. We expect schools to support pupils affected by hate crimes and bullying as necessary.

The Government has continued to take action to support schools in this area. This work has included projects targeting bullying of particular groups, such as those with SEND and those who are victims of hate related bullying, along with a project to report bullying online.

In extreme circumstances, where schools are concerned that an incident of bullying or discrimination may amount to a criminal offence, they should report this to the police.

Victims may wish to seek contact from an organisation to provide them with support suitable to the victim's needs. A list of such organisations can be found at the police-run True Vision website at the following link:

### **Hate Crime: Educational Institutions**

**Preet Kaur Gill (Labour Co-op) [179340]** To ask the Secretary of State for the Home Department, pursuant to the answer of 31 March 2021 to Question 174230, on Hate Crime: Young People, when her Department last undertook a review of the efficacy of its policies on the prevention and reporting of hate crimes in schools and colleges.

**Reply from Kevin Foster:** The government, alongside schools and teachers, is committed to supporting children and young people to thrive and reach their potential in a safe and respectful environment.

Schools continue to play an important role in preparing children and young people for life in modern Britain, supporting them to understand the society in which they are growing up and teaching about respect for other people and tolerance.

We continue to work with colleagues across government, as well as those in the school sector and communities to better understand issues around discrimination, hatred and prejudice on an ongoing basis. For example, the Department for Education has provided funding to anti-bullying organisations to support schools to tackle bullying, including projects targeting bullying of particular groups, such as those who are victims of hate related bullying.

These grants ended in March 2021, and grant holders are currently working to finalise independent evaluations of their programmes, which will be published in due course.

The Department for Education has considered next steps for anti-bullying support in schools, working closely with external stakeholders, and will shortly be running a

procurement exercise to fund activity in 2021-22.

#### **Crime: Ethnic Groups**

**Baroness Ritchie of Downpatrick (Non-affiliated)** [HL14464] To ask Her Majesty's Government what steps (1) they have taken, and (2) they intend to take, to address the level of (a) domestic abuse, (b) violence against women and girls, (c) hate crime, (d) online hate, and (e) online radicalisation, experienced by BAME communities.

#### **Reply from Lord Greenhalgh:**

Domestic Abuse and VAWG

Tackling Domestic abuse and violence against women and girls (VAWG) is a government priority. These abhorrent crimes have no place in our society.

We know that anyone can be a victim of domestic abuse, regardless of ethnicity or background. That is why the Home Office has provided funding to 'by and for' specialist services including, Southall Black Sisters who have been provided with

£80,951 in funding during the Covid pandemic.

Added to this, our landmark Domestic Abuse Bill which is due to achieve Royal Assent this Spring will strengthen our response to perpetrators and improve our support to victims. This Summer the Government will also publish a strategy to combat Violence Against Women and Girls, followed by a complementary strategy on Domestic Abuse.

#### Hate Crime & Online Hate

The Government has been clear that all forms of hate crime are unacceptable and that the cowards who commit these crimes should face the full force of the law. Action under the hate crime action plan 2016-20 (Action Against Hate: The UK Government's plan for tackling hate crime) included approximately £5 million for protective security measures to protect places of worship and asking the Law Commission to review the effectiveness and coverage of hate crime legislation.

In November 2020, the Ministry of Housing, Communities and Local Government awarded £1.8 million through the Faith, Race and Hate Crime Grant Scheme to support established community groups and civil society organisations to run short projects to boost shared values and tackle religiously and racially-motivated hate crime.

We have published the Full Government Response to the Online Harms White Paper, which includes specific measures to work with private companies and ensure that they are held to account for tackling illegal activity and content, such as hate crime, harassment, and cyber-stalking, as well as activity and content which may not be illegal but is nonetheless highly damaging to individuals (legal but harmful). The Full Government Response will be followed by legislation, which we are working on at pace, and will be ready this year. The Home Office also funds a Police Online Hate Crime Hub to improve the police response to victims of online hate crime.

#### Online radicalisation

Terrorist groups use the internet to spread propaganda designed to radicalise, recruit and inspire vulnerable people, and to incite, provide information to enable, and celebrate terrorist attacks. Our objective is to ensure that there are no safe spaces online for all forms of terrorists to promote or share their extreme views.

In 2010, we set up the police Counter Terrorism Internet Referral Unit (CTIRU), based in the Metropolitan Police. To date, over 314,500 individual pieces of terrorist content referred by CTIRU have been removed by companies and the Unit has also informed the design of the EU Internet Referral Unit based at Europol.

The Government has also pressed companies to increase the use of technology to automate the detection and removal of content where possible. As a result of continued engagement, companies have expanded the use of automated removals.

### Coronavirus: Vaccination

**Stuart Anderson (Conservative)** [131481] To ask the Secretary of State for Health and Social Care, what steps he is taking to ensure that people (a) from a BAME background and (b) who are more vulnerable to covid-19 receive the vaccination in a timely manner.

**Reply from Nadhim Zahawi:** On 13 February the Government published the United Kingdom COVID-19 Vaccine Uptake Plan, which aims to improve uptake across all communities on a national scale, including those from black, Asian or other minority ethnic backgrounds and those who are more vulnerable to COVID-19. The plan takes a local, community-led approach, with support provided from the Government, NHS England and NHS Improvement and local authorities to coordinate and enable action.

On 25 January we released £23.75 million funding to support our Community Champions Scheme. Through the Community Champions scheme councils and voluntary organisations will deliver a wide range of measures to communicating accurate health information. The funding is specifically targeted at areas with plans to reach groups such as older people, disabled people and people from ethnic minority backgrounds who according to the latest evidence are more likely to suffer long-term impacts and poor outcomes from COVID-19. Each of the sixty councils in receipt of funding have developed their own plan to improve communications with these groups including helplines, school programmes, workplace engagement, phoning those in at risk groups as well as training sessions to help people provide information and advice. On 24 February 2021, the COVID-19 vaccine deployment programme, working with partners, made available an extra £4.2 million initially, to further support and enable locally led community engagement in all areas with health inequalities to support those who are most vulnerable to get their vaccine.

**Reply from Lord Bethell:** Over £23 million has been allocated through the Community Champions scheme to 60 councils and voluntary groups across England to expand work to support those most at risk from COVID-19 and boost vaccine take up. The Department of Health and Social Care, the Ministry of Housing, Communities and Local Government and the National Health Service hold regular meetings with local authorities, faith leaders and black, Asian and minority ethnic organisations to provide advice and information about COVID-19 vaccines and how they will be made available. A coalition of trusted voices to promote vaccine confidence in target audiences will be built and also provide us the opportunity to listen to concerns and adjust our approach. Local NHS staff and council officials have attended online question and answer sessions facilitated by local community leaders and community engagement workers have visited areas of low vaccine uptake to provide information in spoken and written community languages.

**Reply from Lord Bethell:** Whilst there are no plans to establish national COVID-19 telephone helplines for the public to use to ask questions related to COVID-19 vaccines, the Department and the NHS and PHE are providing advice and information at every possible opportunity to support those who have been prioritised to receive a vaccine and anyone who has questions about the vaccination process. The latest advice and information is available online and our social media channels are regularly publishing fact cards, films and interviews about vaccine safety and answering frequently asked questions about vaccine production. In addition, senior clinicians are giving media interviews and taking part in live question and answer sessions with the public about COVID-19 vaccines.

The Government's communications plan includes targeted information and advice via TV, radio and social media. This is being translated into 13 languages including Bengali, Chinese, Filipino, Gujarati, Hindi, Mirpur, Polish, Punjabi and Urdu. Print and online material, including interviews and practical advice has appeared in 600 national, regional, local and specialist titles including media for African, Asian, Bangladeshi, Bengali, Gujarati, Jamaican, Jewish, Pakistani and Turkish communities.

Research to evaluate the long-term health and psychosocial effects of COVID-19 is continuing. Major studies include the Post-Hospitalisation COVID-19 study in the United Kingdom and the International Severe Acute Respiratory and emerging Infection Consortium global COVID-19 long-term follow-up study.

**Baroness Ritchie of Downpatrick (Non-affiliated)** [HL14461] To ask Her Majesty's Government what assessment they have made of the effectiveness of the measures (1) in place to address the COVID-19 pandemic, and (2) aimed at minimising the impact of COVID-19 among BAME communities.

**Reply from Lord Bethell:** Throughout the pandemic the Government has sought robust scientific evidence and advice to guide decisions regarding the measures taken to address the COVID-19 pandemic. The Scientific Advisory Group for Emergencies and its sub-groups has undertaken significant wider analysis and evaluation including consideration of economic impacts, the level of compliance with measures, amount of enforcement needed and impacts felt by local authorities. The measures taken have been effective at slowing the virus while balancing the need to protect the economy.

The Minister for Equalities (Kemi Badenoch MP) is leading cross-Government work to tackle disparities experienced by ethnic minority groups. The second quarterly report, published on 26 February 2021, set out work conducted since the first quarterly report, including reviewing the effectiveness of current actions being undertaken by the Government to lessen disparities in infection and death rates. The report reflects that considerable efforts are underway to address these disparities, including through the Community Champions scheme led by the Ministry for Housing, Communities and Local Government, which has provided £23.75 million in funding to local authorities. The report commits the Government to monitoring the impact of the scheme. The report found that the direct impacts of COVID-19 improved for ethnic minorities as a whole during the early second wave. ... The Government remains committed to addressing ethnic disparities and

tackling deprivation will be a particular focus of work in the third quarter.
