# **Immigration and Asylum**

### **Scottish Parliament Ministerial Statement and Q&A**

### **Ukraine (Humanitarian Response)**

The Minister for Culture, Europe and International Development and Minister with special responsibility for Refugees from Ukraine (Neil Gray): ... We, as a nation, stand in solidarity with the people of Ukraine. Our communities have welcomed thousands of people who are fleeing the war, Scottish families have opened their homes, and our local authorities and third sector partners are working tirelessly to provide people who are often traumatised with the safety and support that they need.

Unlike with the Syrian vulnerable persons resettlement scheme, we were not able to plan in advance, and homes had not already been found for people before they travelled. The displacement from Ukraine has been on a large scale and swift, causing a humanitarian crisis that Europe could not have predicted or planned for. ...

Thanks in large part to our supersponsor scheme, Scotland has now offered a place of sanctuary to more than 21,000 people—a fifth of all United Kingdom arrivals and double our population share. ...

By pausing the scheme in July, we sought to ensure that we were able to continue to provide appropriate accommodation and support to those displaced people who had already arrived and to those we knew would arrive in the weeks ahead. At that time, I also committed to a review of the scheme. ...

... the review has identified 16 interventions for our warm Scottish welcome, to improve our offer and to ensure that we are doing everything that we can to help those from Ukraine. There are seven criteria for reopening the supersponsor scheme. ...

For many people, moving from welcome accommodation to long-term accommodation is a key milestone. ... We want to be there to support them through this time. ...

One intervention that we have already begun is increasing the supply of housing stock through the £50 million Ukraine longer-term resettlement fund. ...

The Scottish Government does not want anyone to stay in welcome accommodation longer than is necessary. It is clear that a settled home is a better longer-term outcome, so we will set a clearer expectation that stays will be short term, and we will highlight the support that is available to secure longer-term settled accommodation.

With many arrivals now in employment or in receipt of social security benefits, when appropriate, and in line with guests in private host homes and people living in other temporary rented accommodation, we will also consider asking for a contribution to temporary welcome accommodation for those who are still using it. That will help us to improve the prioritisation of limited temporary accommodation ...

We want to place people with hosts quickly and safely, but we know that the most successful arrangements happen when the needs of both hosts and Ukrainians align, which is why matching is a two-way process and resettlement leads must listen and take account of the needs and preferences of Ukrainians. ... Matching takes time and considerable input, so we have increased resources to our local authorities to boost the process ...

There will also be many people who are interested in hosting who have not yet taken the first step, as they are not sure what is expected of them. Therefore, we will launch a Scotland-specific campaign to ask households across the nation to consider offering a place in their home to a Ukrainian. As part of that campaign, later this month, we will hold our first warm Scottish gathering, where Ukrainians and our local communities can come together. ...

Scotland is facing the most severe economic upheaval in a generation ... Difficult decisions are being taken that affect all of Scotland's people, and our offer of support for people who have been displaced by the conflict in Ukraine is, unfortunately, not immune to that. ...

Reopening the scheme must be predicated on ensuring that we are able to honour our commitment to displaced people who are already in Scotland and those who are yet to travel. We must be assured that measures are in place to mitigate pressures on local councils and other services, which have been working tirelessly, and that funding is in place to meet the associated costs. Having considered the current position, I have concluded that we are unable to resume applications to the supersponsor scheme at this time.

That does not mean that there are no new arrivals from Ukraine. There are daily arrivals from Ukraine—around 100 a day—and there are more than 13,000 visa holders still to travel. The private sponsor route for Ukrainians remains open. ...

**Donald Cameron (Conservative):** ... The Scottish Conservatives recognise the efforts that Governments across the United Kingdom have taken to ensure that as many Ukrainian refugees as possible can seek sanctuary from the horrors that continue to unfold in their homeland. We appreciate that there will be profound challenges ahead in ensuring that many of those people can settle in a permanent home and begin to build a new life here.

However, despite the best intentions of the minister and his officials—I have never doubted their intentions for a moment—the supersponsor scheme remains mired in problems, which are exacerbated by the housing crisis ...

I therefore ask the minister on what date he expects the supersponsor scheme to resume, given that it has now been paused for four months. I will also ask the same question that I asked on 8 September, which remains unanswered. Can the minister detail specifically the average time that it takes between arrival in Scotland and placement in permanent accommodation?

**Reply from Neil Gray:** ... The scheme is, without doubt, incredibly successful. It has meant that, at the last count, almost 18,000 people have been able to get to Scotland and the UK without securing a private sponsor, and there are many more to come. ...

The challenges with housing that we face in Scotland are not unique to Scotland ... On the resumption of the scheme, we now have objective criteria by which we will continually assess the issue. When those criteria are met, we will take a decision on resuming the scheme. I cannot put a timescale on that ...

The average time that it takes for people to be matched from temporary accommodation into permanent accommodation varies. Just as people vary and the circumstances that they arrive with vary, their needs and what they are looking for will be different. ...

**Sarah Boyack (Labour):** ... We have a long-standing housing crisis in Edinburgh and I want to ask the minister why the £50 million funding allows only repurposing of buildings. ... I therefore ask about the proposal for modular housing. ... my understanding is that modular homes are already available as an option for new build by both registered social landlords and councils for permanent housing?

The minister also talked about promoting employment ... Can he say what is being done to monitor the employment of Ukrainians coming to Scotland and what is being done on a joined-up approach for employability support? ...

**Reply from Neil Gray:** ... At the start of the scheme, when we first looked at providing a humanitarian response, I was determined that it was going to be a truly Scotland-wide effort, and I think that we are seeing that. ...

... we are looking at what we can do with modular accommodation, and it is part of the review. ...

... we are obviously cognisant of the need to run the scheme in an equitable way, making it sustainable and encouraging people to go into longer-term accommodation. We are also trying to ensure that our offer to Ukrainians provides parity with our offer to people who are in temporary accommodation for other reasons ...

### **Scottish Parliament Oral Answers**

### **Accommodation (Displaced People from Ukraine)**

**Mark Ruskell (Green)** [S6O-01501] To ask the Scottish Government what support is available to displaced people from Ukraine who are moving from temporary accommodation into permanent housing.

Reply from the Cabinet Secretary for Social Justice, Housing and Local

**Government (Shona Robison):** Our aim is to improve the performance of the supersponsor scheme, and this week we published 16 interventions following a review of the scheme. We want to empower those arriving with clear advice, support and improved access to longer-term housing options, thereby reducing dependency on short-term and temporary accommodation. That is why we have put in place up to £50 million for our Ukraine longer-term capital fund to increase the overall supply of housing stock. That has already provided more than £400,000 to North Ayrshire Council and £6 million to Aberdeen City Council.

**Mark Ruskell:** I have seen at first hand how communities and local authorities across my region, from Killin to Rosyth, are working tirelessly to try to find long-term housing solutions for displaced Ukrainians who have found sanctuary in Scotland. However, it is critically important that any housing offer empowers our new Ukrainian neighbours to have choices over their next steps.

I welcomed Tuesday's statement by the Minister with special responsibility for Refugees from Ukraine [see above], but will the cabinet secretary outline what further support will be made available specifically to local authorities such as Stirling Council to support the displaced Ukrainians to access that housing and also, critically, to co-ordinate efforts with local communities who have their own interests with regard to finding solutions for their Ukrainian neighbours and are engaged in their own efforts to do so?

**Reply from Shona Robison:** We have provided £11.2 million of funding to increase the capacity of local authority resettlement teams, to support the refurbishment of properties and to enhance the pace of host checks and matching. I encourage local authorities to ensure that they are making full use of that funding. We are encouraging all local authorities and registered social landlords to consider what properties in their area could be brought back into use, and I encourage Mark Ruskell to discuss that fund with local authorities in his region, in order to identify opportunities to make best use of the funding.

Mark Ruskell also made a very important point about the role of communities. The warm, welcoming response from communities throughout Scotland has been absolutely amazing. We want to encourage the continuation of that and we want solutions that are proposed by communities to be listened to and acted on where that is appropriate.

#### **Ukrainian Refugees (Killin Hotel)**

Alexander Stewart (Conservative): As the First Minister will be aware, refugees staying at the Killin hotel, which is in my region, were originally given four weeks' notice to quit when the Scottish Government cancelled its contract with the hotel, effective from 18 November. Since then, media interest and coverage of the plight of the refugees has resulted in what has been billed as a U-turn by the Scottish Government, which has said that it will work with the hotel to see whether the refugees can continue to stay while the Government assists them to find long-term, sustainable accommodation. However, despite the Scottish Government's reprieve, which was announced last week, neither the hotel, the local community council nor the Ukrainians have heard anything further. Many of the Ukrainians are unsure and anxious and have already resigned themselves to relocation. The situation is highly unacceptable and is causing severe distress to the individuals concerned. What action can be put in place to draw a line under the saga and give everybody the resolution that they deserve?

Reply from the First Minister (Nicola Sturgeon): It is our priority to ensure that

people who are displaced from Ukraine are looked after and well supported here. Figures that are out just today, I think, show that, since the conflict in Ukraine began, more than 21,500 people, most of whom are sponsored by the Scottish Government, have arrived here. That represents 20.8 per cent of all United Kingdom arrivals, which is testament to our desire and determination to support people from Ukraine as far as possible.

Many of the people staying at the Killin hotel wanted to move to a more central location with easier access to amenities and employment, and, by offering accommodation in Stirling, we seek to provide exactly that. We have of course listened to those Ukrainians who wanted to stay in the Killin area, such as those with employment or children in local schools, and we will help them to do that. We are working with Stirling Council and the local community to ensure that they are supported to find suitable alternative accommodation. We are aware that some of the Ukrainians will be able to stay at the hotel while they continue to be supported to find matched or longer-term accommodation.

We will continue to support everybody who has come here from Ukraine. Part of that is about supporting them out of temporary accommodation and into more settled accommodation as quickly as possible.

# **UK Parliament, House of Commons Written Answer: Rwanda Refugee Policy**

**Asylum: Correspondence** 

**Stephen Kinnock (Labour)** [74714] To ask the Secretary of State for the Home Department, what her Department's policy is on the criteria and process for when (a) a letter is sent to an asylum seeker informing that person that they are inadmissible for asylum under the Nationality and Border Act 2022 and (b) a letter is sent to an asylum seeker informing them that the Government intends to transport that person to Rwanda; whether those letters are sent at the same time or separately; and if she will make a statement.

**Reply from Robert Jenrick:** Inadmissibility guidance is published online and can be found at Inadmissibility: safe third country cases

Individuals are first served with a Notice of Intent which sets out that we may ask Rwanda to admit them, under the terms of the Migrations and Economic Development Partnership. Individuals have either 7 or 14 calendar days (depending

on their circumstances) to respond with reasons why their claims should not be treated as inadmissible.

Following that time period, decisions on inadmissibility and removal can be made. The general approach as set out in the "Removal Agreements and Timescales" section of the guidance is that inadmissibility decisions are served with removal decisions, however that is not a requirement.

### **Undocumented Migrants: English Channel**

**Luke Pollard (Labour)** [73133] To ask the Secretary of State for Defence, whether the Royal Navy will extend its role in tackling small boat crossings in the English Channel after January 2023.

**Reply from James Heappey:** Military primacy for managing small boat crossings of the Channel is scheduled to end on 31 January 2023, at which point responsibility will revert to the Home Office and Border Force. Any request to consider extending primacy would need to take into account the operational requirements and funding arrangements.

### Refugees: Afghanistan

**Sarah Olney (Liberal Democrat)** [73111] To ask the Secretary of State for the Home Department, how many Afghan refugees are awaiting housing resettlement following their entry into the UK through Government schemes.

**Reply from Robert Jenrick:** Through Operation Warm Welcome, Afghans resettling in the UK under the Afghan Relocations and Assistance Policy (ARAP) and Afghan Citizens Resettlement Scheme (ACRS) will be supported in accessing accommodation alongside the vital health, education, and support into employment they need, to fully integrate into society.

As stated in the recently published, 'Afghan Resettlement: Operational Data' factsheet, at 12 Aug 2022, the UK:

- Has welcomed 21,450 people to the UK from Afghanistan or a neighbouring country since June 2021.
- Is providing temporary accommodation for 9,667 people in hotels while they await settled accommodation.

The factsheet will be updated every quarter – with the next iteration scheduled for publication on 24 November 2022.

The Home Office will also include Afghan resettlement statistics in its <u>quarterly</u> <u>Immigration Statistics publications</u>, in due course.

### Refugees: Afghanistan

**Fleur Anderson (Labour)** [74942] To ask the Secretary of State for the Home Department, what steps she is taking with local authorities to move refugees from Afghanistan who have been in hotels for longer than year into alternative accommodation.

Reply from Robert Jenrick: There is a significant effort underway to support the families into permanent homes as soon as we can so they can settle and rebuild their lives. We remain committed to matching evacuees to suitable settled accommodation and continue to work collaboratively alongside around 350 local authorities, government departments and other partners to meet the demand for housing. In addition, many families have, in recent months, taken steps to secure their own accommodation through the Find Your Own Accommodation scheme which opened on 29 June and empowers Afghan families to source their own accommodation. We are also looking at ways to make more suitable homes available in the private rented sector, and exploring alternatives to hotels for families who may have to remain in bridging accommodation for long periods.

The length of time that a family will remain in bridging hotels is dependent on the availability of appropriate housing. The demographic complexity of the Afghan cohort, coupled with a shortage in supply of appropriate housing and reliance on local authorities to bring forth property pledges means that this remains challenging. We encourage families to accept appropriate properties as quickly as possible and urge local authorities to continue to do all they can to help house people.

### **Homes for Ukraine Scheme**

**Charlotte Nichols (Labour)** [69812] To ask the Secretary of State for Levelling Up, Housing and Communities, what his plans are for refugees currently being hosted under the Homes for Ukraine Scheme who have been living with their hosts for more than six months, whose hosts wish to withdraw from the scheme.

**Reply from Felicity Buchan:** We would like as many sponsors as possible to extend their sponsorship beyond six-months, but we understand not all sponsors will want to or will be able to, so we are providing guidance for those who cannot continue sponsoring. The guidance sets out a range of options available to Ukrainians and their hosts which are:

- Staying with the same host for an extended period beyond the six-months by mutual agreement.
- Finding a different host if the Ukrainian guest is unable to move into their own accommodation post the six-months sponsorship period.
- Getting support from the local council to find another host.
- Renting private accommodation and support available for this.
- · Moving into a different area of the UK.
- If none of the above is feasible, guests can contact their local councils for support.

# UK Parliament, House of Commons Written Answers: Other Immigration and Asylum

### **Undocumented Migrants: Albania**

**David Davis (Conservative)** [73789] To ask the Secretary of State for the Home Department, whether her Department considers Albania to be a safe country for the return of illegal migrants.

**Reply from Robert Jenrick:** Albanian Illegal migrants may claim they require international protection. The Home Office has designated Albania as 'generally safe' under Section 94 of the Nationality, Immigration and Asylum Act 2002. This means that asylum / human rights decision-makers presume an applicant will be safe on return unless the person can show that this does not apply in their particular case.

### **Asylum**

**Stephen Kinnock (Labour)** [74712] To ask the Secretary of State for the Home Department, whether a person who has arrived in the UK with the intention of seeking asylum is classified in government records as an asylum seeker in the event that the person has been deemed inadmissible under the Nationality and Borders Act 2022.

**Reply from Robert Jenrick:** The Home Office publishes data on asylum in the 'Immigration Statistics Quarterly Release'.

Data on asylum applications are published in table Asy\_D01 of the 'asylum and resettlement detailed datasets'. Data on cases considered under inadmissibility rules are published in table Asy\_09a of the 'asylum and resettlement summary tables'.

When an individual submits an asylum application, they are counted in Asy\_D01. If they are later deemed as inadmissible, this will be recorded in table Asy\_09, but they will not be removed from table Asy\_D01. A person is not considered on inadmissibility grounds if they have not submitted an asylum claim.

**Judith Cummins (Labour)** [73023] To ask the Secretary of State for the Home Department, what recent [findings] she has made of the average waiting time to process an asylum claim.

**Judith Cummins (Labour)** [73024] To ask the Secretary of State for the Home Department, what the average waiting time for an asylum interview is in England.

**Judith Cummins (Labour)** [73025] To ask the Secretary of State for the Home Department, what percentage of asylum cases are decided within (a) six months, (b) one year and (c) over one year.

**Reply from Robert Jenrick:** The Home Office is unable to state what the average waiting time is to process an asylum claim or how many asylum claimants were awaiting their asylum interview because this information is not held in a reportable format, not routinely published and could only be obtained at disproportionate cost. However, the Home Office does publish data on the number asylum claims awaiting an initial decision by duration and the numbers processed within six months, for main claimant only. This data can be found at Asy\_04 of the published Immigration Statistics and ASY\_02 of the published Transparency Data:

### **Asylum: Housing**

**Richard Thomson (SNP)** [74944] To ask the Secretary of State for the Home Department, how many places in accommodation alternative to Manston did she approve from (a) 6 to 11, (b) 12 to 18, (d) 19 to 25 and (e) 26 to 30 September 2022; when the first of those places was approved; and when the first place accommodated someone.

**Reply from Robert Jenrick:** The significant increase in dangerous journeys across the Channel is placing unprecedented strain on our asylum system.

We are committed to working closely with communities and stakeholders to ensure destitute asylum seekers are housed in safe, secure and suitable accommodation, and that they are treated with dignity, care and compassion while their asylum claim is considered. All appropriate options are being explored to ensure that suitable accommodation is secured as quickly as is necessary and hotels are one element. In the month of September 19 new hotel sites were brought into use providing additional bedspaces for over 2700 people

A breakdown of individual hotels, approvals, online and occupancy could only be provided at disproportionate cost.

# The following two questions both received the same answer Detention Centres: Manston

**Alison Thewliss (SNP)** [74738] To ask the Secretary of State for the Home Department, whether Manston Asylum Processing Centre is designated as a non-residential short term holding facility under the Short-term Holding Facility Rules 2018.

**Alison Thewliss (SNP)** [74741] To ask the Secretary of State for the Home Department, whether people detained at Manston Asylum Processing Centre have access to (a) their own mobile phone and (b) a public phone.

Reply from Robert Jenrick: Manston operates as a non-residential short-term holding facility. In order to operate as a short-term holding facility (STHF), a site does not need to be designated as one. The Immigration (Places of Detention) Direction 2021 sets out the places in which people can lawfully be detained, and included within that are STHFs (both non-residential and residential STHFs) as set out in paragraph 3(1)(c) of the Direction. Only immigration removal centres are designated individually by name.

Immigration (Places of Detention) Direction 2021

The STHF Rules 2018 apply by default to Manston, minus the specific disapplications/modifications for holding rooms set out in Rule 6 of the STHF Rules 2018 STHF-rules-operational-guidance-v1.0-EXT.pdf Rule 28 provides that individuals in STHFs must have access to a telephone to make calls, and the means to receive incoming telephone calls, which they must be notified of promptly. While their own mobile phones are securely stored with their property, the Home Office is ensuring that people held at Manston have access to mobile phones held by the contractors operating the facility.

### **Detention Centres: Manston**

Diana Johnson (Labour) [72951] To ask the Secretary of State for the Home Department,

what is the maximum amount of time an individual can legally be detained at the Manston immigration facility.

**Reply from Robert Jenrick:** Under the Short Term Holding Facility Rules 2018, someone may be held at Manston for up to 24 hours, or longer if authorised by the Secretary of State in exceptional circumstances.

**Luke Pollard (Labour Co-op)** [73134] To ask the Secretary of State for the Home Department, what personnel, from which agencies, are based at the Manston immigration facility.

**Reply from Robert Jenrick:** The Home Office does not routinely publish information relating to the number of staff working in specific locations as this would publicise operational practises which, in the wrong hands, could be used to attempt to evade controls at the border and compromise border security.

Medical services are delivered through two separate but complementary contracts with external suppliers. In total, there are 8 paramedical/medical trained staff on site by day, in a fully equipped medical centre. In addition, there are 3 Emergency Department Consultant doctors providing clinical cover at the site; a Consultant is on site during the day between 0800-2000hrs, with on-call cover provided overnight.

We currently have up to 900 staff involved in the landside small boat response which includes HO staff, Contractors (fulfilling security, detention custody, catering, medical, transport and facilities management tasks) and Military support.

The resource and staffing requirements are continually reviewed by the Home Office, working closely with contractors and stakeholders to deploy resources flexibly as and when they are required.

**Reply from Robert Jenrick:** Medical services are delivered at Manston and Western Jetfoil through two separate but complementary contracts with external suppliers. Currently, in total, there are eight paramedical/medical trained staff on site by day, in a fully equipped medical centre. In addition, there are three Emergency Department Consultant doctors providing clinical cover at the site; and a Consultant is on site during the day between 0800-2000hrs, with on-call cover provided overnight.

To date there have been 6 confirmed cases of Diphtheria at Manston. All suspected cases are isolated in line with public health guidance. Every confirmed case is referred to the UK Health Security Agency by the laboratory.

**Reply from Robert Jenrick:** The Manston Initial Triage and Processing Centre has been stood up as a critical infrastructure to enable criminal, identity and immigration background checks on migrants illegally crossing the Channel and collate their initial asylum claims away from the Port of Dover.

Accommodation on site is provided by a mix of existing barrack blocks converted for this purpose and marquees erected as emergency accommodation once the number of migrants crossing demanded the rapid expansion of capacity. Seven of these marquees are certified as holding rooms under the Short-Term Holding Facility rules.

There are no extant plans with the Local Authorities for the installation or building of any permanent structures on site. However, it is our aim to continuously improve the quality of accommodation to provide adequate response to the needs of those

crossing the channel.

A laundry service is provided by the contractors on site. Washing machines are available on site for use by families.

Food is provided for everyone being held at Manston. As the number of crossings has increased, resulting in longer stays whilst onward accommodation is sourced, the Home Office has continued to engage with contractors to ensure the food provision meets this changing need — including increasing the variety of food available and ensuring that it meets each individual's needs.

### **British Nationality: Assessments**

**Lord Rosser (Labour)** [HL2703] To ask His Majesty's Government, further to the Written Answer by Lord Sharpe of Epsom on 21 September (HL2244), what checks they made to ensure questions about the UK's membership in the EU and information about the EU was removed from all Life in the UK tests; what plans they made to ensure test applicants with third edition handbooks published between 28 January 2013 to 31 January 2020 are made aware this information is not tested; and what other information in the original test handbook published in January 2013 has been removed.

**Reply from Lord Murray of Blidworth:** PSI deliver the Life in the UK test on behalf of the Home Office. In September 2019 PSI conducted a review of all test material to identify any questions relating to the EU, and these were retired from all Life in the UK tests by 31st October 2019.

The Stationery Office (TSO) produce the Life in the UK handbooks and related study materials. A review was conducted of these materials to identify all references to the EU. An errata slip was produced to accompany handbook stock on sale from January 2020 which clarified the amendments and digital versions updated. In summer 2020 "Third edition. Twenty First impression 2020 (with amendments)" handbook was printed with identified references to the EU removed.

The Home Office works closely with TSO to ensure the handbook remains up to date and factually accurate.

### **British Nationality: Assessments**

**Lord Rosser (Labour)** [HL2705] To ask His Majesty's Government, further to the Written Answer by Lord Sharpe of Epsom on 21 September (HL2176), why the Home Office booklet AN: Naturalisation Booklet: The Requirements and the Process, published on 28 June, states that individuals must wait at least seven days between tests if this is not a formal requirement and only advisory; whether applicants were instructed they must wait

at least seven days since November 2005; and whether there are other requirements in that booklet stating what customers must do that is not required and only advisory.

Reply from Lord Murray of Blidworth: We amended Booklet AN in early September to show that a person "should", rather than "must" wait seven days before taking the test again. This is recommended to allow someone to reflect on areas they need to prepare better for or develop. The booklet sets out the statutory requirements that those applying for citizenship must meet. They must provide evidence of how they meet the requirements or, where that is not possible, give reasons why the Secretary of State might exercise discretion in their favour.

### **Sleeping Rough: Migrants**

**The Lord Bishop of** Durham [HL2720] To ask His Majesty's Government whether the 'exhaust all options' approach, as outlined in the Rough Sleeping Strategy, includes supporting individuals to have their No Recourse to Public Funds conditions lifted through a 'change of condition' application.

**Reply from Baroness Scott of Bybrook:** We recognise that rough sleepers with restricted eligibility for homelessness assistance, including individuals with a No Recourse to Public Funds (NRPF) condition, face particular challenges moving away from the streets. The Rough Sleeping Strategy committed to building on our expectation that local authorities exhaust all options to support this group.

This may include supporting individuals with leave under the family and human rights routes who are destitute, at risk of destitution, the welfare of their child is at risk due to their low income or there are other exceptional financial circumstances, to apply, for free, to have their NRPF condition lifted by making a 'change of conditions' application to the Home Office.

#### **Detention Centres**

**The Lord Bishop of Durham** [HL2721] To ask His Majesty's Government what is the estimated cost of reopening (1) the Campsfield House immigration removal centre in Kidlington, Oxfordshire, and (2) the Haslar immigration removal centre in Gosport, Hampshire.

Reply from Lord Murray of Blidworth: As set out in the Prior Information Notice published on 21 September, the current estimated operating costs for Campsfield and Haslar immigration removal centres (IRC) for the lifetime of the 8 year contract will be £170 million and £229 million respectively. In addition to the operating costs, there are also costs associated with the refurbishment and new build of the sites. The early cost estimates for Campsfield House IRC range between £90 and £100 million. The early cost estimates for Haslar IRC range between £150 and £160 million. These estimates exclude any potential inflation, optimism bias and contingency estimates. The actual costs will only be known once the contractors have been appointed, and more detailed designs are established, but the approach being taken will ensure that value for money is prioritised.

**Janet Daby (Labour)** [71269] To ask the Secretary of State for Health and Social Care, what plans she has to improve the uptake of vaccinations in (a) Black African and (b) Black Caribbean adults.

**Reply from Neil O'Brien:** We continue to work with the National Health Service to provide information on the benefits of COVID-19 and flu vaccination, targeted for specific communities where vaccination uptake is lower or has been falling. This includes information and advice via television, radio and social media and translated into 13 languages. We have also launched a nationwide communications campaign to encourage eligible members of the public to receive a COVID-19 booster and flu vaccination this autumn.

On 24 June 2021, NHS England published the COVID-19 vaccination toolkit to provide evidence-based guidance for increasing vaccination confidence and uptake within black African and black Caribbean communities. We continue to work with community and faith ambassadors and organisations to build trust within local communities.

**Stephen Timms (Labour)** [74492] To ask the Secretary of State for Business, Energy and Industrial Strategy, what plans he has to introduce obligatory pay gap reporting with respect to ethnic minority employees.

**Reply from Kevin Hollinrake:** The Government responded to the Commission on Race and Ethnic Disparities' report and recommendations with the "Inclusive Britain" report which was published in March 2022. In this report, Government set out that ethnicity pay reporting will be voluntary and we will not be legislating for mandatory ethnicity pay reporting at this stage.

### **Air Pollution: Ethnic Groups**

**Ruth Jones (Labour)** [69800] To ask the Secretary of State for Health and Social Care, what assessment he has made of the impact of toxic air pollution on the health and wellbeing of people from Black and minority ethnic backgrounds living in urban communities in England.

**Reply from Neil O'Brien:** The Committee on the Medical Effects of Air Pollutants (COMEAP), an expert committee of the Department of Health and Social Care (DHSC), published advice on the health evidence relevant to setting PM2.5 targets in 2021. It concluded that there is evidence to suggest that people from minority ethnic backgrounds are more highly exposed to air pollution, such as fine particulates (PM2.5) and nitrogen dioxide.

The UK Health Security Agency (UKHSA) was recently involved in a review of the association between air quality around schools and inequalities in England, finding that schools in areas with the highest background levels of PM2.5 had a significantly higher ethnic minority pupil proportion compared to schools in areas with the lowest background PM2.5, and were more likely to be near major roads.

**Florence Eshalomi (Labour)** [73165] To ask the Minister for the Cabinet Office, what is the (a) mean and (b) median salary for black civil servants.

**Reply from Jeremy Quin:** The mean annual salary for civil servants at grade 7 and above as of March 2022 was £64,730 in London and £60,000 outside London (including overseas).

As of March 2022, 2.5% of civil servants (with a reported ethnicity) at grade 7 and above reported their ethnicity as black.

The mean annual salary for civil servants who reported their ethnicity as black was £33,380, with the median at £31,060, as of March 2022.

The mean annual salary for senior civil servants working in London as of April 2021 was £88,420, with the median at £80,400. For those outside London (including overseas) the mean was £87,630 and the median was £81,450.

To monitor diversity, HMRC asks staff to voluntarily and confidentially record their ethnicity, disability, sexual orientation, religion or belief, gender identity, and carer details on their HR records. The information can be input or updated at any time (either on entry to the department or at any time during employment).

The recording of diversity information is not mandatory, but HMRC asks everyone to consider the importance of recording it for individuals and the Organisation. The information provided for black and ethnic minorities therefore comes with a caveat that it represents only those who have chosen to declare this.

Gordon MacDonald (SNP) [S6M-06603] Edinburgh Apologises for Past Participation in Slave Trade and Colonialism - That the Parliament welcomes the historic measure taken by the City of Edinburgh in apologising for its past participation in the slave trade and acknowledging its involvement in colonialism; believes that the apology, given on behalf of the city by the Lord Provost, is a necessary step in the collective pursuit for justice and equality; applauds the city for accepting the recommendation to apologise made by the Edinburgh Slavery and Colonialism Legacy Review Group, chaired by the Chancellor of Heriot-Watt University and Scotland's first black professor, Sir Geoff Palmer; considers that such an apology can help create a sense of place that is educated and introspective: understands what it sees as the pertinence of the apology in its current global context, in light of the Black Lives Matter movement and reported widespread calls for admittance of involvement in past injustices; agrees with the reported comments by Sir Geoff that "An apology doesn't buy bread but it gives another form of sustenance – it is about feeling that somebody has looked at something and recognised it was wrong"; notes what it sees as role of Edinburgh as an influential world capital whose decisions, it believes, will undoubtedly evoke further conversation as to how other cities can best address their own colonial history, and praises reports of the positive reception for this action by the people of Edinburgh.

I am not responsible for ministerial correspondence, but the right hon. Members he mentioned were written to in a ministerial capacity and I would have expected replies to have been provided. I am sure that the hon. Gentleman will continue to pursue the issue that he has raised. If he does not, he should please let me know. If he would like to drop me a line to tell me which Ministers have failed to reply, I will take that up in private.

**Valerie Vaz (Labour)** [72246] To ask the Secretary of State for Digital, Culture, Media and Sport, if she will make it her policy to ensure spending on repairs and renovations to listed places of worship are permanently exempt from VAT to enable conservation of heritage sites.

**Reply from Stuart Andrew:** The Government recognises that listed places of worship represent some of the nation's finest heritage, and that there are particular burdens to the upkeep of such spiritual architecture. The Government funded Listed Place of Worship Grant Scheme aims to support the works by giving grants that cover the VAT incurred in making repairs to listed buildings in use as places of

worship. This supports the effective conservation of these sites.

In 2012, my Department and the Treasury became joint funders, with annual funding increased up to £42 million per annum. I am pleased to confirm this amount of funding has been secured for the current spending period until 31st March 2025. Whilst the government cannot confirm this funding permanently, my officials remain in close contact with the sector and are aware of the ongoing need for support for this scheme.
