### **Scottish Parliament Written Answers**

### Schools: English as a Second Language

**Willie Rennie (Liberal Democrat)** [S6W-20900] To ask the Scottish Government how many pupils at Scottish schools currently speak English as a second language.

**Reply from Jenny Gilruth:** There are 66,265 pupils in publicly funded schools in Scotland with English as an additional language, based on the 2022 pupil census. Statistics on pupils with English as an additional language are published annually in the Pupil Census Supplementary Statistics, table 5.9.

#### **Ukrainian Refugees**

**Maggie Chapman (Green)** [S6W-21756] To ask the Scottish Government whether it will provide an update on the progress in developing future plans for supporting displaced people from Ukraine living in Scotland.

**Reply from Mary-Anne Somerville:** Today I am pleased to announce the launch of 'A Warm Scots Future' in partnership with the Convention of Scottish Local Authorities, and the Scottish Refugee Council.

The paper sets out the policy direction for the next phase of Scotland's response to the humanitarian crisis created by Russia's illegal invasion of Ukraine. This will help the Scottish Government, and its partners, to transition from an emergency response to a long-term and holistic approach that supports the integration of displaced people from Ukraine. This is in alignment with the New Scots approach, which aims to support integration from day one.

To aid this transition, five overarching and interlinked strategic priorities have been identified to guide the next phase of Scotland's Ukraine response. These are:

- 1. A trauma informed, holistic and rights-based approach to long-term integration, in line with the New Scots refugee integration strategy
- 2. Reduce reliance on welcome accommodation
- 3. Boost long-term, settled housing that leaves a legacy for Scotland
- 4. Pursue clarity on routes to settlement, family reunification and repatriation
- 5. Continued partnership and collaboration, ensuring good governance and recognising the lived experience of displaced people from Ukraine.

We will now work closely with partners to deliver against these strategic priorities, and ensure displaced people from Ukraine achieve the best outcomes possible as they build their lives in Scotland.

### **UK Parliament, House of Lords Written Answers**

### Immigration: EU Nationals

**Baroness Buscombe (Conservative)** [HL10093] To ask His Majesty's Government when they plan to introduce requirements to prevent non-resident EU citizens from remaining in the UK for longer than 90 days out of 180 days, without obtaining a visa valid for 6 months at their own expense.

**Reply from Lord Murray of Blidworth:** All visitors to the UK (including those from the EU) are permitted to come for up to 6 months, regardless of their nationality or whether they require a visa in advance of travelling to the UK.

Nationals of EU Member States do not currently require a visa to visit the UK.

#### **Migrants: Health Services**

**Baroness Garden of Frognal (Liberal Democrat)** [HL10103] To ask His Majesty's Government what assessment they have made of the impact on academic institutions in the UK of increasing the annual immigration health surcharge for overseas researchers from  $\pounds$ 624 to  $\pounds$ 1,035 for main applicants and to  $\pounds$ 776 for child dependents from this autumn in combination with an increase of 15 per cent in visa fees.

**Reply from Lord Murray of Blidworth:** The Government is preparing full economic impact assessments for the increases to the Immigration Health Surcharge (IHS) and the immigration and nationality fees. Regulations will be laid in Autumn to increase immigration and nationality fees and the IHS. The IHS rates have not increased since 2020, and the cost of providing public services has increased in that time. It is right that we keep the IHS level under review to ensure that it reflects the genuine cost to the NHS of providing healthcare to those who pay it.

#### **Migrant Workers: Visas**

**Lord Rosser (Labour)** [HL10280] To ask His Majesty's Government what caps are in place for work-related visas, and how they are enforced.

**Reply from Lord Murray of Blidworth:** The UK's Points Based system Skilled Worker and Temporary Worker routes are not capped, with the exception of the Seasonal Worker route which is specifically designed to support the UK horticulture sector. A sector in which growers typically require higher volumes of labour, for relatively short-term periods of time, in line with seasonal production peaks.

The Seasonal Worker route currently has 45,000 visas available. A further 10,000 places will be released if there is sufficient evidence of need, and contingent with improvements in worker welfare. A separate quota of 2,000 places is also available to support the poultry sector in the run up to Christmas. These allocations are divided amongst the licenced Scheme Operators, in line with published policy, and are managed via the Home Office's Sponsor Management System.

### **Migrant Workers: Visas**

**Baroness Randerson (Liberal Democrat)** [HL10196] To ask His Majesty's Government what assessment they have made of the number of applicants for Global Talent Visas, and the reasons for any shortfall in that number, and whether they intend to review associated policies which might deter applicants, such as increased health surcharges.

**Reply from Lord Murray of Blidworth:** The Global Talent route is for individuals recognised as leaders, or who have demonstrated promise to become leaders, in their field. It forms part of the wider offer for skilled workers.

Since its launch in 2020, the Global Talent route has seen a significant increase in applicants. In the year ending June 2023, there was a 76% rise (+1,679) in Global Talent visas to 3,901 grants, compared to the year ending June 2022. Applications across work routes, such as Skilled Worker, are at record highs.

As with all immigration routes, we keep the requirements under review. We continue to work closely with the Global Talent endorsing bodies, who assist in setting endorsement criteria by virtue of their position as the UK's leading experts in the scientific, digital technology, and arts and culture sectors.

Immigration Health Surcharge (IHS) rates have not increased since 2020, and the cost of providing public services has increased in that time. It is right that we keep the IHS level under review to ensure that it reflects the genuine cost to the NHS of providing healthcare to those who pay it.

**Lord Rosser (Labour)** [HL10281] To ask His Majesty's Government how many Rwandans have (1) applied for asylum, and (2) been granted asylum, in each year since 2010.

### Undocumented Migrants: Sahel

**Lord Patten (Conservative)** [HL10320] To ask His Majesty's Government what assessment they have made of the number of migrants who arrived in the UK via irregular routes from countries in the Sahel during the past 12 months.

**Reply from Lord Murray of Blidworth:** The Home Office publishes data on asylum applications and initial decisions, by nationality and year, in the Immigration System Statistics quarterly release on gov.uk. These statistics are published in tables Asy\_D01 and Asy\_D02 of the asylum & resettlement detailed datasets which can be downloaded via the table attached. The latest data relates to the end of June 2023.

### Asylum

**Lord German (Liberal Democrat)** [HL10145] To ask His Majesty's Government, further to the official statistics published by the Home Office Irregular migration to the UK, year ending June 2023, published on 24 August, which found that "small boat arrivals account for less than half (46 per cent) of the total number of people claiming asylum in the UK in the year ending June 2023", by what means the other 54 per cent of people seeking asylum arrived in the UK.

**Reply from Lord Murray of Blidworth:** The Home Office publishes data on small boat arrivals in the 'Irregular migration to the UK' release. Data on asylum applications from small boat arrivals on these applications can be found in table Irr\_D02 of the 'irregular migration detailed datasets'.

Other entry routes to the UK may include:

- arrival on a legal visa route, but where an individual subsequently finds that they are unable to return to their country of origin and have reason to claim asylum in the UK
- arrival through the common travel area without valid permission to enter
- arrival through other irregular routes including lorries or shipping containers
- arrival through regular routes using fraudulent documents

### Asylum: Gender

**Lord Scriven (Liberal Democrat)** [HL10117] To ask His Majesty's Government how many people who arrived in the UK by small boats in each of the last three years claimed asylum based on their (1) sexual orientation, or (2) gender identity; and of those, how many have been granted refugee status.

**Reply from Lord Murray of Blidworth:** The Home Office publishes data on small boat arrivals in the 'Irregular migration to the UK' release. Data on asylum

applications from small boat arrivals and initial decisions on these applications can be found in tables Irr\_D02 and Irr\_D03 respectively of the 'irregular migration detailed datasets'. Please note that information on the basis of the asylum claim (e.g. sexual orientation or gender identity) is not published.

Information on how to use the datasets can be found in the 'Notes' page of the workbooks. The latest data relate to the year ending June 2023.

Additionally, data on asylum claims on the basis of sexual orientation can be found in tables SOC\_00, SOC\_01 and SOC\_02 of the 'asylum and resettlement datasets', as part of the 'Immigration System Statistics Quarterly Release'. Please note that this data is not broken down by method of arrival to the UK (i.e. small boats). The latest data relate to 2022.

### **Undocumented Migrants: Children**

**The Lord Bishop of** Durham [HL10357] To ask His Majesty's Government when, if at all, they intend to publish the operational processes and circumstances in which the Home Office will use the 'vice versa' power of child transfer from local authority care under the Illegal Migration Act 2023.

**Reply from Lord Murray of Blidworth:** The Illegal Migration Act received Royal Assent on 20 July 2023. The Act seeks to ensure the only way to come to the UK for protection will be through safe and legal routes and will take power out of the hands of the criminal gangs and protect vulnerable people, including children.

In light of Mr Justice Chamberlain's High Court judgment of 27 July 2023 in ECPAT UK, R (On the Application Of) v Kent County Council & Anor [2023] EWHC 1953 (Admin), we are reflecting on our use of powers in the Illegal Migration Act relating to the accommodation and transfer of unaccompanied children. This includes the vice versa transfer power in Section 17. These powers have not yet been commenced; a decision will be made on this matter in due course.

We will continue to work with local authorities across the UK to ensure suitable local authority placements are provided for unaccompanied children, in line with their statutory duties.

### Asylum: Children

**Lord Scriven (Liberal Democrat)** [HL10118] To ask His Majesty's Government in the past two years how many children who have arrived in the UK unaccompanied and seeking asylum, who have had their age verified, and who have been placed in hotels provided by the Home Office while waiting to be placed with a local authority, were aged: (1) under 5 years, (2) 5 years old, (3) 6 years old, (4) 7 years old, (5) 8 years old, (6) 9 years old, (7) 10 years old, (8) 11 years old, (9) 12 years old, (10) 13 years old, (11) 14 years old, (12) 15 years old, and (13) 16 years old.

**Reply from Lord Murray of Blidworth:** We take the safety and welfare of those in our care, including unaccompanied asylum-seeking children, extremely seriously. Any unaccompanied child who enters the UK via small boat and claims to be under the age of 18 will go through an age assessment process, unless they are clearly

a child. Following an initial age determination which is undertaken by Home Office officials, anyone accepted as under 18 years old will be processed as a child. If officials cannot be sure a person is significantly over 18 years old, the Home Office will treat the person as a child pending further in-depth assessment.

We have robust safeguarding procedures in place to ensure all unaccompanied asylum-seeking children in hotels are as safe and supported as possible as we seek urgent placements with a local authority. No individuals, apart from the unaccompanied asylum-seeking children, are residing at any of the hotels ringfenced for children.

All individuals working directly with the young people accommodated at the hotels have Enhanced Disclosure and Barring Service checks, and all those working and operating on the hotel sites have DBS clearance. The Independent Chief Inspector of Borders and Immigration (ICIBI) found that the young people accommodated at the hotels unanimously reported feeling happy and safe.

The data requested cannot be provided as it comes from live operational databases that have not been quality assured.

#### Asylum: Children

**Lord Scriven (Liberal Democrat)** [HL10204] To ask His Majesty's Government what is the total cost per night, including the cost of safeguarding, of placing an unaccompanied child seeking asylum in a hotel while waiting for a local authority placement.

**Reply from Lord Murray of Blidworth:** The cost of accommodating unaccompanied asylum seeking children is subject to change depending on the numbers being accommodated. Accommodation costs are considered to be commercially confidential, therefore the Home Office does not publish this information. However, total expenditure on asylum is published in the Home Office Annual Report and Accounts, available at

#### Asylum: Children

**The Lord Bishop of Durham** [HL10226] To ask His Majesty's Government what plans they have, if any, for Home Office accommodation for unaccompanied asylum seeking children to be subject to regulation and inspection by Ofsted.

**Reply from Lord Murray of Blidworth:** The Government continues to take steps to support local authorities to provide timely placements to unaccompanied children through the National Transfer Scheme (NTS). We remain committed to working with the local authority sector to ensure the system continues to operate effectively and unaccompanied asylum-seeking children move out of Home Office hotels guickly in light of the ECPAT judgment in the High Court.

### Asylum: Children

**The Lord Bishop of Durham** [HL10222] To ask His Majesty's Government whether, in the instance a child is found after going missing from Home Office accommodation, they are initially returned to hotel accommodation or the care of the local authority.

**Reply from Lord Murray of Blidworth:** When a missing child is found, a referral to the local authority is made with a clear expectation that they are taken into local

authority care.

Hotel accommodation is a temporary means to accommodate the increased number of unaccompanied asylum-seeking children (UASC) arriving and is only ever a contingency option, not a long-term solution. Out of necessity we accommodated UASC on an emergency and temporary basis in hotels while placements with local authorities have been vigorously pursued.

Ending the use of hotels for UASC is an absolute priority and we will continue to work around the clock with councils to increase the number of care placements available.

### Asylum

**Lord German (Liberal Democrat)** [HL10146] To ask His Majesty's Government what assessment they have made of the impact on (1) refugees, and (2) local authorities, of starting the move-on period for refugees granted asylum at the point they receive notice of their asylum decision instead of when they receive their Biometric Residence Permit.

**Reply from Lord Murray of Blidworth:** An individual remains eligible for asylum support for a prescribed period from the day they are notified of the decision on their asylum claim. Where someone is given notice that their asylum claim has been granted, their appeal has been allowed or their asylum claim has been refused but they have been given leave to enter or remain, the prescribed period in legislation is 28 days. Individuals should make plans to move on from asylum support as quickly as possible. Migrant Help are available to provide 'Move On' support, which includes advice on accessing jobs, housing and benefits.

#### **Asylum: Applications**

**The Lord Bishop of Durham** [HL10224] To ask His Majesty's Government from what date asylum applications were first treated as withdrawn on the basis that the claimant failed to report or to inform the Home Office of a change of address.

**Reply from Lord Murray of Blidworth:** We do not currently publish data on the date asylum claims were first treated as withdrawn on the basis that the claimant failed to report or to inform the Home Office of a change of address. However, official statistics published by the Home Office are kept under review in line with the code of practice for statistics, taking into account a number of factors including user needs, as well as quality and availability of data.

Changes to the Immigration Rules were laid on 17 July 2023 and implemented on 7 August 2023 which included amending paragraph 333C to provide clarification on the circumstances in which an asylum claim can be treated as withdrawn.

The withdrawal of asylum claims is not a new process. It is a longstanding principle that claims that are explicitly or implicitly withdrawn will have their consideration discontinued. At each step of the asylum process, claimants are warned about the importance of complying with the asylum process and the prospect of withdrawal of their asylum claim should they fail to do so.

#### **Asylum: Employment**

Lord Stone of Blackheath (Non-affiliated) [HL10323] To ask His Majesty's Government what assessment they have made of the case for allowing asylum seekers to work and cover the cost of their own living expenses.

**Reply from Lord Murray of Blidworth:** There are no plans to change the existing policy, which allows asylum seekers to work if their claim has been outstanding for 12 months or more, through no fault of their own. It is important that our approach

distinguishes between those who need protection and those seeking to work here who should apply for a work visa under the Immigration Rules. Asylum seekers do not need to make perilous journeys in order to seek employment in the United Kingdom, and we are concerned such a change could be a further pull factor.

The Home Office has a legal obligation, as set out in the Immigration and Asylum Act 1999, to support asylum seekers (including any dependants) who would otherwise be destitute. This may include the provision of accommodation and/or subsistence support.

The level of the allowance given to those supported under 1999 Act is reviewed each year to ensure it covers asylum seekers' essential living needs.

### **Refugees: Housing and Universal Credit**

**The Lord Bishop of Durham** [HL10359] To ask His Majesty's Government what discussions have taken place among (1) the Home Office, (2) the Department for Work and Pensions, and (3) the Department for Levelling Up, Housing and Communities, on extending the move-on period for newly recognised refugees to at least 56 days, in line with the Homelessness Reduction Act 2017 and applications for Universal Credit.

**Reply from Lord Murray of Blidworth:** The Home Office only has a legal obligation to support someone until the end of the prescribed move-on period. Where someone is given notice that their asylum claim has been granted, their appeal has been allowed or their asylum claim has been refused but they have been given leave to enter or remain, the prescribed period is 28 days.

We are engaging the Department for Work and Pensions and the Department for Levelling Up, Housing and Communities on ensuring individuals can move on from asylum support as smoothly as possible.

**Liam McArthur (Liberal Democrat)** [S6W-21679] To ask the Scottish Government whether it plans to make regulations for the provisions in the Hate Crime and Public Order (Scotland) Act 2021 to come into force, and, if so, when.

**Reply from Siobhian Brown:** The Scottish Government continues to work closely with justice partners to ensure effective implementation of the Hate Crime and Public Order (Scotland) Act 2021 ('the Act'); we are working together towards a 1 April 2024 commencement date. This is to provide enough time to allow justice partners to complete a number of key IT change programmes and for the delivery of a robust package of training and guidance for police officers prior to commencement.

Our recently published Hate Crime Strategy for Scotland makes a number of commitments including ensuring improved support for victims, improving data and evidence and developing effective approaches to prevention. It will also support the implementation of the Act. A delivery plan, setting out our immediate and longer term activity, will be published later this year.

### Marriage and Funeral Celebrants

**Kevin Stewart (SNP)** [S6W-20924] To ask the Scottish Government whether it has any plans to allow people who are currently funeral celebrants to officiate at weddings.

**Reply from Siobhian Brown:** The current arrangements for religious and belief celebrants, and civil registrars, to solemnise marriage and register civil partnership allow couples to choose from a wide range of options for their ceremony to satisfy both the requirements of the law, and of any religion or belief.

These arrangements were broadened under the Marriage and Civil Partnership (Scotland) Act 2014 (the Act). Couples can now have their marriage solemnised by a celebrant from a belief body as an alternative to having a civil or a religious ceremony. Intended civil partners also have the same options as those who wish to marry.

The Policy Memorandum that accompanied the Marriage and Civil Partnership (Scotland) Bill in the Parliament set out the Government's reasons for rejecting the option of opening the solemnisation of marriage to celebrants with no link to a religious or belief body at paragraph 28.

This remains our position and we have no plans to change the law.
