**Kirsty Blackman (SNP) [13086]** To ask the Minister for the Cabinet Office, what recent assessment he has made of the compatibility of the Civil Service Code with the Safety of Rwanda (Asylum and Immigration) Bill.

**Reply from Alex Burghart:** On 17 January 2024, there was an exchange of letters between the Cabinet Office and the Home Office regarding the future implementation of the Safety of Rwanda (Asylum and Immigration) Bill which set

out draft guidance to the Civil Service.

**John Healey (Labour)** [12767] To ask the Secretary of State for Defence, how many Pashto and Dari language specialists have worked on the Afghan Relocations and Assistance Policy scheme in each month since April 2021.

**Reply from James Heapey:** Between October 2021 and January 2022 three Pashto and Dari language specialists worked on the Afghan Relocations and Assistance Policy (ARAP) scheme. Two have been working on the ARAP scheme since February 2022.

### Refugees: Afghanistan

**John Healey (Labour)** [12499] To ask the Secretary of State for the Home Department, how many ARAP applicants awaiting a decision are residing in UK hotels as of 30 January 2024.

**Reply from Tom Pursglove:** Relocation to the UK is only facilitated once ARAP eligibility status has been decided and entry clearance has been issued, therefore there are no ARAP applicants awaiting an immigration decision residing in UK hotels.

The UK has made an ambitious and generous commitment to resettle.

Afghans fleeing persecution and those who served the UK. The latest published Immigration system statistics - (www.gov.uk) show that (up to the end of September 2023) we have brought around 24,600 people to safety from Afghanistan and the region.

These statistics also show that:

- We have relocated 11,684 under the Afghan Relocations and Assistance Policy (ARAP); and
- 1,674 people were living in interim accommodation (i.e. hotels and serviced accommodation) during this period (though this number changes frequently, and most of those within interim have now moved into settled accommodation) as of September 2023.

ARAP arrivals correct as of around December 2023, and accommodation data, will be reflected in the next release of the Immigration Statistics, which is due around 22 February 2024.

## UK Parliament, House of Commons Written Answers: Other Immigration and Asylum

### Immigration Controls

**Dehenna Davison (Conservative)** [12688] To ask the Secretary of State for the Home Department, what steps his Department is taking to reduce net migration.

**Reply from Tom Pursglove:** The Government remains completely committed to reducing levels of legal migration. Our points-based immigration system allows us to control who comes to the UK to work, study and visit.

In May 2023, we took decisive action to tackle the substantial rise in the number of students bringing dependants to the UK. These reforms have now been implemented.

On 4 December, the Home Secretary announced a new package of measures to further reduce legal net migration. These include: limitations on family dependants being brought in by care workers and senior care workers; increasing the salary threshold for the Skilled Worker route; commissioning the Migration Advisory Committee to review the Shortage Occupation List and raising the minimum income requirement progressively over the next few years.

This package of measures, taken together with the measures the Government announced in May 2023 to restrict the number of overseas students able to bring dependants, means that around 300,000 people who were eligible to come to the UK last year would not be able to do so in future.

We keep all our immigration policies under review to ensure they best serve the UK and reflect the public's priorities, including filling skills gaps and growing the economy.

### Asylum

**John Hayes (Conservative)** [13239] To ask the Secretary of State for the Home Department, how many and what proportion of asylum seekers who were given the right to remain in the UK had had a previous application for the right to remain denied in each of the last five years.

**Reply from Tom Pursglove:** The Home Office publishes data on asylum in the '[Immigration System Statistics Quarterly Release](#)'. Data on the outcomes of asylum applications at initial decision is published in table Asy\_D02 of the [Asylum applications, decisions and resettlement](#) detailed dataset. Information on how to use the dataset can be found in the 'Notes' page of the workbook. The latest data relates to the year ending September 2023. Data up to December 2023 is due to be published on 29 February 2024.

### **Asylum: Employment**

**Deidre Brock (SNP)** [13049] To ask the Secretary of State for the Home Department, what assessment he has made of the potential impact of replacing the Shortage Occupation List with the Immigration Salary List on the number of asylum seekers who are eligible to work who are in employment.

**Reply from Tom Pursglove:** The Home Secretary has commissioned the independent Migration Advisory Committee (MAC) to carry out a rapid review of the new Immigration Salary List (ISL) in time for its implementation in the Spring Immigration Rules. The MAC is due to report on 23 February, at which point the Government will consider its recommendations carefully. We will keep the list under regular review and the MAC will carry out a fuller review later in the year.

The introduction of the ISL will not undermine our policy that asylum claims by an individual applying for permission to work must still be outstanding for 12 months or more and any resulting changes to the policy will be announced in due course.

### **Asylum: Catterick Garrison**

**Fleur Anderson (Labour)** [6669] To ask the Secretary of State for the Home Department, how many (a) asylum seekers and (b) refugees of which nationalities are housed at Catterick Garrison.

**Reply from Tom Pursglove:** There are no asylum seekers housed at Catterick Garrison. The Government is using MOD Service Family Accommodation including at Catterick Garrison to provide settled accommodation for Afghans who are eligible for relocation to the UK under the Afghan Relocation and Assistance Policy. We are continuing work on other uses for Catterick.

### **Asylum: Sexual Offences**

**John Hayes (Conservative)** [12900] To ask the Secretary of State for the Home Department, whether he is taking steps to ensure that asylum seekers convicted of sexual offences are not granted indefinite right to remain in the UK.

**Reply from Tom Pursglove:** The Nationality and Borders Act 2022 strengthened existing legislation to provide that anyone convicted of a particularly serious crime resulting in a custodial sentence of 12 months or more and are considered a danger to the UK, will be denied asylum and can be considered for removal from the UK. Settlement is a privilege, not an automatic right, and if a refugee has engaged in criminality, it is appropriate that they are denied the benefits of settlement.

## UK Parliament, House of Lords Written Answer: Afghanistan

### Afghanistan: Refugees

**Lord Sedwill (Crossbench)** [HL1899] To ask His Majesty's Government how many Afghans who were employees of NATO and the UN during 2001–21 have been admitted to the UK under the various Afghan resettlement programmes.

**Reply from Lord Ahmad of Wimbledon:** The UK has two Afghan resettlement schemes. The Afghan Relocations and Assistance Policy (ARAP) is for Afghan citizens who worked for or with the UK Government in Afghanistan in exposed or meaningful roles and is managed by the Ministry of Defence. The Afghan Citizens Resettlement Scheme (ACRS) prioritises those who assisted the UK efforts in Afghanistan and stood up for values, such as the rule of law, and vulnerable people. The Home Office are the responsible department for ACRS.

FCDO does not hold comprehensive data on who has been resettled under either scheme. We hold data on the first stage of Pathway 3 of ACRS where FCDO acted as the referral partner for Home Office for 3 cohorts - British Council contractors, Gardaworld contractors (Embassy guards) and Chevening alumni. We also hold data on some ARAP eligible persons that FCDO has sponsored because they worked for, alongside or under contract to DFID/FCO in roles contributing to UK national security objectives. We do not hold data on the number of former NATO and UN staff who have been resettled in the UK.

## UK Parliament, House of Lords Written Answers: Other Immigration and Asylum

### Asylum: Mental Health Services

**Baroness Lister of Burtersett (Labour)** [HL2168] To ask His Majesty's Government what steps they are taking to (1) monitor the mental health of residents, and ongoing safeguarding concerns, and (2) reduce the risk of further suicides, on the Bibby Stockholm and at MDP Wethersfield; and what assessment they have made of the findings of the report Ghettoised and traumatised: the experiences of men held in quasi-detention in Wethersfield, published by the Helen Bamber Foundation and Humans for Rights Network on 15 December 2023, and their implications for housing asylum seekers at MDP Wethersfield.

**Reply from Lord Sharpe of Epsom:** The welfare of asylum seekers is our utmost priority. The Home Office ensures that accommodation provided is adequate and meets the regulatory standards.

The Home Office assesses an individual's suitability to reside at the sites and only accommodates single adult males who are considered suitable to reside there. Guidance on the suitability criteria used can be found here: [Allocation of accommodation](#).

Each person's suitability is assessed at regular intervals and if they are no longer suitable for any reason, they will be moved to alternative accommodation.

The Home Office operates a Safeguarding Hub to support vulnerable individuals. Both the Home Office and its accommodation providers have robust processes in

place to ensure that where someone is at risk, they are referred to the appropriate statutory agencies of the police, NHS, and social services, to promote appropriate safeguarding interventions.

As well as making safeguarding referrals to the appropriate statutory agencies, other actions include attendance at adult protection meetings with the police and the Home Office liaise with external and internal partners to share information. The statutory agencies retain responsibility for all decisions on intervention activity.

All asylum seekers in the UK may contact Migrant Help 24 hours a day, 365 days a year if they need help, advice, or guidance. This includes raising issues relating to safeguarding.

### **Asylum: MOD Wethersfield**

**The Lord Bishop of Chelmsford** [HL2025] To ask His Majesty's Government what is the schedule for, and availability of, transport provided to residents of MDP Wethersfield to leave the site.

**Reply from Lord Sharpe of Epsom:** Those living at the site are able to come and go. The process for leaving the site is the same as the rest of our asylum accommodation.

To minimise the impact on the local services, and to ensure the orderly flow of people onto and off the site, a regular transport service is in place to take asylum seekers to larger local towns to access amenities and planned voluntary and community activities off-site.

This has been developed following consultation with key stakeholders in the Multi Agency Forum (MAF).

If off-site services are needed, transport services will be available by the Home Office's provider.

### **Asylum: MOD Wethersfield**

**The Lord Bishop of Chelmsford** [HL2026] To ask His Majesty's Government whether they intend to accommodate the planned maximum population of 1,700 asylum seekers at MDP Wethersfield, and if so, when.

**Reply from Lord Sharpe of Epsom:** The Home Office is using a phased approach; increasing the number of asylum seekers accommodated at the site over time, with the practicalities of managing the site under constant review. The site can accommodate 1,700 individuals when fully operational.

### UK Parliament, House of Commons Written Answers

#### **Maternity Services: Ethnic Groups**

**Theresa Villiers (Conservative)** [12958] To ask the Secretary of State for Health and Social Care, whether she has had recent discussions with NHS England on improving awareness of inequalities in black and Asian maternal health outcomes amongst clinicians.

**Reply from Maria Caulfield:** The Government is committed to tackling and reducing disparities in health outcomes. My Rt hon. Friend, the Secretary of State, has not had specific discussions with NHS England about improving clinician awareness. However, the Maternity Disparities Taskforce, of which I am a co-chair, was established in February 2022 to tackle disparities for mothers and babies and reduce maternal and neonatal deaths.

The taskforce brings together experts from across the health system, governmental departments, and the voluntary sector to explore and consider evidence-based interventions to tackle maternal disparities. One of the key priorities of the taskforce at present is focusing on improving access to effective pre-conception and maternity care for women from ethnic minorities, and those living in the most deprived areas.

NHS England has also published their Equity and Equality guidance for Local Maternity Systems, supported by a £6.8 million investment, which focuses on actions to reduce disparities for women and babies from ethnic minorities and those living in the most deprived areas.

#### **Maternity Services: Ethnic Groups**

**Theresa Villiers (Conservative)** [12960] To ask the Secretary of State for Health and Social Care, what steps she is taking to measure progress made by initiatives to tackle health inequalities in maternity care in the black and Asian community.

**Reply from Maria Caulfield:** NHS England's three-year delivery plan for maternity

and neonatal services outlines an ambition to reduce inequalities for all in access, experience, and outcomes, and provide targeted support where health inequalities exist. As part of this plan, NHS England will utilise several metrics to track the impact on maternity and neonatal outcomes based on ethnicity, to measure progress towards improving equity for mothers and babies. These metrics are of sufficient sensitivity and statistical power to track changes in clinical outcomes for the groups most at risk of adverse outcomes.

Ethnic coding data completeness has improved year on year since 2019, helping to better understand health outcomes for different ethnic groups. NHS Resolution's Maternity Incentive Scheme safety action two also sets a data quality standard to improve ethnic coding data completeness.

## Racism, Religious Hatred, and Discrimination

### UK Parliament, House of Commons Written Answer

#### **Transplant Surgery: Racial Discrimination**

**Jackie Doyle-Price (Conservative)** [11773] To ask the Secretary of State for Health and Social Care, what steps she is taking to help tackle racial inequalities in levels of organ transplantation.

**Reply from Andrea Leadsom:** Generally, patients from ethnic minority backgrounds on the transplant waiting list, wait longer than white patients for a transplant. For example, black patients wait six months longer for a kidney transplant than white patients. The best chance of a match is from an ethnically matched donor. Therefore, NHS Blood and Transplant (NHSBT) is focussed on sharing the benefits of transplantation more equally and increasing consent levels for organ donation amongst ethnic minority communities.

NHSBT raises awareness throughout the year, including during Organ Donation Week every September, with targeted social media, and press engagement. It also works with charities, community partners, celebrities, and influencers to amplify the need for donors from ethnic minority backgrounds. Since April 2023, NHSBT has invested £700,000 into 304 initiatives through the Community Grants Programme, targeting South Asian and black heritage communities, to align with clinical need.

NHSBT is looking at systems as well as training and diversifying the network of Specialist Nurses and implementing national organ offering schemes, which play a key role in targeting inequalities. But more progress is needed, and everyone can help by signing up to the Organ Donor Register.

#### Meat: Labelling

**Andrew Rosindell (Conservative)** [12604] To ask the Secretary of State for Environment, Food and Rural Affairs, whether his Department plans to undertake a consultation on the labelling of non-stun slaughter meat.

**Reply from Mark Spencer:** There are no Regulations that require the labelling of non-stun slaughter meat, but where any information of this nature is provided it must be accurate and must not be misleading to the consumer. The Government respects religious freedoms and expects the industry, whether food producer or food outlet, to provide consumers with all the information they need to make informed choices.

As recently announced by the Secretary of State, we will soon be launching a consultation on clearer food labelling. This will include proposals to improve and extend current mandatory method of production labelling, including options for the production standards behind them. Our proposed standards initially focus on the period of time the animal spends on farm. We will seek views through consultation on these standards, including the period of life which they should cover.
