# "Scotland's Future" Scottish Government White Paper on Independence: International Relations

On 18 September 2014 there will be a referendum in which voters will be asked the question, "Should Scotland be an independent country?", and the Scotlish Government has produced a White Paper to explain its proposals for the way in which an independent Scotland would be governed.

A White Paper is a document produced by the Government that sets out details of their proposed future policy on a particular subject. It is not a consultation and does not set out alternatives, but only gives details of the Government's intentions. This White Paper does not, therefore, provide an analysis of the advantages and disadvantages of Scotland becoming an independent country, and it does not discuss what should happen if Scotland remains in the UK.

# **Background**

At present, international relations are reserved, that is, the responsibility of the UK Parliament, so matters concerning Scotland's relations with other countries are decided in London, not in Scotland. However, the Scottish Government believes that UK Government foreign policies have not always reflected Scottish priorities. The White Paper proposes that if Scotland were to become an independent country, it would be able to negotiate bilateral agreements with other countries about trade and other matters, and would become an active member of the European Union, the United Nations, the Commonwealth, the World Trade Organisation, the World Bank, NATO, and other major multi-national organisations.

## **Passports**

The Scottish Government believes that, if Scotland were to become an independent country, Scottish citizens would not need a passport for travel to England, Wales, the Isle of Man and the Channel Islands, and the Republic of Ireland.

#### **Embassies**

The White Paper proposes that, if Scotland were to become an independent country, the Scotlish Government would establish a network of embassies, initially in 70-90 countries. In some cases, these embassies might share premises with the embassies of other countries, including the rest of the UK. The most important role of Scotlish Embassies would be to develop commercial opportunities for Scotland, but they would also engage with local governments, promote Scotlish culture, oversee Scotland's international development activities, and provide consular services to Scotlish citizens.

#### Scotland and the British Isles

The Scottish Government believes that independence would remove many of the tensions that currently exist between Scotland and the rest of the UK because of political differences over reserved matters such as welfare. However, it believes that Scotland's most important diplomatic relationships would continue to be with the rest of the UK and Ireland, and that independence would not affect many other relationships between Scotland and the rest of the UK, so that "the social union, made up of connections of family, history, culture and language, will have every opportunity to flourish and strengthen."

# Scotland and the European Union

Although the European Union (EU) does not have any standard membership procedures for countries that gain their independence from an existing EU member state, the Scottish Government believes that, since Scotland currently has membership as part of the UK, an independent Scotland would immediately become a member in its own right due to the principle of "continuity of effect".

The White Paper also proposes that, if Scotland were to become an independent country, it would not be part of the Eurozone, because the currency would continue to be the Pound Sterling, and that the Bank of England would continue to be the central bank for Scotland as well as the rest of the UK.

#### Scotland and the Rest of the World

The Scottish Government believes that independence would give Scotland a stronger voice on world affairs, and greater opportunities to develop trade and investment.

#### **International Aid and Development**

The Scottish Government proposes that, if Scotland were to become an independent country, it would:

- ensure that Scottish Government policies do no harm to developing countries, do not undermine international development aims, and, where possible, contribute to international development success:
- initially spend 0.7% of gross national income on international development, rising to 1% over time:
- work to ensure that Scottish export policies do not create "unjust" debt for developing countries, and support moves to establish Scotland as an international centre for debt arbitration;
- ensure that gender equality is enshrined in all of its development work.
