### **HMIE review gives BEMIS an “excellent” report**

A newly published HMIE review rates the impact made by BEMIS in local communities as “excellent”, and praises BEMIS for making a significant difference to the organisations it supports. Organisations contacted by HMIE expressed an extremely high rate of satisfaction, with 96.3% rating the overall service provided by BEMIS as good to excellent.

HMIE identified BEMIS’s strong commitment to inclusion and diversity as one of its key strengths. In addition to its work with established minority ethnic communities, BEMIS proactively seeks to engage with new, and hard-to-reach groups, “empowering communities [and] working towards an inclusive society by establishing structures which recognise diversity”.

## **HMIE review gives BEMIS an “excellent” report** (continued)

BEMIS is committed to ensuring that all minority communities are enabled to speak for themselves, rather than being spoken for by gatekeepers, and initiatives such as “MEMO” and “MEMO+” have encouraged minority communities to participate in consultations and external events, and led to a significant increase in consultation responses from minority ethnic communities.

This commitment to organisations speaking for themselves is also evidenced by the energy BEMIS devotes to capacity building, which ensures that local projects become self sustaining, and no longer require significant support from BEMIS staff.

The report also praises BEMIS’s highly committed board of directors and staff who bring with them an excellent range of professional skills and a clear understanding of their responsibilities. Together they work “to ensure that the diverse ethnic minorities voluntary sector and the communities that this sector represents are fully recognised and supported as a valued part of civic society and a multicultural Scotland.”
