### **Holyrood Petitions**

**e-Petition** by Jennifer Newman calling on the Scottish Parliament to urge the Scottish Government to review the Fresh Talent: Working in Scotland scheme with the Home Office to allow overseas students on the scheme to stay and work in Scotland for an extended period at the conclusion of their academic studies without the need for a work permit and, as a result, ensure greater benefits for all concerned given the amounts of public funding spent training such individuals.

## **Westminster Parliamentary Questions**

**Lord Hylton** asked Her Majesty's Government [HL1994]: Whether they will make it a requirement for obtaining a visa that men and women coming to the United Kingdom for the purposes of getting married should be at least 21 years old and able to speak and understand English.

**Reply from Lord West of Spithead:** Two consultation documents were published on 5 December 2007: one on proposals to tackle forced marriage, and the other on the proposal to introduce a pre-entry English language requirement for spouses. These consultations fulfil the promises made in our strategy "Securing the UK Border", published in March 2007, to consult on new arrangements for marriage visas.

We are proposing a range of measures to address the problem of forced marriage. One of these proposals is that the minimum age at which a person can sponsor a marriage partner from overseas should be raised from 18 to 21. The same minimum age would apply to the person being sponsored. The Government's strong view is that those who intend to come here to marry should have a knowledge of English. The consultation on the proposal to introduce a pre-entry English language requirement for spouses discusses the key issues around how a requirement of this nature might work in practice.

The consultation periods will run for 12 weeks and the final date for responses is 27 February 2008. The results of the consultations will be published shortly.

**David Davis** [191896]: To ask the Secretary of State for Justice how many of the 359 appeals against a notice of intent to deport between 1 August and 31 October 2006 were successful; on what grounds they were successful; and how many of those that were successful cited breach of Article 3 of the European Convention on Human Rights as a ground for appeal.

**Reply from Jack Straw:** Of the 359 oral appeal hearings against a notice of intent to deport held at the Asylum and Immigration Tribunal between 1 August and 31 October 2006, 70 were successful.

The grounds, and any specific articles of the European Convention on Human Rights, cited in any appeal which was successful could not be determined without examination of the individual files. This would incur disproportionate cost to the Tribunal.

## **Holyrood Debate**

#### Public Appointments (Draft Equalities Strategy)

**Keith Brown:** The motion calls on the Parliament to agree that the Standards, Procedures and Public Appointments Committee's report and the *Official Report* of today's debate form the Parliament's response to the consultation by the Commissioner for Public Appointments in Scotland on her draft equalities strategy.

On 21 November, the commissioner lodged with the Parliament an equalities consultation document entitled "Diversity Delivers" that included a draft equalities strategy. The Equal Opportunities Committee and my committee then took evidence from the commissioner.

The Standards, Procedures and Public Appointment Committee's report not only reflects our views on the draft strategy but takes into account those of the Equal Opportunities Committee. Broadly, we give the strategy a warm welcome.

The boards of public bodies play a vital role in ensuring that those bodies meet the needs of the communities they serve by delivering services effectively and efficiently, and their work can impact on all aspects of Scottish life. Although the committee recognises and commends the work that is undertaken by board members, it also recognises that, at present, board membership does not fully represent the diversity of Scottish society.

The draft strategy seeks to improve the diversity of applications for board membership by raising awareness of the value of public bodies and the role of board members, by ensuring that the public appointments process is encouraging, accessible and easy to use, and by supporting future board members through a range of development and education programmes.

The committee agrees that increasing diversity in board membership can only benefit boards' decision making. The strategy highlights evidence that groups that are more diverse in their skills and knowledge have more potential than less diverse groups to consider a greater range of perspectives and to generate more high-quality solutions to problems.

**Johann Lamont** (S3O-2530): To ask the Scottish Executive what steps it is taking to address inequalities in Scotland.

**Reply from Stewart Maxwell:** Our aim is to focus Government and public services on creating a more successful country, with opportunities for all Scotland to flourish. We are therefore committed to tackling the prejudice and discrimination that leads to inequality in Scottish society. We will do that by mainstreaming equality across all Scottish Government policies, practices and services to ensure that our activities meet the needs of all the people we serve. The requirements of the public sector equality duties for race, disability and gender will support us in that process.

We will continue to support and develop the capacity for equality communities and groups to engage with policy makers so that they can understand their needs and experiences, to inform public policy development and service provision. The provision of robust data and evidence will help us to deliver policies that understand the issues and help to address inequality.

We will raise awareness of equality issues and promote best practice in relation to challenging discriminatory attitudes. That is vital if we are to reduce inequalities and promote equality. We will provide support for activity that promotes equality and challenges unjust discrimination across all equality interests and we will work in partnership with a wide range of interests.

### **Parliamentary Questions**

**Lord Hylton** asked Her Majesty's Government [HL1993]: What preparations they are making for the coming into force later this year of the Forced Marriages (Civil Protection) Act 2007.

**Reply from Lord Hunt of Kings Heath:** The Government are working to implement the Act as speedily as possible. As the Government stated during the passage of the Bill, implementation of any legislation requires a significant programme of work. The programme of work includes the development of the necessary court rules and forms, the setting up of the appropriate court processing systems, guidance developed for staff and judicial training undertaken. The views of the public will also be taken into account and the Government have published a public consultation on who should be a relevant third party to forced marriage proceedings. The draft rules of court have also been published for consultation. The Ministry of Justice is working closely with other departments to decide the best ways in which to publicise the Forced Marriage (Civil Protection) Act 2007 to victims and potential victims of forced marriage when it comes into force in Autumn 2008.

Lord Lester of Herne Hill asked Her Majesty's Government[HL1934]: Whether they have received any representations as to elements of Sharia law which should be recognised in United Kingdom law; and, if so, what is their response to those representations; and

[HL1935] Whether they will extend to marriages under Sharia law the power contained in section 10A of the Matrimonial Causes Act 1973 to refuse a decree absolute if steps are not taken to dissolve a religious marriage.

**Reply from Lord Hunt of Kings Heath:** The Government have not received any representations. Sharia law has no jurisdiction in England and Wales. There are,

however, a number of Sharia councils in England and Wales which, on a private basis where the parties consent, deal with the mediation and resolution of personal and contractual disputes. These councils are not part of the court system. In all cases, parties will always have recourse to the national courts.

The Divorce (Religious Marriages) Act 2002, which amended the Matrimonial Causes Act 1973, allows a court to refuse a decree absolute until a religious divorce is granted. It applies to members of the Jewish faith or to any other prescribed religious group, including Islam. The option does, however, depend on the religious community itself deciding to make use of the provisions of the Act and then asking the Lord Chancellor to prescribe the religious group for that purpose. No application has been received from any Islamic group requesting such recognition.

**Harry Cohen** [189621]: To ask the Secretary of State for Justice what arrangements are in place for marriages in mosques to be performed in conjunction with the civil marriage law arrangements; what consideration has been given to requiring marriage registrars to attend the mosque to perform the civil marriage arrangements at the time of the religious ceremony; whether consideration has been given to placing mosque marriages on the same basis as church marriages; and if he will make a statement.

**Reply from Bridget Prentice:** The Marriage Act 1949 provides for mosques to be registered for the solemnisation of marriages according to the rites of the Muslim religion. The marriage should be solemnised in the registered mosque, in the presence of two or more witnesses, and in the presence of either a registrar of the registration district in which the building is registered, or a person who has been authorised to perform such ceremonies in that registered building. Such marriages are recognised in law without the need for a separate civil ceremony. Where a mosque has not been registered, a separate civil ceremony is necessary.

These same requirements apply to various other religious marriages, including Roman Catholic, Greek Orthodox, Hindu and Sikh. 785 buildings are recorded by the Registrar General (as at 26 February 2008) as certified places of meeting for religious worship by those professing the Muslim religion in England and Wales. Of those, 152 buildings are also registered for marriage, and of the 152, 36 buildings have authorised persons appointed to attend and register marriages.
