Holyrood Parliamentary Motions

S3M-1547 Shirley-Anne Somerville: Iranian Asylum Seekers Mehdi Kazemi and Pegah Emambakhsh—That the Parliament condemns the UK Home Office decision to reject asylum applications from Mehdi Kazemi and Pegah Emambakhsh, both Iranian nationals who fear persecution and execution on return to Tehran on the basis of their sexual orientation; notes with deep concern reports that Mehdi Kazemi's former boyfriend was arrested and executed for sodomy and that Ms Embambakhsh's partner was arrested and may face being stoned to death; expresses concern over increasing reports of growing repression in Iran and figures from Iranian human rights campaigners which state that over 4,000 lesbians and gay men have been executed since 1979, and calls on the UK Government to urgently review these cases and the guidance issued to immigration officers and to consider following the example of the Netherlands and Germany by imposing a moratorium on the deportation of gay and lesbian asylum seekers who fear that they will be persecuted in Iran.

Iain Smith (S3M-1571): Roman Catholic Support for Mehdi Kazemi and Pegah Emambakhsh—That the Parliament notes Pope John Paul II's encyclical, Evangelium Vitae, in which his late Holiness made clear that circumstances where the death penalty is acceptable are "very rare, if not practically nonexistent" and Pope Benedict's statement when he was Prefect of the Congregation for the Doctrine of the Faith that, in modern society, it is "practically impossible" to find any cases deserving of the death sentence; also notes that Mehdi Kazemi and Pegah Emambakhsh are at risk of being executed for their homosexuality if they are returned to Iran, and calls on the Roman Catholic Church to join the cross-party campaign for the Home Office to reverse its rejection of their asylum applications.

Westminster Ministerial Statement

Jacqui Smith (Secretary of State for the Home Department): The Government are committed to the swift establishment of a UK Border Agency (UKBA), which will bring together the work of the Border and Immigration Agency, UK Visas and parts of HM Revenue and Customs at the border. The new agency will work very closely with the police and other law enforcement agencies to improve border controls and security. We will shortly publish our detailed plans for the UKBA's first year of operation, but we are able today to announce key measures to ensure an immediate and seamless operation between the police and the new UKBA.

First, to strengthen effective police coordination at a strategic level I am announcing that chief constable Roger Baker of Essex police will join the UKBA board with immediate effect.

Secondly, to add to the 3,000 police permanently based at our borders 39 new specialists' posts at ports will be funded in 2008-09 to increase special branch coverage where it is most needed.

Thirdly, we will publish in April a new framework for inter-agency co-operation at the border. This can progress more quickly than further structural change either within the police service themselves or between the police and the UK Border Agency.

Fourthly, I can confirm that we will seek a new legislative basis and new powers for the UKBA as part of our immigration bill in the autumn.

Fifthly, the Government will be discussing with police forces and authorities whether change is necessary in the current regime for special funding of special branch posts at ports and airports with a view to implementing a new regime from 2009-10. The Government are also considering how to implement the conclusions of the independent report into airport policing, with the aim of clarifying the roles and responsibilities of the police, airport operators and other agencies to deliver a high level of security at UK airports and we will set out proposals on this later in the year.

Finally, in response to a recommendation in the Cabinet Office report "Security in a Global Hub—Establishing the UK's New Border Arrangements" published last November, the Home Office is working with the Association of Chief Police Officers for England, Wales and Northern Ireland to consider how policing—which is currently delivered by the local force for each port and airports—may best be organised to deliver a fuller level of integration at the border, taking into consideration the drive for greater collaboration which is at the heart of the Government's programme for improving protective services. There are various models.

The Home Office will also be discussing with the Scottish Devolved Administration and the Association of Chief Police Officers in Scotland ways of strengthening working relationships between the Scottish police service and the new agency taking into account the devolved nature of policing in Scotland.

Westminster Parliamentary Questions

Mike Hancock [190052]: To ask the Secretary of State for the Home Department if she will provide funding for *(a)* legal aid and *(b)* safe accommodation for women with undecided immigration status who are victims of domestic violence or abuse while their immigration status is being assessed.

Reply from Vernon Coaker: Victims of domestic violence with undecided immigration status are eligible to apply for legal aid. All cases are judged on individual circumstances and are measured against the criteria set out in the Legal Services Commission Funding Code.

Victims of domestic violence with undecided immigration status can also access services funded by the Supporting People grant, which provides support to vulnerable people in refuges, hostels and supported accommodation, or in their own home.

In addition, the Home Office announced on 6 March a new scheme where victims of domestic violence who have made successful applications for indefinite leave to remain, may qualify for a contribution towards their housing and living costs.

We recognise the need to find a permanent solution to this issue and are working across Government to achieve this.

Mike Hancock [190051]: To ask the Secretary of State for the Home Department what guidance she has provided to (*a*) local authorities and (*b*) voluntary agencies on women whose insecure immigration status is being assessed on the no recourse to public funds rule in the Domestic Violence, Crime and Victims Act 2004; if she will bring forward proposals to amend the Act to provide funding for such women; and if she will make a statement.

Reply from Vernon Coaker: In February 2006, guidance and a factsheet were issued to all local authority chief executives alerting them to the key issues experienced by these women and setting out how they can be helped through other legislative processes.

We have also commissioned the development of a step-by-step guide for women in black and minority ethnic communities who are victims of domestic violence. It will provide practical advice on how victims, and agencies supporting victims, can protect themselves and their children. This will be published in spring 2008.

Soon we will be announcing a new scheme where victims of domestic violence who have no recourse to public funds may be able to have their housing and living costs met linked to indefinite leave to remain (ILR) criteria. The proposals under the new scheme will strengthen the way in which domestic violence cases are considered enabling those victims who are vulnerable to access further support.

Michael Spicer [192007]: To ask the Secretary of State for the Home Department what her most recent estimate is of the number of failed asylum seekers in the United Kingdom.

Reply from Liam Byrne: No Government have ever been able to produce an accurate figure for the number of people who are in the country illegally and this includes failed asylum seekers. By its very nature it is impossible to quantify accurately and that remains the case.

Exit controls were phased out from 1994. As part of the Government's 10-point plan for delivery, by Christmas 2008 the majority of foreign nationals will be counted in and out of the country. This will build on the successes of our early testing of the e-Borders programme (Project Semaphore) which already covers over 30 million passenger movements and has led to 18,000 alerts and more than 1,500 arrests.

This is part of a sweeping programme of border protection which also includes the global roll-out of fingerprint visas, compulsory watch-list checks for all travellers from high-risk countries before they land in Britain and ID cards for foreign nationals.

David Davis [186929]: To ask the Secretary of State for the Home Department (1) what assessment she has made of the average cost to the public purse of deporting *(a)* an illegal immigrant and *(b)* a foreign prisoner with a recommendation for deportation in the last 12 months;

(2) [186930] how much has been spent on deporting (a) illegal immigrants and (b) foreign prisoners in each of the last five years for which figures are available.

Reply from Liam Byrne: The average cost of the removal of illegal immigrants and foreign prisoners is not disaggregated from the overall costs of the Border and Immigration Agency and therefore not readily available.

In 2007 we removed one person every eight minutes (over 63,000), including a record number of foreign prisoners (over 4,200).

Voluntary returns are always preferable but we will enforce returns where necessary. In doing so, we aim for the lowest available costs. The National Audit Office in 2005-06 estimated the average cost of an enforced removal as £11,000. The report can be accessed at:

We are committed to doubling our enforcement activity by 2010. This includes increasing the number of removals.

Lord Roberts of Llandudno asked Her Majesty's Government: Whether they will grant asylum to Mehdi Kazemi, who is threatened with execution should he be deported to Iran.

Reply from Lord Bassam of Brighton: My Lords, I cannot comment on the details of individual cases. However, I can assure the noble Lord that the United Kingdom Government are committed to providing protection for those individuals found to be genuinely in need, in accordance with our commitments under international law. Asylum applicants have access to the independent appeals process through the courts.

Lord Roberts of Llandudno: My Lords, I thank the Minister for his reply, but it is not quite as full as I would expect and hope. He will be aware that, since the ayatollahs came to reign in Iran, humanitarian organisations tell us that 4,000 lesbians and gay men have been executed in that country. What representations have Her Majesty's Government made and what representations do they continue to make about that policy? Secondly, will he assure us on behalf of the Government that no one, gay or otherwise, will be deported to any country where they will be persecuted, tortured or executed?

Reply from Lord Bassam of Brighton: My Lords, I have read with serious concern the human rights figures that the noble Lord refers to. The Foreign and Commonwealth Office regularly raises concerns with Iran in the context of individual cases, most often around methods of punishment used by that regime. Representations are also made through the EU, as this has been found to be the most effective way of making such representations. The Border and Immigration Agency enforces the return of Iranian gay men only when we are satisfied that they are not in need of protection. We do not seek to enforce returns to Iran unless our decision-making processes and the independent courts are satisfied that it is entirely safe to do so.

Education, Lifelong Learning and Culture Committee: Panjabi Language Examination

Karen Whitefield (Convener): The second and final item on our agenda is to consider correspondence that was sent to me, as the committee convener, by the Guru Nanak Sikh Temple in Glasgow with regard to the assessment of Panjabi language learning. It is not currently possible for students in Scotland to sit an examination in Panjabi as the funding that has enabled such examinations to take place for the past three years is no longer available.

Members will see from the briefing paper that we are asked to consider whether the committee should write to the SQA to seek its comments on the possible inclusion of Panjabi and other minority ethnic languages in the examination diet. I seek members' views on the matter.

Rob Gibson: I am happy for us to enter into dialogue on the matter because it is clear that many more languages are becoming prevalent. We need to get some sort of benchmark for the examination aspect.

Karen Whitefield In that case, we will write to the SQA. In light of our consideration of foreign languages a few weeks ago, and given the point that the deputy convener has just made about considering all languages, we could consider this issue again when we consider the other petition that was passed to the committee. However, we will write to the SQA about Panjabi language learning because that is what the organisation in question wants us to do.

Paul Goodman: To ask the Secretary of State for Communities and Local Government how much her Department plans to spend on *(a)* the provision of new Gypsy and Traveller sites and *(b)* the refurbishment of existing Gypsy and Traveller sites in (i) 2007-08, (ii) 2008-09, (iii) 2009-10 and (iv) 2010-11. [190110]

Reply from lain Wright: The Government makes Gypsy and Traveller Sites Grant available for the provision of new sites and refurbishment of existing sites. In 2007-08, £18.4 million has been approved for new sites or the extension of existing sites, £11.8 million has been approved for the refurbishment of existing sites (which in some cases may bring pitches back into use) and £3.7 million has been approved for schemes which include both refurbishment and extension. £33 million will be available for the grant in 2008-09, and £32 million in both 2009-10 and 2010-11.

Harry Cohen [192523]: To ask the Chancellor of the Exchequer pursuant to the Answer of 29 February 2008, *Official Report*, column 1985W, on marriage: Islam, how many marriages have taken place in each of the 152 buildings in the last 10 years; how many of those weddings have taken place in the presence of (*a*) a registrar of the registration district and (*b*) an authorised person for that building; what criteria he applies in deciding on applications for authorised person status; and how many people have applied for authorised person status and have been refused in that period.

Reply from Angela Eagle: The information requested falls within the responsibility of the National Statistician, who has been asked to reply.

Letter from Karen Dunnell, dated 10 March 2008:

As National Statistician and Registrar General for England and Wales I have been asked to reply to your recent Parliamentary Question pursuant to the Answer of 29th⁽⁾February 2008, Official Report, column 1985W, on marriage: Islam, how many marriages have taken place in each of the 152 buildings in the last 10 years; how many of those weddings have taken place in the presence of (a) a registrar of the registration district and (b) an authorised person for that building; what criteria he applies in deciding on applications for authorised person status; and how many people have applied for authorised person status and have been refused in that period. (192523)

Information on the numbers of marriages in England and Wales is published in the annual reference volume Series FM2 Marriage, Divorce and Adoption Statistics, available from the House of Commons library. However, figures for the number of marriages by building are not readily available.

Authorisation of a person to be present at the solemnisation of marriages in a registered building instead of a registrar are given by the trustees or governing body of the building. They may do so one year or more after the building has been registered by the Registrar General for the solemnisation of marriages. The criteria for authorisation are a matter for the trustees or governing body but the person must fulfil certain statutory obligations and duties in respect of the solemnisation and registration functions. The trustees or governing body certify on a prescribed form the name and address of the authorised person to the Registrar General and to the superintendent registrar of the registration district in which the building is situated.

This is not an application and there are therefore no refusals. Information prior to 2005 is not readily available but in each of the last three years, the number of authorised persons certified to the Registrar General has been:

2005. 1379, of which 1 was for a building registered for Muslim marriages 2006. 1636, of which 7 were for buildings registered for Muslim marriages

2007. 1057, of which 10 were for buildings registered for Muslim marriages

Margaret Moran: To ask the Secretary of State for the Home Department what plans she has to introduce accredited training in respect of people in the criminal justice system dealing with cases of forced marriage. [188273]

Reply from Tony McNulty: The Initial Police Learning and Development Programme administered by the National Policing Improvement Agency (NPIA) covers the police response to planned forced marriages, within the wider training material on domestic violence and child abuse.

Police officers also receive additional training on domestic violence and the NPIA are, in conjunction with the Crown Prosecution Service (CPS), currently considering the development of forced marriage and honour-based violence training, although its use by the police service is optional. There are no immediate plans to accredit this learning.

In July 2007, a pilot on forced marriage/so-called honour-based violence commenced in four CPS which will aim to establish information about the prevalence of forced marriage and to inform the development of any national guidance and training for prosecutors to improve these prosecutions and increase support for victims. A final report on the pilot is due in summer 2008.

In relation to the judiciary, a programme of work being planned prior to the implementation of the Forced Marriage (Civil Protection) Act 2007 will include the development of the necessary court rules and forms, the setting up of the appropriate court processing systems, guidance developed for staff and judicial training undertaken.
