Immigration: Migrant Integration Policy Index

Lord Dholakia asked Her Majesty's Government whether they will use the Migrant Integration Policy Index to inform debates on migrants in Europe.

The noble Lord said: First, I thank the British Council for its work on the migrant integration policy index. My thanks also go to the Migrant Policy Group in Brussels, which co-ordinated the contents of the research that provides the basis of my contribution today. The debate comes at a crucial time, with the Prime Minister and the President of France today discussing the issue of immigration. Only this morning we saw a most disturbing report on the treatment of asylum seekers in this country.

MIPEX uses indicators to compare the legal provisions across Europe to promote the integration of non-European Union migrants. This is a timely measure. There is often a confused debate in this country about a cohesive society, particularly when issues of multi-ethnicity and multi-culturalism surface. There is a kind of schizophrenia on matters of immigration on the one hand and community cohesion and a pluralist society on the other. The progress that we have made in achieving some sort of multi-culturalism is too valuable to be played in a cynical manner. This is often backed up by a perception of the majority population that, despite all our history and all our pride in tolerance, the majority is somehow not able to live as part of a community of communities.

Holyrood Debate (continued)

Some of us have spent a lifetime of work in the field of race relations. The United Kingdom has been at the forefront of legislation and other machinery to establish equality of opportunity for all our citizens. There is now a strong emphasis on race, disability, gender, age, faith and sexual orientation. The law puts a new emphasis on promoting good relations between people of different groups. It is clear that bench-marking is commonly used in the private sector and particularly in the field of justice, security and freedom; however, the exercise remains a relatively new phenomenon for immigrant integration. It is here that MIPEX provides a constant and reliable stocktaking with the ability to track policy advances and reversals.

Let me at the outset avoid the confusion about migrants. We are talking about—MIPEX uses the term in this way—third country nationals legally residing in an EU member state. It covers six policy areas which shape a migrant's journey to full citizenship. I am delighted that the debate in the UK has moved to citizenship. The six policy areas that are covered by MIPEX are labour market access, family reunion, long-term residence, principal participation, access to nationality and anti-discrimination.

Westminster Parliamentary Questions

Jim Cunningham: To ask the Secretary of State for the Home Department what steps the Government plan to take to stop employers employing illegal immigrants. [194133]

Reply from Liam Byrne: The Border and Immigration Agency is increasing enforcement activity against illegal working in general. Steps have been taken to strengthen the law preventing employers from using illegal migrant workers. The law in this area applies to employers or agencies in all sectors of the economy.

The Immigration Asylum and Nationality Act 2006 introduced a system of civil penalties for careless employers and a criminal offence of knowingly employing illegal workers. This came into force on 29 February 2008.

The maximum level of civil penalty is £10,000 and the criminal offence of knowingly employing an illegal migrant will attract a prison term of up to two years as well as an unlimited fine on conviction on indictment.

Lord Hylton asked Her Majesty's Government [HL2502]: What is their response to the comments by the Children's Society and the Refugee Council about the Border and Immigration Agency's Clan Ebor project for unsuccessful asylum applicants; and what action they will take as a result.

Reply from Lord West of Spithead: The aim of the project was to encourage the voluntary departure of families whose asylum applications had been refused and had exhausted all their appeal rights. The views of stakeholders, including the Children's Society and the Refugee Council, were taken into account in the course of the project and some changes made to the process as a result. The project has now ended, although we continue to work with stakeholders to identify how we can better promote voluntary return for all asylum applicants whose applications have been refused and have no lawful basis on which to remain in this country.

Kerry McCarthy [195557]: To ask the Secretary of State for the Home Department if she will permit the fee for applying for indefinite leave to remain to be paid in instalments in exceptional circumstances.

Reply from LiamByrne: Under the Fees Regulations, there are no circumstances in which the fee for a valid application for indefinite leave can be paid for in instalments.

Kerry McCarthy [195558]: To ask the Secretary of State for the Home Department if she will waive the requirement to pay the fee to apply for indefinite leave to remain in (*a*) cases where someone was brought to the UK from a Commonwealth country as a child prior to 1981 but whose parents omitted to apply on their behalf for nationality and (*b*) other exceptional cases.

Reply from Liam Byrne: We currently have no plans to waive the fee for application for indefinite leave to remain in cases where someone was brought to the UK from a commonwealth country as a child prior to 1981 or in other exceptional circumstances.

Lord Hylton asked Her Majesty's Government: Whether they will provide an independent review system for immigration and asylum detainees who have been held for three months or more.

Reply from Lord West of Spithead: My Lords, we have no plans to introduce an independent review system. The detention of individuals under Immigration Act powers is kept under regular review at successively higher levels in the Border and Immigration Agency. We have no interest in detaining individuals for longer than is strictly necessary or in prolonging their detention unduly.

Lord Hylton: My Lords, I thank the Minister for his reply, which I have heard a good many times before. In view of the present situation, will the Government abolish the detained fast track? Will they ensure that legal advice is available to all detainees? Will they undertake not to detain former convicted criminals with innocent asylum seekers and others?

Reply from Lord West of Spithead: My Lords, as the noble Lord will be aware, people in detention centres have access to legal advice for which they do not have to pay. I will take away the thought whether those who have committed crimes and are then being removed from the country should not be kept in the same immigration centres as other asylum seekers. In practical terms it would be extremely difficult, but I will see whether there is any possibility of it.

The Earl of Onslow: My Lords, will the Minister undertake not to return cancer victims to die in their countries of origin, which happened recently and was a disgrace to this country?

Reply from Lord West of Spithead: My Lords, I do not think I can give such a commitment. I have visited Tinsley House. It is worth remembering that all these cases are individual tragedies because, for a number of reasons, these people are desperate to be in this country. As the noble Lord, Lord Hylton, said, some of them have committed crimes here and are on their way out. I am afraid that we cannot offer healthcare to individuals with no legal right to remain in the United Kingdom. That is clearly covered in EU and our own law.

However, we make absolutely certain that they are able to get treatment back in their own country. It might not be as good as it is here, but we cannot open our doors and say that anyone who comes here and says that he cannot get the same treatment in his own country should be allowed to stay. That is not a sensible policy.

Lord Dubs: My Lords, my noble friend will be aware of the concern that has been expressed about the detention of children. How many children are now detained under these powers?

Reply from Lord West of Spithead: My Lords, my noble friend raises an important point. We do not put any children who are on their own into detention centres. The only ones who ever go there are with families, and normally it is just before the point of removal. As of today, 19 families with children, and 30 children in total, are detained.

Lord Laird asked Her Majesty's Government [HL2519]: What the status of British subject means; when it was introduced; and in what way it differs from British citizen status.

Reply from Lord West of Spithead: The term "British subject" has been in use since the 18th century.

Within the British Nationality Act 1981, the current nationality legislation, the term "British subject" applies only to two groups: (a) persons who derive the status by reason of a connection with the Republic of Ireland before 1949 and who have claimed the right to remain British subjects; (b) certain persons closely connected with the former British India who have not acquired any alternative citizenship.

British subjects can hold a United Kingdom passport and seek consular protection, in the same way as other British nationals. All British citizens have the right of abode in the United Kingdom, but only certain British subjects (those with a United Kingdom born parent or who were married before 1 January 1983 to a citizen of the United Kingdom and Colonies). For EC purposes only those British subjects with a right of abode under the Immigration Act 1971 are classed as United Kingdom nationals and are thus entitled to free movement rights.

British subjects are entitled to be registered as British citizens, subject to their meeting a number of residence requirements.

Lord Laird asked Her Majesty's Government [HL2629]: Under what circumstances someone outside the United Kingdom whose father was a British subject and who is now married and lives in the United Kingdom can obtain British citizenship.

Reply from Lord West of Spithead: The provisions for the acquisition of British citizenship are contained in the British Nationality Act 1981. Whether a person will qualify for British citizenship depends on various factors, including the person's current nationality status and length of residence in the United Kingdom.

For example, a person may be entitled to be registered as a British citizen if he or she holds a form of British nationality and has lived in the United Kingdom lawfully for five years, or has no other nationality; was born stateless and has remained stateless.

Immigration and Asylum Westminster Parliamentary Questions (continued)

Those who wish to acquire British citizenship but are not eligible for registration may apply for naturalisation at the Home Secretary's discretion if they can meet certain residence and other requirements set out in the 1981 Act. Those who are married to a British citizen must be of good character and have a satisfactory knowledge of the English language and life in the United Kingdom. They must also have lived lawfully in the United Kingdom, without long absences, for at least three years and be free from immigration conditions by the time they apply.

Terminal Illness (Patient Choice)

Jeremy Purvis: I am very supportive of the work of the palliative care movement in Scotland. I represent a constituency that has no hospice institution and relies heavily on the outstanding and caring work of the community palliative care staff under the consultant Dr David Jeffrey, for whom I have great regard. However, there are some people who are coming to the end of a terminal illness for whom the best palliative care available is not sufficient. They want greater control over the precise arrangements of their death. There is a choice gap in relation to allowing people to die at home for example. Marie Curie Cancer Care used that term in highlighting that, although 75 per cent of people say that if they had a terminal illness they would wish to die at home, only 25 per cent are likely to achieve their wish. A small number of those patients who wish to die at home would wish to have a greater say, when they are at the end of their life, over the precise circumstances of the timing of their death.

I wish to clarify my position. I do not propose euthanasia. I am not proposing a change in the law that will affect children. I am not proposing a change in the law that will affect all adults. My proposals concern not the elderly, the infirm or the depressed; they concern mentally competent adults with a terminal illness.

Although I acknowledge that the term is "physician-assisted suicide", the emphasis is not on a debate about suicide, in so far as that involves an individual choosing whether to live or die; rather, it is on situations in which an individual

has been informed by two doctors that they have a terminal illness and the issue is how and when they die, rather than if.

Ministerial Speech

The politics of identity (speech by Justice Minister Michael Wills)

Since James Carville wrote it over every desk in Bill Clinton's first presidential campaign, 'It's the economy stupid' has framed political discourse on both sides of the Atlantic. But this morning, I'm going to suggest that it's time that 'Who do you think you are?' was posted up alongside it.

This morning, I want to explore the importance of identity for politics - how it helps determine how voters vote and how a shared sense of national identity creates the framework for our democracy. And I want to suggest how important a shared sense of national identity is in meeting the challenges that lie ahead for our nation. I'm then going to reveal the latest poll evidence about who we actually think we are. And I'm then going to conclude by setting out what I see as the implications for government. And then, most importantly, I'm going to welcome your questions and comments.

It may seem perverse to focus on the importance of identity when for at least 20 years general elections have turned on practical issues of public policy - defence in the 1980s, public services more recently and the economy throughout. And, of course, politics is instrumentalist, of course voters see it as a means to an end and their assessment of what's in it for them, who'll manage the economy best, deliver most jobs, highest living standards, lowest mortgage rates, the best NHS and schools, all help determine general elections. But voting is not simply a consumer transaction. It's also an expression of identity.

In the twentieth century, identity politics, conceptualised as such, spoke the language of insurgency, challenging the conventional organisation of politics around belief or programme, or party as an umbrella for belief and programme, organising instead around a shared identity - usually one expressed as being oppressed and exploited.

Parliamentary Questions

Lord Lester of Herne Hill asked Her Majesty's Government [HL2432]: Whether the guidance given under Section 63Q of the Family Law Act 1996 (as inserted by the Forced Marriage (Civil Protection) Act 2007) will be more robust than that currently issued by the Forced Marriage Unit, especially in relation to education authorities ensuring that publicity is given in schools to the help available for pupils at risk of being forced into a marriage.

Reply from Lord Malloch-Brown: The existing guidance for education professionals, issued by the Forced Marriage Unit and the Department for Education and Skills in 2005, says that educational establishments should aim to create an environment where forced marriage is discussed openly. The guidance suggests ways this can be done. We will revise the existing guidance issued by the Forced Marriage Unit in light of the provisions of the Forced Marriage (Civil Protection) Act 2007. Guidance relating to education will be subject to a period of public consultation before being issued on a statutory footing in the autumn—which will make more robust the requirement to implement the guidance. In revising the guidance we will aim to clarify further what should be done to raise awareness of the issue of forced marriage with children and young people and to publicise the help available to those at risk.

Lord Lester of Herne Hill asked Her Majesty's Government [HL2433]: Whether they will consult about the guidance to be given under Section 63Q of the Family Law Act 1996 (as inserted by the Forced Marriage (Civil Protection) Act 2007) on (a) the effect of the relevant provisions of the Act; and (b) other matters relating to forced marriages.

Reply from Lord Malloch-Brown: Some or all of the revised guidance will be subject to a period of public consultation before being issued. The exact details have yet to be decided.

Lord Lester of Herne Hill asked Her Majesty's Government [HL2434]: Whether they intend to increase the financial and other resources available to the Forced Marriage Unit to give effective protection to the victims or potential victims of forced marriages.

Reply from Lord Malloch-Brown: The Government are fully committed to tackling forced marriage. The Forced Marriage Unit leads this work, and other government departments are also playing a key role in helping develop policy, raising awareness and providing support and advice to victims. The work of the Forced Marriage Unit is continually evolving, hence the resources needed by the unit are kept under review.

Lord Lester of Herne Hill asked Her Majesty's Government [HL2435]: Whether they will review the extent to which the guidance given by the Forced Marriage Unit to healthcare professionals and education authorities is followed in practice.

Reply from Lord Malloch-Brown: The Forced Marriage Unit, jointly with the government departments, has issued guidance for relevant education professionals, health professionals, social workers and police officers. This guidance is being revised and will be reissued on a statutory footing. The Forced Marriage (Civil Protection) Act 2007 makes it clear that a person exercising public functions to whom guidance is given under the Act must have regard to it in the exercise of those functions. We would expect bodies that inspect and/or regulate healthcare professionals and education authorities to check that such responsibilities are being met. In the case of education, the Office for Standards in Education already makes a judgment on safeguarding and we would expect compliance with relevant statutory guidance to be considered in reaching that judgment. Should the Forced Marriage Unit become aware of any organisation not following the statutory guidance it will of course raise this with the relevant authority.

Lord Lester of Herne Hill asked Her Majesty's Government [HL2436]: What financial and staff resources are provided to the Forced Marriage Unit for its work in tackling problems related to forced marriages (a) in the United Kingdom, and (b) overseas; and what resources will be available when the Forced Marriage (Civil Protection) Act 2007 comes fully into force.

Reply from Lord Malloch-Brown: The Government are fully committed to tackling forced marriage. The Forced Marriage Unit leads this work, but the response should not be seen just in terms of the work it does. Other government departments play a key role in helping develop policy, raising awareness and providing support and advice to victims. Staff based in our embassies overseas also make a vital contribution to our response. The Forced Marriage Unit has six members of staff, drawn from the Foreign and Commonwealth Office, Home Office and UK visas. For the 2007-08 financial year, the unit's non-casework project budget was £167,000. All staff in the unit work on domestic and international aspects of forced marriage. Resource needs are kept under review, but we do not anticipate needing a significant increase in resources as a result of the Forced Marriage (Civil Protection) Act 2007.
