Modern Slavery

The Secretary of State for the Home Department (Mrs Theresa May): Modern slavery is a brutal crime which knows no boundaries and does not discriminate on gender, age, creed, culture or race. Traffickers and slave masters exploit whatever means they have at their disposal to coerce, deceive and force individuals into a life of abuse, servitude and inhumane treatment. This is simply unacceptable in modern day Britain. We will not, and cannot let this continue.

That is why I have set up a new modern slavery unit in the Home Office, and it will be responsible for ensuring that we tackle this problem from every angle, while always keeping the plight of victims at the very heart of our policies and everything we do.

Today, I have published a White Paper which includes a draft Modern Slavery Bill (CM 8770) to strengthen our response and reduce the number of victims of this abhorrent crime. This flagship Bill will be the first of its kind in Europe, and sends a strong message, both domestically and internationally, that the UK is determined to put an end to modern slavery.

The Bill will simplify legislation, toughen sentences for slave drivers, and enable the courts to restrict activity where individuals may be at risk. This will mean that more traffickers are pursued, disrupted and brought to justice. The Bill will also create an Anti-Slavery Commissioner who will galvanise law-enforcement's efforts to tackle modern slavery.

We have already asked the right hon. Member for Birkenhead (Mr Field) to lead a series of evidence sessions. The draft Bill will now be subject to pre-legislative scrutiny and copies will be available from the Vote Office. Both the Member for Birkenhead's report and the Joint Committee's report will inform development of the final Bill and an action plan which will be published in the spring.

UK Parliament Questions

NHS: Foreign Workers

Tony Cunningham: To ask the Secretary of State for Health what assessment he has made of the effect of migrant health workers from developing countries working in the National Health Service. [180357]

Reply from Daniel Poulter: The Department is not able to make an assessment as the number of migrant health workers from developing countries is not collected centrally.

Although in earlier years the national health service relied quite heavily on recruiting staff overseas, efforts to recruit, train and retain staff in this country have paid off in recent years. The NHS now has many more health care professionals, and is much closer to self-sufficiency—in line with World Health Organisation recommendations.

However, given the size and complexity of the NHS it is likely that it will still need to recruit some doctors (and other skilled staff) from overseas to fill gaps in service provision.

The United Kingdom has signed the World Health Organisation Code of Practice on the International Recruitment of Health Personnel and the UK was a member/donor of the Global Health Workforce Alliance.

NHS organisations are strongly advised to adhere to the Code of Practice in all matters concerning the international recruitment of health care professionals across all disciplines—including the appointment of medical staff, nurses, dentists,

radiographers, physio- therapists, occupational therapists and all other allied health professionals.

Lord Roberts of Llandudno: To ask Her Majesty's Government what were the total number of (1) successful, (2) unsuccessful, and (3) dropped appeals against refusals of non-European Economic Area spouse entry clearance and further leave applications lodged in (a) 2011, and (b) 2012.[HL3760]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The requested figures are shown in the following tables:

Immigration

Lord Avebury: To ask Her Majesty's Government what are the average and maximum times taken to process applications for indefinite leave to remain in the United Kingdom; what is the average time taken to process 95 per cent of such applications; and whether they plan to prioritise applications from people who are stateless.[HL3744]

Reply from Lord Taylor of Holbeach: For postal Indefinite Leave to Remain (ILR) applications dispatched between 1st July 2012 and 30th June 2013:

- Average time to conclusion was 91 days.
- Average time taken to conclude 95 per cent of applications was 66 days.

In relation to maximum time taken to process applications for ILR, this will depend on the complexity of the application type. As at 12 December 2013, for the most complex work stream, Settlement Other (SET O) cases, casework teams are working on ILR applications submitted a maximum of 206 days earlier.

There are currently no plans to prioritise applications purely on the grounds that an individual may be stateless.

EU: Migration

Lord Roberts of Llandudno: To ask Her Majesty's Government what arrangements are in place to monitor and count migrants from European Union member states, in particular Bulgaria and Romania, who enter the United Kingdom after 1 January 2014.[HL4097]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The first national data release which will provide information on Romanian and Bulgarian nationals in employment in the UK after the lifting of transitional controls will be the quarterly Labour Force Survey. This is scheduled for publication on 14 May and released by the Office for National Statistics at: <u>http://www.ons.gov.uk/ons/index.html</u>

This release will include employment numbers and rates by nationality and country of birth, covering the period January to March 2014.

The Office for National Statistics also publish their Migration Statistics Quarterly Report at: <u>http://www.ons.gov.uk/ons/rel/migration1/migration-statistics-quarterly-report/index.html</u>

The release on 28 August 2014 will include provisional estimates of long term international migration for the year ending March 2014, including estimates for the European Union.

On 22 May, the Department for Work and Pensions will publish statistics for National Insurance Number allocations to foreign nationals for the first quarter of 2014 available from: <u>https://www.gov.uk/government/organisations/department-for-work-pensions</u>

The previous information collected by the Home Office on Romanians and Bulgarians in connection with the Seasonal Agricultural Worker Scheme and the Sector Based Scheme will end at the same time as the transitional controls as these schemes also then come to an end.

Vaccination: Immigrants

David Blunkett: To ask the Secretary of State for Health pursuant to the answer of 9 December 2013, *Official Report,* columns 107-08W, on vaccination: immigrants, which group is responsible for the commissioning of the specific vaccination programmes recommended by the World Health Organisation and National Institute for Health and Care Excellence for newly-arrived migrants from areas with high prevalence of a particular disease; and who is responsible for commissioning hepatitis B vaccinations for newly arrived migrants from areas of high prevalence of this disease. [180568]

Reply from Daniel Poulter: NHS England's area teams commission vaccination programmes recommended by the Joint Committee on Vaccination and Immunisation (JCVI). JCVI's advice takes into consideration recommendations from the World Health Organisation and guidance from the National Institute for Health and Care Excellence.

Specialist public health staff employed by Public Health England are embedded in these teams to provide accountability and leadership for the commissioning of the programmes and to provide system leadership. Clinical commissioning groups are responsible for assessing the local need for provision of outreach immunisation services which includes commissioning of hepatitis B vaccination for newly arrived

migrants from areas of high prevalence who are not registered with a general practitioner (GP). Migrants who have registered with a GP are offered vaccines in line with national guidance on immunisation against infectious diseases.

Illegal Immigration

Philip Hollobone: What estimate he has made of the number of illegal immigrants in Scotland. [901635]

Reply from the Secretary of State for Scotland (Alistair Carmichael): Given the ability of illegal and clandestine immigrants to move freely within the UK, it is not feasible to produce separate estimates for each part of the UK.

Philip Hollobone: It would appear that the Government do not really know how many illegal immigrants there might be in Scotland. Given the attraction of the whole of the UK to people from other countries, I suspect that the problem might be rather greater than the Secretary of State imagines, particularly in cities such as Glasgow and Edinburgh. Will he reassure the House that he will work closely with the UK Border Agency to ensure that Scotland is not an easy route into the UK for illegal immigrants?

Reply from Alistair Carmichael: Certainly there should be no easy routes for anyone in these circumstances, but I would caution the hon. Gentleman against devoting too much Government resource to the compilation of figures that do not help us to tackle the problem.

Graeme Morrice: What discussion have the UK Government had with the Scottish Government about the operation of border controls in an independent Scotland?

Reply from Alistair Carmichael: We have had no such discussion so far. The truth of the matter is that either we can have an open area with no border controls or we can have closely aligned immigration policies—unlike the position of the Scottish National party, we cannot have both.

Angus Brendan MacNeil: For years, immigrants have been vital to the economy—in my constituency, I see the importance of Filipino fishermen—and, since the Union, the problem in Scotland has been emigration, not immigration. But what can we do for Syrian refugees, to enable them to come here as legal immigrants? Although the Secretary of State might have failed to get his colleagues to vote for war in Syria, what might he do this Christmas to help refugees come from Syria, especially given that Germany is taking 80% of the European total and the UK is taking zero, which Amnesty International says should cause heads to hang "in shame"?

Reply from Alistair Carmichael: This country has a long and proud record of offering asylum to those who seek it and those who deserve it and need it. That will continue to be the case.

Asylum: Finance

Barry Sheerman: To ask the Secretary of State for the Home Department what safeguards her Department has put in place to ensure that Azure Payment Cards issued to those receiving support under section 4 of the Immigration and Asylum Act 1999 are used only in accordance with her Department's rules for the card; and what steps she takes to monitor compliance. [179813]

Reply from Mark Harper: The Home Office works closely with its contractor and the retail outlets affiliated to the Azure card scheme to ensure that the card's rules are applied properly, including the prohibition on purchases of alcohol, tobacco, vehicle fuel and gift cards.

The card also contains various automated features designed to ensure compliance with the relevant rules-for example by capping the amount of credit that can carried over into the following week. The Home Office also has access to data that can be used to analyse transaction histories for each card holder.

Barry Sheerman: To ask the Secretary of State for the Home Department if he will estimate the value to organisations certified for receiving payment with Azure Payment Cards of receiving payments made through that scheme; and if he will take steps to increase the number of retailers participating in the scheme. [179814]

Reply from Mark Harper: There are no plans to estimate the value to retailers of participating in the Azure Card scheme. It is difficult to envisage how such an estimate would be made.

The Azure Card is already accepted by Tesco, Asda, Sainsbury's, Morrison's, the Co-operative, Boots, Peacocks, The British Red Cross, The Salvation Army and a few small independent retailers.

There are ongoing discussions with other retail outlets who may be interested in joining the scheme.

Asylum Seekers

Lord Roberts of Llandudno: To ask Her Majesty's Government how many unaccompanied asylum-seeking children arrived in the United Kingdom (1) in 2012, and (2) thus far in 2013.[HL4107]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): In 2012 there were 1,125 applications from unaccompanied asylum seeking children (excluding dependents). There have been 835 applications in the first three quarters of 2013.

The Home Office publishes annual and quarterly statistics on asylum applications from unaccompanied asylum seeking children in tables as_08 and as_08_q (Asylum data tables Volume 2) of Immigration Statistics. Immigration: Holding Facilities

Lord Avebury: To ask Her Majesty's Government what improvements have been made to the short-term holding facilities at Heathrow Airport since they were the subject of critical reports by the Independent Monitoring Board; and when they now expect the deficiencies noted by the Board to be remedied. [HL3778]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The Heathrow Independent Monitoring Board (IMB) published their annual report on 10 June 2013.

The provision of accommodation facilities at ports of entry are provided by the port operator, at Heathrow Airport this is Heathrow Airport Limited (HAL).

The Home Office has been working very closely with HAL to progress accommodation improvements to the short term holding facilities at Heathrow Airport.

Some improvements including re-decoration have already been implemented since the publication of the Independent Monitoring Board's Annual Report.

Border Force and HAL have agreed and signed off a scope of works that covers all the recommendations of the IMB report and more.

This includes expansion of the family room in Terminal 2 and Terminal 5; provision of showers and a toilet lobby in Terminal 5; re-configuration of the family accommodation at Lima 23; and a complete re-build of the holding room accommodation in Terminal 3 and Terminal 4.

HAL have produced a detailed project plan and the earliest that the works will be completed is December 2014. This is primarily because of the high level of costs associated with the works and that the funds do not become available to HAL until 1st April 2014 (new regulatory finance period). The works at Terminal 2 will be complete in time for opening of the terminal in June 2014.

HAL, Border Force and the Home Office are currently in the detailed design stage with HAL due to go to tender for a contractor to carry out the works in March 2014.

Human Trafficking

Frank Field: How many young people currently in young offenders institutions and specialist children's homes are being held on human trafficking offences. [901657]

Reply from the Minister for Policing, Criminal Justice and Victims (Damian Green): From 2008 to 2012, no children and young people were sentenced to custody for human trafficking as the principal offence. This Government are committed to combating human trafficking. On Monday we published the draft Modern Slavery Bill to strengthen our response and to underpin the work of law enforcement agencies.

Frank Field: As the Lord Chief Justice has ruled that victims of slavery should not be prosecuted for crimes they undertake under the direction of their slave owners, will the Minister undertake an audit of young people in offender institutions to establish how many are there, even if they have been charged under a lesser crime, in order to see whether their cases should be reviewed?

Reply from Damian Green: Yes, as part of the extra work we are doing under the aegis of the draft Modern Slavery Bill, to which the right hon. Gentleman has contributed significantly, we are obviously looking at the individual effects on those who might have been victims of trafficking and enslavement. He makes a perfectly valid point.

Human Trafficking

The Lord Bishop of Derby: To ask Her Majesty's Government how many people were arrested, prosecuted and convicted for human trafficking-related offences in 2009, 2010, 2011 and 2012.[HL3443]

reply from the Advocate-General for Scotland (Lord Wallace of Tankerness): Information on the number of arrests made by the police for human trafficking offences is not held centrally and could only be obtained at a disproportionate cost.

Crown Prosecution Service data is available through the Case Management System (CMS) and associated Management Information System (MIS). The CPS collects data to assist in the effective management of its prosecution functions. The CPS does not collect data which constitute official statistics as defined in the Statistics and Registration Service Act 2007. Official criminal justice statistics are

published by the Office for National Statistics (ONS).

The CPS does however maintain a central record of the number of cases flagged as involving human trafficking where there have been prosecutions, including convictions, by way of a monitoring flag, introduced in April 2010. The flag is applied at the onset of a case; and remains in place even if the charges are subsequently amended or dropped.

The number of human trafficking flagged prosecutions and convictions for the last three calendar years for which data is available, is as follows;

Frank Field (888) Romanian and Bulgarian citizens intending to work and live in the UK from 1 January 2014 – That this House notes the lifting of Transitional Provisions set out in Article 20 and Annexes VI and VII of the European Communities No. 2 (2005) Treaty from 1 January 2014 with reference to the movement of Romanian and Bulgarian citizens intending to work and live in the UK; acknowledges that there are nearly one million young people out of work in this country; and therefore urges the Government not to lift Transitional Provisions on the movement of Romanian and Bulgarian citizens intending to work and live in the UK while unemployment and youth unemployment remain so high in this country.

Female Genital Mutilation

Helen Jones: To ask the Secretary of State for Health what steps he has taken to implement the recommendations in the report, Tackling FGM in the UK; and if he will make a statement. [180279]

Reply from Jane Ellison: The Government welcomes the inter-collegiate report Tackling FGM in the United Kingdom, published recently. Female genital mutilation (FGM) is child abuse. We are committed to preventing and tackling FGM and are clear that safeguarding, prevention and a multi-agency approach are important to protect girls and young women from this abhorrent procedure.

It is a priority of the Department to continue working with the medical Royal Colleges and other organisations supporting this report, Government departments and the Director of Public Prosecutions towards eradicating FGM in England. I recently met with stakeholders and representatives from Royal Colleges involved in the development of the inter-collegiate report to discuss the report's recommendations, and the group will meet again in the new year to continue this dialogue. The Department is currently looking at how best the national health service could collect and share information on FGM, with options in development to collect information on prevalence. With this work under way I will be looking to make an announcement in the new year.
